This report is written by Police Officer Corstan D. COURT, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 11/15/06, officers along with a 19 year old Police Aide entered the Encore Tavern 101 S. Dana Ct. The Police Aide was able to order and purchase two beers from the bartender. The bartender was cited for Sale of Alcoholic Beverages to Underage Person.
- 2. On 02/22/07 officers responded to an injury accident at the Encore, 101 S. Dana Ct. Officers' investigation revealed that a patron was ejected from the tavern for fighting. The fight continued outside where another patron armed himself with a baseball bat. The bat was taken away by a bouncer and the fight quieted down. The applicant learned from a bouncer, that the person with the baseball bat was a longtime friend of his named Reginald, and that Reginald was going to come after him with the bat. The applicant became enraged at this and went outside to confront the friend. Reginald was now in a vehicle and he accelerated that vehicle towards the applicant, striking him and knocking him several feet. Reginald backed up towards the applicant, but struck a bouncer instead, breaking his leg. The applicant stated to officers several times during the investigation that he knew better, not to leave his bar to escalate the fight.

Officers reviewed the tavern's exterior cameras, which showed that the applicant's actions escalated the fight outside. The applicant was cited for Disorderly Premises Prohibited.

A check with Municipal court on 03/11/08 found citation from incident # 2 was never issued.

- 3. On 02/16/08 at 2:42 am, Milwaukee police were dispatched to 101 S Dana Court for a Call For Police. Investigation found several patrons inside the tavern were involved in a heated argument. Officers were able to view video provided by the owner, Nicholas Monreal, which showed a patron pushing another and the argument continued outside of the tavern where is escalated. Police were called and one of the patrons involved received a resisting/obstructing citation for failing to cooperate with police regarding the investigation.
- 4. On 06/18/08 at 12:02 am, Milwaukee police were dispatched to 101 S Dana Court for a Battery complaint. Police spoke to the owner Nicolas Monreal who stated the victim was seated inside the club when he saw his ex-girlfriend with another man. The victim began to provoke the ex-girlfriends boyfriend and a fight ensued. Security broke up the fight and removed the victim from the tavern. The victim waited for the couple to leave the tavern and confronted them both once they left. Another fight occurred and the victim was knocked unconscious. The victim was treated and later released for his injuries at a nearby hospital. The victim was uncooperative with police and did not want to press charges.
- 5. On 08/01/08 at 12:57 am, Milwaukee police were dispatched to 101 S Dana Court for a Fight complaint. Officers spoke to the caller/victim who stated she and friends were at the Encore drinking and having some fun when security came up to them and asked them to leave because they were receiving complaints that she and friends were soliciting patrons at the bar. The victim stated she didn't argue and that she finished her drink and just "slid" her glass towards the waitress when the waitress grabbed a towel and threw it at the victim, striking her face. The victim stated she got angry and lunged at the waitress when security grabbed the victim from behind and walked her out of the bar along with her friends. Officers spoke with security officer Richard Hayes as well as the bartender Ashley Gonzales who both stated they wanted no citations issued and just wanted the caller and friends out of the tavern. No injuries were reported.
- 6. On 03/13/10 at 7:52 pm, Milwaukee police were dispatched to 101 S Dana Court for a Sick and Injured. Officers were met by MFD who stated a subject from Montreals was incapacitated by alcohol and subsequently conveyed to a nearby hospital for treatment. Officers located the victim at the hospital and interviewed her. The victim stated she was drinking an unknown number shots of tequila at the bar and would not provide information to the officers as to who the bartender was that served her. The victim was an employee of the tavern. Medical personnel at

the hospital found her blood alcohol level to be at .28, which is three times over the legal limit. Further investigation found the identity of the bartender who served the victim but she was no longer on scene when officers returned. The licensee Nicolas Monreal was not on scene either and officers contacted him by phone and advised him of what occurred and that he would be receiving a citation.

7. On 09/22/12 at 1:00 am, Milwaukee police investigated a battery that occurred at the Monreal's Encore located at 101 S Dana Court. Investigation found an employee of the bar was battered by her husband outside of the business causing minor injuries. A report was filed.

- 8. On 04/13/2013 Milwaukee police responded to a Battery complaint at 101 South Dana Court (Monreal's Encore). Investigation revealed two patrons of the business became involved in an argument while sitting in a car after they left the business. This argument escalated and resulted in one of the involved parties receiving a citation for Battery.
- 9. On 08/22/2013 Milwaukee police conducted a licensed premise check at 101 South Dana Court (Monreal's Encore). During this check, it was discovered the bartender did not possess a valid class D operator's license. Both the bartender and the applicant were cited.

On 03/19/2014 the Wisconsin Department of Transportation revoked the applicant's driver's license for 6 months for Prohibited Alcohol Concentration. 11.On 02/18/2015 Milwaukee police responded to a theft complaint at 101 South Dana Court (Monreal's Encore). The victim, Veronique Brown, told officers that around 7:00pm a subject Brown knows as Michelle Harris stole her purse. Brown is employed at Monreal's Encore and knows Harris from a relationship she (Harris) had with the father of Brown's child. Harris left in a Grey Hyundai prior to officer's arrival. Milwaukee police incident report #150490126 filed. 12. On 03/09/2019 officers were dispatched to a battery at Encore, 101 S Dana Ct. The caller stated he was thrown out of the business and punched, but had no injury. Security stated they removed the subject for attempting to steal other patrons alcohol and money from tables. 13. On 03/16/20 at 11:02pm, Milwaukee Police conducted a license premise check at 101 S. Dana Court. The reason for the check was to make sure the business knew of the county and city mandated closures. The staff stated that they understood the rules. 14. On 06/17/20 at 11:05pm, Milwaukee Police were dispatched to 101 S. Dana Court for a battery complaint. Investigation revealed that two females (one a former

Investigation revealed that two females (one a former employee) were in a verbal argument with the bartender who asked them to leave because they were causing a disturbance. Video surveillance shows security standing by two females who were trying to go around him, so security wraps his arms around one and moves her towards the door. While at the entrance, it appears that there is a struggle between both parties to get the door closed and security is able to close the door.
 - 15. On 02/07/21 at 1:50am, Milwaukee Police were dispatched to 101 S. Dana Court for a shots fired/subject with a gun complaint. Investigation revealed that someone fired shots outside that establishment with one shot going through the front door, hitting the back counter of the bar, and then ricochets into a glass shelf that holds liquor bottles. Two other bullet strikes were found in the building but did not enter the establishment. Employees believe that a group of patrons that were kicked out earlier in the night might have fired the shots into the building.

16. On 02/27/21 at 1:29am, Milwaukee Police were dispatched to 101 S. Dana Court for a subject with gun complaint. Upon arrival, officers interviewed security who stated that they were informed that a subject was beating another subject inside a vehicle, outside the establishment, and the subject was armed with a firearm. Security went outside to investigate, observed the incident, and called police. The subject left the scene before police arrival.

This report is written by P.O. Andrew KEMPEN, assigned to District 3, Late Power Shift, Tavern Squad.

At 11:13 PM, Squad 3465, P.O. Taylor ZUBE and I, responded along with Squad 3490, P.O. Samuel KEHOSS, to Monreal's Encore at 101 S Dana Ct for a Battery complaint.

Upon arriving on scene P.O. KEHOSS spoke to the caller, Jessica R BREHMER (F/W 02/28/97), who sated that she worked at the location and was there with a friend, April M OLIVER (F/B 11/07/93) when she overheard the bartender say something about "Mexicans" which she stated she took offense at because she is Hispanic. BREHMER stated that she and her friend confronted the bartender and the bouncer asked them to leave but they stated that they were waiting for a drink and refused to exit at which point the bouncer picked her up out of her chair and pushed her and OLIVER out of the location. OLIVER claimed that she was pushed in the face causing pain to her head and BREHMER stated that the chair was pulled out from under her.

I then spoke to the Security at the location, Morgan E BOURNE (M/W 10/15/77) who stated that he had just removed three male subjects when he noticed a commotion at the bar between his bartender, Jacqueline Y MURPHY (F/W 6/27/71), where the two females,, BREHMER and OLIVER, were calling MURPHY a bitch so he went up to MURPHY who informed him that she was not going to be serving the two so they could leave the location. BOURNE stated that BREHMER who had been dancing earlier in the night had changed and told him that she quit so he told them both that since they were not going to be served and were no longer working there, they needed to leave the location. BOURNE stated that both females refused to leave stating that they were waiting for their drinks which he again told them would not be coming and they needed to leave. BOURNE stated that after trying several times to ask them nicely to leave he was forced to push them toward the front door and when he got them both to the door they started to struggle at which point his glasses were knocked off. BOURNE stated that he just wanted the subjects to leave because of the way they were acting.

I then spoke to the bartender, MURPHY who stated that the incident started after 3 Hispanic subjects were removed after being disorderly and one had made a comment about blowing the place up so she said, "Oh the Mexican's are going to blow the place up" to kinda laugh the comment off at which point BREHMER started yelling at her for making the comment and calling her a bitch. MURPHY stated that the other female, OLIVER, was also calling her a bitch so she told them that she was not going to serve them and to leave but they refused so she signaled BOURNE that they were refusing to leave and he took it from there.

The owner Nicolas S MONREAL, responded out to the location and allowed me to view video of the incident. The video does not have any audio but I was able to observe BOURNE standing by the bar with

two females and the two trying to go around him at which point he blocks them from and appears to carry or wrap one with his arms and move to the door. At the door it appears that there is a little of a struggle before BOURNE is able to get the door closed. The incident occurred between 10:55 PM and 11:00 PM. No other camera views of the incident were available. I advised MONREAL that a license premise would be filed regarding.

No injuries were observed on BREHMER or OLIVER and they only claimed to have been pushed by BOURNE. BOURNE's glasses were scratched during the altercation but did not want to press charges regarding it at this time.

On Sunday, February 7, 2021 at 1:58AM P.O. Robert DAVIS and I (Squad 3465) were dispatched to 101 S. Dana Ct. (Encore Gentlemen's Club) for a shots fired/subject with gun call for service.

Upon arrival along with other squads we held containment on the building because it was still unclear if the shooter or anyone with a gun was still inside. I did observe one bullet strike to the front door of the building. Once we made entry to the building it was made clear the shooter was no longer on scene and no one was hurt inside the bar.

Scene Description:

Encore Gentlemen's Club is a 2 story building on the corner of S. Dana Ct. and W. Fairview Ave. There are 2 entrances to the bar one off the northeast corner of the building and one off the northwest corner to the rear of the building. There is a small 5 step set of stairs that leads up to the front door of the bar. As you enter the bar you immediately walk into a room that has an "L" shaped bar on the southside of the room and as you continue to walk into the building it opens up to a larger room with stages for the dancers. I observed from the inside of the front door that the bullet went through the door hit the back counter of the bar and then bounced into a glass shelf that holds liquor bottles. There was also 2 bullet strikes to the outside of the building that did not enter the building.

Interview of Ruben A. CENTENO (w/m, 4-11-95):

I spoke to Ruben A. CENTENO (w/m, 4-11-95) who stated he is a bouncer and bartender. CENTENO stated there was an altercation between 3 black males and 4 black females because the bartender had cut them off because they were intoxicated. CENTENO stated he helped escort them out and they were not happy about having to leave. CENTENO stated he went back into the bar and was talking to Stephanie A. REFFRUSCHINNI (w/f, 10-

24-90) behind the bar when they heard about 2-3 gunshots and heard the wood crack on bar counter and then heard the glass shatter. CENTENO stated the bullet struck the bar right in between where he and REFFRUSCHINNI were standing. CENTENO stated he never saw who fired the shots, but believed it may have been the group that was just kicked out. CENTENO stated he then told REFFRUSCHINNI to call police.

Interview of Albert MARSH Jr. (w/m, 5-12-61):

I spoke to Albert Marsh (w/m, 5-12-61) who stated he was working the door tonight when he observed a group of individuals being kicked out due to their level of intoxication. MARSH stated he did not really have any interaction with the group of individuals that were escorted out. MARSH stated he was standing to the left of the front door near the pull tab machine when he heard 2-3 gunshots and noticed a bullet had come through the front door.

- P.O. Samuel KEHOSS from Squad 3490 spoke to the bartender Stephanie A. REFFRUSCHINNI (w/f, 10-24-90) see his supplement regarding her statement.
- P.O. DAVIS reviewed video and placed a copy on inventory at District 3. P.O. DAVIS placed the 2 casings that were recovered on inventory at District 3.
- P.O. Devin WHITFIELD from Squad 3451 took 32 photos of the scene and casings at 2:49AM.

CENTENO, MARSH, and REFFRUSCHINNI were all issued PV-17's.

MARSH stated that the subjects then left the location traveling southbound on S 60th St. MARSH stated that the vehicle was a newer model Cadillac CTS with an unknown plate. MARSH stated that he did not observe a gun on the subject.

MARSH stated that the patron who initially informed him of this was no longer on scene.
