
Enclosed please find a proposed resolution. We ask that it be introduced and referred to the Committee on Judiciary & Legislation, with the following recommendation.

The plaintiff alleges that she, a minor at the time of the events, was targeted by Rajaphoumi, then a Milwaukee Police Officer, for sexual predation. She alleges that he contacted her numerous times and had made sexual propositions to her and a friend, as well as having physical contact with her on one occasion. Based on his actions, Rajaphoumi was convicted on two counts of Causing Mental Harm to Child, a Class F felony.

Rajaphoumi initially met the plaintiff while working as a Milwaukee police officer; however, some of the subsequent contacts were on duty, some were not. Regardless, Rajaphoumi asserted though that he had an employment-related interest in all of his actions towards the plaintiff. The City filed a motion for summary judgment, arguing that the claims should be dismissed for the Rajaphoumi's actions having been outside the scope of employment; however, the court denied that motion, holding that the scope of employment issue was a factual matter for the jury because the employee's intent is a factor in the determination.

Subsequent to mediation, the plaintiff's attorney tendered an offer of settlement in this matter for the amount of \$250,000.00, inclusive of all costs and attorney's fees, which would settle all claims against the City and Rajaphoumi.

Because of the unpredictability of a trial, and the City's risk for exposure to compensatory and punitive damages, as well as additional attorney fees and costs, we recommend that

this matter be settled for that amount. Consistent with our recommendation, we request authorization to execute a settlement agreement on behalf of the City and its officer, and have enclosed an appropriate resolution for your consideration.
