9. On 01/03/19 at 2:41am, Milwaukee Police were dispatched to 1840 N. 6<sup>th</sup> Street for an armed robbery complaint. Investigation revealed that the caller/victim, who works at 1840 N. 6<sup>th</sup> Street, was 408 W. North Avenue when the incident occurred. The victim stated that he was at the filling station when he was approached by a subject with his hands under his hooded sweatshirt. Fearing for his safety, the victim pulled out his firearm for protection and the subject ran. The victim is a CCW holder and went to work before calling police.

- 10. On 08/08/19 at 10:00pm, Milwaukee Police were dispatched to 408 W. North Avenue for a trouble with subject complaint. Upon arrival, officers interviewed the caller who stated that she was having a conversation with two panhandlers inside the filling station who wanted her to buy them a charger. The employee locked the panhandlers out of the establishment by closing the metal gate to the entrance of the store. This action made the caller feel like a prisoner and she felt that it was unwarranted. She also felt like the employee believed that she stole items from the store to help the panhandlers. The caller said that she will be at the licensing meeting to speak about the incident.
- 11. On 12/19/2020 at 9:11pm officers conducted a license premise check at US Gas & Food Mart, 408 W. North Av. The officers located several expired food items throughout the store. The clerk was advised of the items and stated he would remove them from the shelves. The officers also observed two video gaming machines. The machines were plugged in and operating. The business did not have a PEP license. The officers contacted the applicant and advised him of the expired items and the unlicensed gaming machines. The applicant stated the machines are leased and he would take care of the expired items.

12. On 03/08/2021 at 3:12pm officers were dispatched to a Property Damage at US Gas & Food Mart, 408 W. North Av. The officer arrived on scene and observed a subject actively destroying items inside the store. The subject was arrested. The officers interviewed the clerk, who stated the subject refused to pay for items so they locked the door. The subject then began destroying the store.

This license premise report is written by PO David LETTEER, assigned to District 5, Late Power Shift, Sq 5468 with PO Russell MACRAE.

On 12-19-20 at 9:11 p.m., we assisted Sq. 5490 PO Justin SILKEY with a trouble with subject complaint, located at 408 W. North Ave., US Gas & Food Mart, with is a licensed premise in the city of Milwaukee.

While assisting with the trouble with subject complaint, PO MACRAE and I conducted a licensed premise check of the business. We checked the licenses, which were a current Filling station, 24hrs, food, cig and w&m, all of which expire on 06-15-21. While checking licenses, PO MACRAE began to inspect the coolers of the business, checking for expired dairy and refrigerated items.

PO MACRAE located several packs of expired bologna and informed the clerk Arit SINGH. I located 7 expired Peets Vanilla Latte refrigerated cans, which expired 06-12-19 and 06-14-19. I also located 5 Dunkin Donuts refrigerated coffee, which expired on 01-11-20, along with 8 Power Core Elute Vanilla protein shakes, which expired on 11-29-20, along with 1 that expired on 09-21-20 and 2 Gatorade protein shakes that were also expired.

We informed SINGH that the business needed to removed the items that were expired, so that customers would not buy the items and get sick, to which SINGH stated he would immediately remove the items. I asked SINGH how often the store conducts an inventory on their products and SINGH could not answer that question.

We then contacted the listed agent, Gurinder HAGRA and informed him of what we had located. He stated that he would take care of the issue and that some of the items he does receive from the vendor as they are. We informed him that we would be filing this report showing what we located and that NAGRA would be resolving the problems with the expired items.

Also while there, as you walk into the store, just to the left of the entrance door, next to the ATM, observed were two video gaming machines, which were plugged in and ready for use. The units appeared to take US currency and credit cards. PO MACRAE asked about the machines and was told that the machines take credit cards and the payout is given to the clerk, who gives the patron the money won. PO MACRAE also spoke to NAGRA about the machines who stated they are leased and that they have had people break into the machines before to steal the cash and this is why the machine only accepts a credit card.

We informed NAGRA that the gas station does not have a Public Entertainment License or Amusement license and that he may not be able to operate the machines legally. We will inform the State of the machines to see if they will want to check on the machines.

# LICENSE PREMISE REPORT

Polzin, Lucas 024048

This report was written by P.O. Lucas Polzin assigned to District 5 Early Power Shift.

On Monday, March 8, 2021, at approximately 3:12 PM, Squad 5242 (P.O. Stephen Cook and I) and 5263 (P.O. Deshon Nash and P.O. Leon Young) were dispatched to a property damage at the US Gas & Food Mart lcoated at 408 W. North Avenue. Officers had their body worn cameras equipped, and activated, during this investigation. P.O. Nash and P.O. Young arrived on-scene, and arrested a subject who was causing damages inside of the business. This subject identified himself as Terrance D. Singleton (b/m, 7/26/1992).

Officers spoke with the manager of this business, who identified himself as Harjeet S. Tiwana (I/M, 10/14/84), who estimated Singleton caused around \$4,000 in damages to the business. Please see the initial report below.

This report is submitted by Police Officer De' Shon NASH assigned to District 5 Early Power shift.

On Monday March 8, 2021 Squad 5263 (myself and P.O. Leon YOUNG) in full duty uniform, operating a marked Milwaukee Police Department squad car #106, affixed with an Axon body camera on our outer most garment, was dispatched to a Property Damage complaint at Citgo Gas Station the address of 408 W North Ave which is located in the City and County of Milwaukee at approximately 3:17PM.

Prior to arrival on scene we were notified that the subject later identified as SINGLETON, Terrance D (B/M 7-26-1992 was destroying the store, knocking merchandise over and breaking glass on the ice cream freezer.

As we arrived on scene I observed SINGLETON with a white metal rack actively striking the Bullet proof service glass, which was causing the glass to shatter. We then ordered SINGLETON to drop the metal rack which SINGLETON was using as a weapon. We placed SINGLETON under arrest.

I then conducted a walkthrough to observe all the damage SINGLETON committed.

### Damages to Citgo

I observed multiple potato chip bag racks to be knocked over, with potato chips bags being scattered all over the floor.

I observed multiple cake racks to be knocked over with cakes scattered all over the floor.

Multiple racks that contained numerous candy items was also destroyed all scattered all over the floor.

Racks/Shelves that contained household goods were destroyed and broken.

Ice cream freezer doors which the ice cream is kept were destroyed and glass shattered which caused glass to scatter all over the store.

Mini freezer which red bulls were kept was knocked over to the floor.

Bullet proof window which keeps a barrier between customers and employees had notable extension damage, which was consistent with SINGELTON striking with the metal rack.

Metal rack in which SINGLETON was using as a weapon was also damaged.

I then interviewed the store employee who was a witness to the incident.

#### Interview of Witness

I interviewed SINGH, PINDER (W/M 1-6-95) who witnessed the incident and was serving SINGLETON.

SINGLETON stated that approximately 3:06PM SINGLETON entered into the store and came to the counter to purchase 3 Black & Mild cigars valued at \$1. SINGH stated SINGLETON card purchase transaction declined and notified SINGLETON he would have to use another method of payment. SINGH stated SINGLETON then refused to pay for the merchandise and attempted to leave out of the store without paying. SINGH stated they then locked the door, so that SINGLETON could not leave in hopes SINGLETON would pay. SINGLETON still refused to pay and proceeded to destroy the store causing over \$2500 in damages.

End of Interview.

Squad 5242 P.O. Stephen COOK and P.O. Lucas POLZIN responded on scene to assist. P.O COOK took digital CST photos of the damages in the store. P.O. POLZIN downloaded video of the incident and placed the video on a DVD disk drive, and was placed on inventory, inventory #21008010.

P.O. POLZIN filed a License Premise report regarding this incident.

Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.

2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)

3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).

4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.

5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

6. You may then provide testimony.

a. Include only information relating to the above license application.

b. Include only information you have personally witnessed or seen.

c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.

d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.

7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
