This report is written by P.O. Jason WALLICH, assigned to District Six, Early Shift, Squad 6240.

On 01/08/21 at 3:49 PM, an unknown subject walked in to the Walgreens located at 3701 S Howell Av. The subject immediately walked into the cosmetic section and began filling a plastic bag with approximately 20-25 Olay brand skincare serums. The products are worth \$38.99 each. The approximate total value of items taken is \$857.78.

INITIAL INVESTIGATION

Upon our arrival, we were met by the manager, William R DEDYNSKI (W/M 12/29/78). DEDYSNSKI led us to the back office and was able to show us video surveillance of the suspect. The subject is described as a white male, approximately 18-20 years old, 5'10", thin build, last seen wearing a beanie with tassels, blue mask, black/dark blue jacket with a gray hoodie underneath, blue jeans, and black/white shoes.

I observed the suspect enter the Walgreens at 3:49 PM, and walk towards the cosmetic section, which is not shown by the video surveillance system. I then observed DEDYNSKI walk over to the cosmetic section with the subject. DEDYNSKI stated that he recognized the subject as a known shoplifter and stood next to the subject as he continued filling the bag with merchandise.

The subject then left the store and fled Southbound on S Howell Av without paying for the merchandise.

DEDYNSKI stated that he was unable to determine the exact amount of merchandise taken, but pointed out the section that he observed the suspect stealing from. I observed that the section had several empty slots for merchandise. The items were Olay brand skincare serums worth \$38.99 each. DEDYNSKI was unable to determine the exact amount, but estimated that 20-25 items were taken. The approximate total value of items taken is \$857.78.
