N. 53rd St. – W. Cody St. to the cul-de-sac north (ST211210195) Install traffic calming speed hump(s).

W. Philip Pl. – N. 58th St. to N. 60th St. (ST211200124) Concrete pavement reconstruction, replace sidewalk and driveway approaches where necessary, sodding (8' width of tree border area), and grading.

N. 44th St. – W. Wright St. to W. Clarke St. (ST211210179) Install traffic calming speed hump(s).


