Project Summary



The JS1962 Project located at 925 North Old World Third Street transforms the building into affordable housing with 83 units with 189 beds for MATC students. Construction started in October 2020 with substantial completion by August 1, 2021.




SBE Professional Services Inclusion

SBE Construction Inclusion


Through the period covered by this report, this project has achieved 27.4% SBE participation for Construction.
