# Settlement Agreement Update



### To Date:

Complaint forms are now available in English, Spanish, and Hmong on the FPC website and have been distributed to public libraries in the City of Milwaukee and all District Stations (IV.D.1.a and b)

Quarterly restock planned for April

Complaints are accepted in person, by phone, by mail, via email, and through an online submission process on the FPC website (IV.D.1.c)

FPC investigators are trained not to, and in practice do not, discourage the filing of any complaint from a member of the public (IV.D.1.e)

Complaints do not require notarization to be submitted to FPC (IV.D.1.e)

FPC investigators conduct complaint interviews at City Hall, over the phone, and at community hours held around the city (IV.D.1.g)

• Pandemic challenges have temporarily prevented in-person complaint filing

FPC continues to investigate all plausible complaints submitted by the public (IV.D.5.a)

FPC provides notification to the Chief when any officer receives 3 or more complaints in 90 days and when any officer receives three or more complaints over a rolling 1 year period (IV.D.5.e)

- EIP referral compliance confirmed by Risk Manager in August






# Proposed Draft audit schedule 2021

# Complications:

### Sample Sizes

- It is not clear what an acceptable sample size would be for each of the audits.
- Unknown what the sample sizes-identifiers will be when reviewing the cam footage.

### Schedule

- In order to complete all 14 audits in 6 months, the FPC will need additional auditors.
  - Risk Auditor is transferring to the Comptroller's Office in April.
- Is it possible to split the audits?:
  - The first audit of dashcam footage would be the review, then the next phase would be a supervisory review of the dashcam footage, and the last phase of the audit would be a review of the training efforts in place in order to comply with the Settlement Agreement.
