g: Your Extended Hours Establishments License Renewal Application as agent for "Speedway LLC" for "Speedway #4025" at 369 E Oklahoma Av.

There is a possibility that your application may be denied for one or more of the following: failure of the applicant or meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. See attached police report or correspondence.

Notice for applicants withProof of warrant satisfaction or payment of fines must be submitted at the hearing on thewarrants or unpaid fines:above date and time. Failure to comply with this requirement may result in a delay of the
granting/denial of your application.

Failure to appear at this meeting may result in the denial of your license. Individual applicants must appear only in person or by an attorney. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

You may examine the application file at this office during regular business hours prior to the hearing date. Inquiries regarding this matter may be directed to the person whose signature appears below.

Limited parking for persons attending meetings in City Hall is available at reduced rates (5 hour limit) at the Milwaukee Center on the southwest corner of East Kilbourn and North Water Street. Parking tickets must be validated in the first floor information booth in City Hall.

Dear Mr. Owczarski:

As you know, we serve as co-counsel with respect to Speedway, LLC's application for an Extended Hours Establishment license. This letter is filed on behalf of Speedway in connection with the above-referenced matter and in conjunction with Michael Murray, Speedway's counsel of record in Milwaukee County Circuit Court Case No. 21-CV-2792.

Speedway respectfully requests that the Common Council grant an Extended Hours Establishment license for its overnight operations at 369 East Oklahoma Avenue in the 14th District.

Since the application was considered earlier this year, Speedway has had open and direct dialogue through ongoing discussions with Ald. Dimitrijevic, Milwaukee Police Department District 6 officers, and City staff. Speedway has also enhanced its existing security system features at the store including the installation of additional exterior security cameras on the exterior of the building. A secure enclosure was custom-designed and constructed inside the store for the safety of Speedway's employees and point-of-sale operations. Finally, Speedway

has maintained the security officer presence at the store and it is committed to continuing that service during the key overnight hours 7 days per week.

These details and commitments are set forth in Speedway's Supplemental Plan of Operation dated June 18, 2021 that accompanies this letter. We previously presented the document to the Community Liaison Officers at Milwaukee Police Department District 6 as well as Ald. Dimitrijevic and confirmed that Speedway has fulfilled all of its terms.

We therefore request that the Supplemental Plan of Operation be placed in the file and entered into the record by the Licenses Committee.

Finally, Speedway expressly waives its right to the required 7 days' notice in order for the hearing to be held on July 7th for the Common Council to consider the Extended Hours Establishment license application.

We appreciate the Common Council's consideration of the requested license so that Speedway may reinstate all of the employee shifts and fully serve its customers and the community at this store.

Supplemental Plan of Operation

Speedway Store 4025 369 East Oklahoma Avenue Milwaukee, WI

Speedway LLC submits this supplemental plan of operation in connection with the renewal application materials on file for its Extended Hour Establishment License for the above-referenced store as follows:

1. A custom security enclosure has been installed inside of the store to ensure the safety of its employees and point-of-sale operations.



- 2. Speedway has enhanced its security system and equipment at the store, including by installing additional exterior security cameras on the west facade of the building.
- 3. As part of the safety plan for its customers and employees, Speedway contracted with a thirdparty professional security provider to staff the store with licensed, bonded and insured security officers who are either off-duty or retired law enforcement personnel. For its Extended Hour Establishment operations, the security will be present seven nights per week between the hours of 12:00 a.m. to 4:00 a.m. which is the appropriate timeframe given the incident history and feedback from the Milwaukee Police Department.
- 4. Speedway will continue the open and ongoing contact with MPD District 6 officers.
