This report is written by Police Officer Xavier Benitez, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 08/21/18 at 2:27pm, Milwaukee Police were dispatched to 6798 W. Appleton Avenue (American Inn Motel) for a dead on entry complaint. Officers interviewed the owner of the motel who was cooperative during the investigation and supplied officers with video surveillance of the time surrounding the incident. The owner also informed the officers that when he is away from the motel, he constantly watches the security cameras from his telephone and has an ID scanner which he is going to install at the check-in counter. This device will record who rents from him in order to keep a "banned" list for himself and other motels in the area. Detectives determined that the death investigation was not suspicious and the cause was undetermined at the time of this report. An Incident Report was filed (172330108)
- 2. On 01/12/19 at 3:00pm, a subject walked into the Third District to report his vehicle was stolen. Investigation revealed that the subject was staying at a hotel, with a female, whom he only knows by first name, at 6798 W. Appleton Avenue. The subject fell asleep and when he woke up, noticed that the female and his vehicle were missing. The subject stated that the female rented the room, so police called and retrieved the females information from the front desk employee.

- 3. On 05/09/19 at 6:16am, Milwaukee Police were dispatched to 6798 W. Appleton Avenue for a welfare check. Upon arrival, officers observed a female on the sidewalk waving her arms and making noises. The hotel manager led officers to the females room where they found the door open and suspected narcotics inside. The female was conveyed to the hospital.
- 4. On 07/13/19 at 7:30pm, Milwaukee Police were dispatched to 6766 W. Appleton Avenue for an accident. Investigation revealed that after the accident occurred, the vehicles moved to 6798 W. Appleton Avenue where an argument ensued with the driver of one of the vehicles pulling out a gun and pointing it at the other driver. A hotel employee was able to provide surveillance footage of the incident.
- 5. On 12/19/19 at 10:03am, Milwaukee Police were dispatched to 6798 W. Appleton Avenue for a shooting complaint. Upon arrival, one of the occupants in the room stated that she and her boyfriend were playing with a gun and it went off striking the victim, rendering him pulseless/not breathing. Investigation revealed that the occupant/suspect had been renting the room for the past two weeks and the victim was a daily visitor to the room and had been staying on a nightly basis. The occupant was arrested for her involvement in the incident.
- 6. On 01/01/20 at 4:00am, Milwaukee Police were dispatched to 6798 W. Appleton Avenue for a sick/injured complaint. Upon arrival, officers interviewed the caller/manager who stated that he received a call at the front desk from one of the occupants in the hotel saying that they heard a weird noise from the room directly below them. The manager went to the room to investigate and after receiving no response from the hotel room door, the manager opened the room to find the occupant unresponsive, so he called police. The subject, who still had a syringe in her arm, received three doses of NARCAN and was transported to the hospital. Inside the room there were various items of drug paraphernalia.
- 7. On 02/20/20 at 1:31pm, Milwaukee Police conducted a meeting at the Seventh District with the applicant regarding the high calls for service and the shooting which occurred on 12/19/19. The applicant told police that he is now requiring identification for all guests staying in the room and if they catch anyone doing anything "suspicious" they would be put on a "Do Not Rent" list. This list is shared with his other hotels and the surrounding hotels in the vicinity. Other policy changes are that employees are going to require identification from persons seen entering a room more than once and he will now employ a security guard who will monitor the property. The applicant said that he and his wife will start splitting time between his other hotel and he was advised to come up with additional plans to combat the issues at his properties.
- 8. On 05/14/20 at 3:30am, Milwaukee Police were dispatched to 6798 W. Appleton Avenue for a sexual assault complaint. Investigation revealed that a female was abducted, taken to the hotel, and was sexually assaulted. The subject was able to go to the front desk and use the phone to call police.

9. On 07/07/20 at 10:43pm, Milwaukee Police were dispatched to 6798 W. Appleton Avenue for an over dose complaint. Officers met Milwaukee Fire Department Medical in room #205. Medical personal was performing Advance Circulation Life Support (A.C.L.S.) on a white female; the female's boyfriend was also in the room. After several attempts the A.C.L.S. was unsuccessful and a time of death was given. Officers turned over the investigation to Sgt. Baker of the Criminal Investigation Bureau.

- 10. On 07/11/20 at approximately 1:22pm, Milwaukee Police were investigating an overdose complaint at 6731 W. Keefe Ave. Officers spoke with the victim's friend who was at the scene. The friend stated that prior to the overdose, they stayed at the American Hotel, located at 6798 W. Appleton Ave. Officers spoke with the manger on scene that provided officers with pertain information, such as vehicle, renter and check out information.
- 11. On 09/06/20 at 12:11am, Milwaukee Police were dispatched to 6798 W. Appleton Avenue for a trouble with subject complaint. Officers spoke with the agent who stated that he was trying to have three long stay room renters vacate the hotel. The agent explained that his license is set to expire at 09/06/20 by 11:59 pm. The agent stated that he notified the renters that they would have to make other accommodations, but they are refusing to leave. The agent further stated that he has a license renewal hearing on 09/08/20. Officers spoke with the renters who stated that they have nowhere else to go and were recently notified to leave. Officers requested a supervisor to the scene who stated that the renters could stay until the hearing 09/08/20, however if the establishment's license is not renewed they would have to vacant the location.
- 12. On 12/05/20 at 11:37am, Milwaukee Police were dispatched to 6798 W. Appleton Avenue for a trouble with subject complaint. Officers spoke with the manager who stated that a renter in room 105 is refusing to leave after check out time. Officers spoke with the female who stated that she was diagnosed with Corvid and that 211, was supposed to pay for her extended room stay. Investigation determined that her quarantine was over and that 211 made no such accommodations for the subject. The female was conveyed away from the location by the officers.
- 13. On 04/17/21 at 6:12pm, Milwaukee Police were dispatched to 6798 W. Appleton Avenue for a Battery DV complaint. Officers spoke with the victim who stated that her boyfriend had struck her in her hotel room. The victim stated that the suspect left the scene after also hitting the manager. Shortly after speaking with the victim, she left the location prior to officers finishing the investigation. Officers spoke with agent was cooperative and provided officers with suspect check in information. The manger also stated that he only observed verbal arguing nothing physical, and asked both parties to leave the hotel.

This report is being written by P.O. Eliezer GONZALEZ-VALENTIN Assigned to District 7, Early Shift.

On Tuesday July 7th, 2020 at 10:43PM I along with P.O. Mario DANZTLER (Squad 7232, While in full duty uniform and marked squad wearing an activated Axon body worn camera) were dispatched to a overdose complaint at the address of 6798 W. Appleton Ave. Room #205, which is in the City and County of Milwaukee, WI.

Upon our arrival we were met by Milwaukee Fire Department (MFD) Engine 36 and Milwaukee Fire Department Medical (MFD) unit #13. Once we entered room #205 we saw an unresponsive white female later identified by WI identification card as Rebecca ARZAMENDI (F/W 2-2-1982). MFD quickly began performing Advance Circulation Life Support (ACLS) on ARZAMENDI. The boyfriend of ARZAMENDI later identified by WI temporary paper identification as JEREMY HOCH (M/W 7-18-1978) was also inside the room. After several attempts of ACLS, MFD called time of death of ARZAMENDI's at 11:04 PM.

Officer DANZTLER submitted an incident notification and Criminal Investigation Bureau Squad 9218 (SGT. Willaim BAKER) responded and took over investigation.

While on scene I was instructed to conduct a vehicle canvass of the location parking lot. None of the vehicles canvassed came back to ARZAMENDI nor HOCH. HOCH stated to Officers both he and ARZAMENDI walked to the location.

It should be noted that the working manager that day was identified as American inn Motel manager Ram Jasti (M/W 08/25/1977). The business has a Provisional renewal license that was issued 6-4-2020. Licensee per www.cityofmilwaukee.gov website was listed to Harjinder SINGH, (414) 379-1742.

This report is written by P.O. Angel GALLEGOS, assigned to District 7, Early Power Shift.

On Saturday, July 11, 2020, Squad 7233 (P.O. Austin LLANAS and I in full duty uniform equipped with Axon body worn cameras and operating marked MPD squad 094) was dispatched to an Overdose call for service at 6731 W. Keefe Ave. Pkwy, located within the City and County of Milwaukee, Wisconsin. P.O. LLANAS and I were equipped with body worn cameras which recorded audio/video during our investigation. The below report is a summary based on recollection and is not a verbatim retelling of the events captured on the body worn cameras.

Upon arrival I observed the victim identified as Latoya D. CONNER (b/f 08-12-88) laying on the ground with a needle in her left arm. MFD, Engine 22, red shift, was on scene and providing medical attention. Captain Jamie McDonald was the acting supervisor.

A female who was standing by identified as Secquioa E. COLLINS (b/f 06-04-89) stated she was CONNER's friend. COLLINS stated they had purchased Heroin at the intersection of N. 21st and W. Chambers St. COLLINS would not state who they bought the heroin from. COLLINS stated after CONNER used the heroin, the passed at out next to her as they were sitting outside of 6731 W. Keefe Ave. Pkwy.

COLLINS stated they were staying at the American Inn hotel located at 6798 W. Appleton Ave, room 112 prior to the incident. COLLINS stated after they left the hotel they were waiting for a ride on the grass and that's when CONNER overdosed. COLLINS could not provide any further information.

P.O. LLANAS stayed with CONNER as she was transported to St. Joseph's Hospital by MFD, MED 5, red shift. Lt. Nathan KING was the acting supervisor.

Interview with Kumar S. RAM (American Inn Manager)

I spoke with the manager at the American Inn identified as Kumar S. RAM (w/m 08-25-77) who stated the females rented the room with another male last night and checked out this morning. RAM stated he did observe CONNER and COLLINS sitting outside on the grass. RAM stated they told him they were waiting for a ride which he had no problem with. RAM stated later he noticed the police and MFD arriving on scene.

RAM stated the male was the individual who rented the room and also checked them out this morning at 11:30 AM. RAM showed me the hotel paperwork which confirmed a male identified as Albert TUNSTALL (b/m 06-27-61) had rented the room. The paperwork also provided TUNSTALL's vehicle information which was a white 2012 Dodge Grand Caravan bearing WI auto plate AFB-9323. RAM stated when TUNSTALL checked out they all walked out of the room together but he drove off without them.

Ebony STEELE (while in full duty uniform and operating a marked Milwaukee Police Department squad with Axon body camera affixed to our most outer garment) was dispatched at 12:11 AM to a Trouble with Subject complaint at the address of 6798 W. Appleton Av (American Inn Motel), located in the City and County of Milwaukee, WI.

Upon arrival, I spoke with Harjinder NMI SINGH, I/M, 04/15/65 who stated he is the manager of the establishment. SINGH stated that on Sunday, September 6, 2020 at 11:59PM his Motel License expired and that the remaining occupants in Rooms 104, 113 and 218 were refusing to leave after being notified of the expiration of the establishment. SINGH stated that he has a hearing for the renewal of the license on Tuesday, September 8, 2020 at 1:35PM and that the business should be back up and running by then.

I made contact with the following occupants who stated they were given a short notice as on the morning of Sunday, September 6, 2020 about the above situation and that they could not make last minute arrangements to leave.

- Donna M. GISSING, W/F, 07/01/1936 (414-524-9300) who has been an occupant in Room 104 of the motel sine Nov 15, 2019.
- Brian E. CARR, B/F, 05/29/1959 (262-278-7297) who has been an occupant in Room 113 of the motel since Dec of 2019.
- Steven NMI GOINGS, B/M, 07/17/1963 and Nicole G. GOINGS, B/F, 06/25/1975 (414-982-7649) who has been occupants in Room 218 of the motel since Jan of 2017.

On 12/05/2020 at 11:37 hrs, Squad 7143, PO Chad STILES and Squad 7243, PO Austin LLANAS, responded to American Inn, 6795 W Appleton Ave for a trouble with a subject. I did respond in marked Milwaukee Police Department Squad car 549, in full Milwaukee Police Department uniform, both equipped with Axon Camera Systems.

On arrival, we spoke to the manager, Raj who stated that Ebony S BUTLER, B/F, DOB 09/15/1984, was staying in room 105 and was refusing to leave after check out time. He stated she was claiming to be COVID positive and had no place to go.

We made contact with BUTLER in room 105. She answered the door with no pants on and exposing her genitals. She was advised to put clothing on and she closed the door and came back with a blanket wrapped around her. She stated that she was diagnosed with COVID and showed me hospital prescriptions for ibuprofen and Tylenol. She stated that 211 had promised to pay for her hotel room. She claimed to be a rape victim that occurred in Chicago and stated that the suspect had shot up a car on 19th/Atkinson regarding. She also claimed that she "sells pussy" and gets THC and cocaine for sex and she ended up at this hotel because a man and his girlfriend wanted to have sex but did not pay her. She also claimed to "sell pussy" to judges, lawyers and the Mayor of Rochester, NY.

She had a non-extraditable warrant out of Grand Rapids, MI.

A check of Wisconsin Service point showed she had not called 211 nor had any contact with any homeless service providers.

I did contact 211 who confirmed that there was no agreement to pay for her hotel room and they had no information on any housing/shelter requests for her. They did take her information and stated a housing assessment could be done on Monday for her but there was currently no shelter options. 211 also contacted Milwaukee Health Department who confirmed that her COVID quarantine ended today.

BUTLER did come to the door naked a second time and did come outside multiple times wearing nothing but undergarments, filming us and claiming to talk to a lawyer.

She became upset when I informed her that her COVID quarantine had ended and she was being requested to vacate this hotel room immediately per the innkeeper request and 211 would follow up with her. I also did contact Outreach Community Health Centers who had no immediate options for her and deferred to 211.

She did intentionally try to cough on JASTI, who had to physically run away from her to escape the

cough.

While on scene, she did then call 911 at 13:27 hrs and stated she is a rape victim and she would file a lawsuit if we arrest her. We did advise her that Chicago PD would need to take any sexual assault report that occurred in their jurisdiction. She also was asking why we were not trying to arrest the suspect, however there was no reports regarding this.

At that point I requested a supervisor and Squad 7111, Sgt. Brian BURCH responded. She demand that we take her to the Greyhound bus station and pay for a ticket for her to leave town.

at 13:40 hrs, she again called requesting to make a complaint against officers. She was advised that a supervisor was responding.

At 14:23 hrs she did intentionally cough at the housekeeping workers face again telling him she has COVID.

She was conveyed by Squad 7143 to the Greyhound bus station per 7111. She was provided a community contact card.

Appleton Ave. which is in the City and County of Milwaukee. Upon arrival we spoke to the caller/victim Tyesha B. CROSS (B/F 10/09/2001) who stated her boyfriend Arturo J. CANNON (B/M 04/08/1990) had assaulted her in her motel room#111. CROSS stated CANNON and herself had been at the motel for a few days. CROSS stated CANNON had hit her in the back of the head and shoulders inside their motel room.

CROSS also stated CANNON stole her cell phone and bank cards off of a table inside the room. CROSS stated after the loud argument and CANNON hitting her the manager of the motel kicked them out of their room. CROSS stated CANNON fled the scene and left her at the motel.

Shortly after talking with CROSS she left the scene without telling us and we were unable to get further information regarding the incident.

SINGH stated he only observed verbal arguing nothing physical between CANNON and CROSS.

SINGH was cooperative during our investigation.
