The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 01/27/2017 the applicant was charged in Waukesha County with Illegal Games/Gambling (Forfeiture).

- 2. On 08/31/2019 at 2:39am officers observed a subject leaving Silk, 144 E. Juneau Av. The officer asked the security guard if that subject was an employee. The security guard stated he was not. The officer asked the manager why a customer was leaving 9 minutes after closing. The manager stated the customer was a high paying customer and he was using the ATM.
- 3. On 10/10/2019 at 1:30am an officer observed a car parked in the alley next to Silk, completely blocking the alley. The officer has seen this occur before with the auto waiting for a Silk employee. The officer spoke with the security guard about keeping the alley clean and he stated that was not Silk's problem. The officer then spoke with the manager, who also stated that was the officer's problem and not Silk's.

4. On 12/07/2019 at 1:29am officer's observed a group of people gathering in front of Silk, 144 E. Juneau Av. The officer approached and observed a subject in a scuffle with security. The security guard stated the subject was inside Silk for several hours. The subject was kicked out after attempting the take money off a table that was not his. Outside he accused the security guard of being racist and hit him with a closed fist to the face. The subject was issued a citation for Assault and Battery and arrested for violating his probation.

- 5. On 06/18/20 at 1:30am, Milwaukee Police were dispatched to 144 E. Juneau Avenue for a battery complaint. Video surveillance reveals an employee/bouncer and a patron have a heated discussion inside the establishment. When they both start walking toward the front entrance, the bouncer takes the patron down and strikes him several times with a closed fist. Two employees then carry the subject, who is unconscious, outside and laid him on the sidewalk. No employees called for medical attention.
- 6. On 02/19/21 at 8:30pm, Milwaukee Police conducted a license premise check at 144 E. Juneau Avenue. The establishment was found to be in compliance at the time of inspection.
- 7. On 03/18/21 at 2:02am, Milwaukee Police were flagged down by the manager of 144 E. Juneau Avenue for a fight complaint inside the tavern. The fight was in the basement of the establishment and was between several dancers/employees. Security dispensed "OC" spray in an attempt to break up the altercation. Two dancers involved in the fight received a citation.
- 8. On 04/12/21 at 12:35am, Milwaukee Police were dispatched to 144 E. Juneau Avenue for a battery complaint. Initial investigation, which was relayed to officers by security, revealed that the staff of 144 E. Juneau had escorted an intoxicated patron away from the establishment without any physical altercation and had not observed any physical fight. Later investigation, through surveillance footage from a neighboring tavern, shows that the employees of 144 E. Juneau were involved in the altercation and had witnessed what had happen to the victim of the battery. A security guard was seen on video taking off his jacket and going into the alley with the victim of the battery, along with several security members of Silk. A different subject who has been employed as security by silk and other establishments in the area is then seen chasing the victim into the street and punching the victim several times. This subject was arrested for the battery. The employees of the establishment were untruthful with police and failed to call police when they observed a crime being committed.

#### INITIAL INVESTIGATION

This report is written by P.O. Richard MICHALAK, assigned to District One, Late Power.

On Thursday, June 18th, 2020 at approximately 1:26 A.M., I (sqd 1420) responded with P.O. McCowan (sqd 1341) to SILK Exotic located at 144 E. Juneau Ave for a Battery complaint.

On arrival I spoke with Troy A. MOORE-SPICER (b/m 12-26-91). Troy is employed by SILK Exotic as their armed security guard and was working the front door at the time of the incident. Troy stated throughout the night he works the front door and also goes inside the club to make sure there are no problems. Troy stated that he was outside and walked into the club at the time of the incident. Troy stated he observed Fernando RUIZ (H/M, 10-21-87) walk up to Diante M. VANCE (b/m, 8-10-90) from behind and wrapped his arm around his neck. Troy stated that our victim lost his balance and fell to the ground. Troy further stated that is when RUIZ went to the floor and struck VANCE in the face several times with his right fist. Troy stated that he and another bouncer stopped RUIZ and escorted VANCE outside of the club. Troy stated that he grabbed VANCE by the arms and another bouncer grabbed him by the legs and then placed him on the sidewalk in front of the club. Troy stated that VANCE was unconscious when they escorted him out of the club. Troy stated that they went back into the club because the crowd that was starting to gather outside was getting violent. Troy stated that he went to get a towel inside the club and then came back outside to help VANCE with his injuries.

I spoke with Sara A. FARRELL (w/f, 7-14-98) that stated she was inside SILK when this altercation took place. FARRELL stated that the men in suits approached the victim and started punching the victim in the stomach for no reason. FARRELL stated the victim was doing nothing wrong and was attacked for no reason.

While on scene Iran D. AMANDAH (b/m, 6-30-79) approached me and stated that he was outside of Scooter's Pub located at 154 E. Juneau Ave having a smoke. AMANDAH stated that when he was outside smoking he observed two males carrying another male outside. AMANDAH stated that one male was holding the victim's arms and the other male was holding the victim's legs. AMANDAH stated that both males tossed the victim to the ground and went back inside the club. AMANDAH stated that the male victim was not moving and seemed to be unconscious.

P.O. MCCOWAN interviewed Fernando RUIZ (H/M, 10-21-87) the bouncer that was involved in this

RUIZ Stated that he was walking near the bar, passing VANCE as he stood at the bar. He informed me that VANCE had tripped him, possibly unintentionally but was unsure. As RUIZ walked past VANCE a second time, VANCE asked if RUIZ was going to apologize for stepping on his shoe. RUIZ stated he would not apologize, as he had been tripped by VANCE. VANCE replied "That's disrespectful" RUIZ stated VANCE then tried to punch him in the stomach, then tried to punch him in the groin. He stated VANCE grabbed him by his neck and tried to pull him to the ground. RUIZ grabbed VANCE by the shoulders and began to walk him out, past the "Private" room, where they both fell to the ground. On the ground, VANCE grabbed RUIZ by the neck again when RUIZ punched VANCE in the face with his closed left fist-twice. VANCE was then carried outside by another bouncer and the armed security guard on scene. P.O. MCCOWAN observed redness and some swelling on RUIZ'S left knuckles. Photos were taken of his knuckles on scene.

#### Thursday 6-18-2020

On Thursday, June 18, 2020 at approximately 7:27 P.M., I met with Kyle ZUBKE (w/m, 12-15-77) the Director of Operations for Silk Exotic to retrieve video of the incident. ZUBKE stated that camera #8 which runs from 1:18 A.m. to 1:24 A.M., shows the incident that occurred inside the club.

The video shows that Fernando Ruiz and VANCE bumped into each other and exchanged some words while in the club. Video shows VANCE exchanging more words with RUIZ as he walks away towards the front entrance. RUIZ approaches VANCE and the two seem to be having a heated discussion when Felipe RUIZ (H/M, 3-30-84) joins the conversation. The victim tries to walk back to the bar when both Fernando and Felipe stop him from doing so. The victim and Fernando start walking towards the front entrance when Fernando takes the victim to the ground, strikes him several times with his left fist to the face, then gets up and walks away. The video shows RUIZ and SPICER carry the victim by his arms and legs and take him out of the club and lay him on the sidewalk. VANCE was unconscious at this time and SILK did not call for medical attention.

On Friday 2-19-21 at approximately 8:30pm, Squad 1441 (PO Jason CHADWICK and I) conducted a nonotice tavern check at Silk On Water located at 144 E Juneau Ave, which is in the City and County of Milwaukee WI.

Upon our arrival we were met by the Manager, identified by WI DOT as Felipe RUIZ (M/W, 3-30-1984) who was more than willing in providing any information I requested to include applicable licensing and occupancy documents. SILK ON WATER was found to be in compliance at the time of this inspection.

Affixed to the outside of the building on the south facing side above the front door is the address numbers of "144", however for unknown reasons the first two numbers "14" are missing. RUIZ stated they were aware of the problem and have ordered replacement numbers which should be in place within the next week.

RUIZ was advised to call District One if he had a further questions or concerns and was issued a Community Contact Card.

This report is written by PO Brian WUNDER assigned to District One, late Power Shift.

On Thursday 3-18-2021 at approximately 2:02am while monitoring the Water Street Bar District for St. Patrick's Day "Code Red", Squad 1441(PO Jason CHADWICK and I) was flagged down by Felipe RUIZ (M/W, 3-30-1984) who is the manager of Silk On Water located at 144 E Juneau, which is in the City and County of Milwaukee.

RUIZ stated several dancers had engaged in a physical fight with each other in the changing room located in the basement and their on-site contacted security guard, later identified by WI DOT as Troy A. MOORE-SPICER (M/B, 12-26-1991) of Gear-Up Protection Company had discharged OC Spray in the changing room in an attempt to dissipate the fight.

MOORE-SPICER stated after several attempts by Silk On Water Staff members to break up the fight with to no avail, MOORE-SPICER stated he had no choice but to discharge his OC Spray for fear that other staff members would be harmed. MOORE-SPICER stated he did not discharge the OC Spray at any specific person, but rather towards the floor and pointed away from everyone to essentially "fill the room".

Investigation revealed the fight was between 4-5 dancers and originated over the alleged theft of misplacement of a cellular phone charger.

Two dancers involved in the fight were issued NTC Citations for Battery.

Per RUIZ, those two dancers have been terminated from further employment at any of the Silk locations.

This report is written by PO Raymond DEBRASKA, assigned to District 1 Late Power Shift.

On Monday, 04/12/21 at 12:43am, my partner PO Ester KREMSEROVA and I (Squad 1440) responded to 131 E Juneau Ave for a battery complaint. The investigation revealed the incident began at 144 E Juneau Ave (Silk Exotic). I spoke with the doorman, Jeremy DOTSON (b/m, 08/06/86), who stated the following. DOTSON stated that 2 patrons had been attempting to come back into the tavern to try and locate a lost set of keys. DOTSON stated that the subject was too intoxicated and agitated to be let back inside. DOTSON stated that staff was unable to locate the missing keys and the subject attempted to rush past him and inside. DOTSON stated that he pushed the subject back away and the subject began threatening harm them. DOTSON stated that they were able escort the subject's away from the building toward the alley to the west. DOTSON stated that as the subject walked away he was joined by a couple more people near the alley and could be heard yelling toward other people passing by on the sidewalk. DOTSON stated that he was not involved in any physical fight and did not observe any fighting.

The subject was later assaulted accross the street by unknown suspects. The subject has since accused the Silk staff of physically assaulting him. At this time of the initial investigation there is no evidence of Silk staff involvement in the battery.

The staff on scene was cooperative in assisting with the initial investigation.

The manager Felipe RUIZ was on scene and advised this report was being written regarding.

On Wednesday, April 14, 2021 at 11:11 pm, PO E. KREMSEROVA (Squad 1460) conducted a surveillance video follow up at 134 E Juneau Av (MOJO's) regarding the incident which started at 144 E Juneau Av (Silk) on Monday, April 12, 2021.

ABDULHADI (victim in the incident) is seen being "thrown" out of the front entrance of Silk and into the Sidewalk by unknown subject, which appears to cause the situation to escalate and anger ABDULHADI as he approaches whoever is standing inside of that door way. The part of how ABDULHADI ends up on the Sidewalk isn't captured on the video shown to officers at Silk during the original investigation, as it skips that part.

Lemetra GRIFFIN (b/m, 1/18/1973) walks from the east and stands in front of Silk. GRIFFIN was not working in security capacity during this incident, but has worked as security contractor at bars on N Water St and E Juneau Av, including Silk, for many years and is known by many District 1 Code RED officers.

Jason A CARSON (b/m, 2/20/1981, Security at Silk during this incident) walks out of Silk and is seen taking off his sult jacket and handing it to Sean T FREITAG (w/m, 12/29/1993, Bartender at Silk during this incident). CARSON is then seen tucking his security badge inside of his shirt, signals ABDULHADI to follow him into the alley (located between Silk and Mojo's and out of camera view). ABDULHADI follows, so does ABDELHADI-ELJATIB (victim's brother), Felipe RUIZ (w/m, 3/30/1984, manager at Silk), GRIFFIN, FREITAG and Jeremy J DOTSON (b/m, 8/6/1986, Security at Silk during this incident).

12:33 am

CARSON is then observed pushing ABDULHADI in the SideWalk, then GRIFFIN pushing ABDULHADI. Small crowd of people, including security working at Mojo's take notice of what is going on and at least one citizen is observed to start videotaping the incident. FREITAG walks toward that recording citizen and it appears as he signals him to stop recording. All 4 mentioned security personnel (RUIZ, FREITAG, CARSON, DOTSON) and GRIFFIN walk out of camera view towards the street and in same direction as ABDULHADI.

Approximately 2 minutes later, RUIZ, FREITAG, CARSON, DOSTON and GRIFFIN walk back into camera view and towards Silk. When by the alleyway, RUIZ taps GRIFFIN's back and GRIFFIN walks away north through the alley prior to police arrival.

ABDULHADI is seen running across the street (southbound) and into this camera view. GRIFFIN is seen running after him and while in the east bound lane of E Juneau Av (approximately 131 E Juneau), GRIFFIN punches ABDULHADI what appears to be two times with his right fist to the face, causing ABDULHADI to fall to the ground. ABDULHADI is eventually able to stand up and leans against a parked vehicle where he is found by responding officers.

Above surveillance footage revealed the staff at Silk to be untruthful with the police investigation of a felony. It should be mentioned none of the staff called the police.

GRIFFIN was ultimately arrested.
