Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. 2. On 12/05/2018 officers conducted a licensed premise check at Aliota's Pub and Grill, 261 E. Hampton Av. The officers found the licenses in order and asked if they would be open on New Years Eve and the daughter of the applicant stated they would be open that night.

- 3. On 11/02/2019 at 9:02pm officers conducted a license premise check at Aliota's Pub and Grill, 261 E. Hampton Av. The officer found no violations.
- 4. On 01/12/2020 at 11:30pm officers conducted a license premise check at Aliota's Pub and Grill, 261 E. Hampton Av. The bartender provided the business licenses and her Class D Operators license. The officer observed 6 electronic gambling machines with a sign affixed that stated "No cash outs under \$20 before leaving".
- 5. On 02/14/2020 at 2:25am officers were dispatched to a Sick/Injured complaint at 261 E. Hampton Av. When the officer arrived they found Whitefish Bay Police on scene with an

intoxicated subject, lying on his side throwing up on the ground. The subject was conveyed to the hospital for treatment. The officer went to Alioto's to investigate, finding the front door locked. Upon entering they observed 4 people inside with alcohol and money on the top of the bar. The officers spoke with the bartender who stated the intoxicated subject had been in the bar and had left about 30 minutes prior to the officer's arrival. The bartender stated 2 of the people in the bar were employees but they had gotten off work at midnight. One of the patrons in the bar attempted to leave but was too intoxicated to walk, so the officers conveyed him home. A check of the license revealed the bar had a closing time of 1:30am. On 02/19/2020 the officer spoke with the applicant regarding the situation. He stated he did not know why the license had a closing time of 1:30am. The applicant was cited for Allow Patron After Hours and the bartender was cited for over serving a patron.

The employee was instructed to obtain her license as soon as possible.
- 7. On 01/31/21 at 9:28P, officers were dispatched to Aliota's, 261 E. Hampton Av., for a DUI complaint. Officers located a citizen in the rear parking lot of the establishment outside of the vehicle, appearing to be intoxicated. Officers spoke to the passenger who stated they had been drinking in the bar earlier and were trying to leave when the driver fell in the snow and lost the keys. Due to weather conditions and level of intoxication the officers conveyed the citizen's home. The officers returned to the bar and located the keys in the snow. The officers spoke to the bartender on duty and advised her of the Safe Ride Program. The employees were cooperative and stated they would inquire about the program.

This report is written by PO David LETTEER, assigned to District 5 Late Power Shift, Sq. 5468.

On 11-23-20 at 10:53 p.m., I went to Aliota's Bar, Icoated at 261 E. Hampton Ave., for a license premise check. This establishment is a licensed premise in the city of Milwaukee.

Upon entering the establishment, I spoke to the bartender Hanna E. DEKKER (w/f 12-30-90), who stated she has been employed by the bar, but has yet to have obtained her Class D license. She showed me her servers course paperwork and stated that a co-worker with a Class D license was there with her while she was serving. I observed Jessica BEVERLEY (w/f 09-22-82), who is a bartender at the bar. DEKKER stated with covid, she was not sure how to get her license. I informed her the call the city as soon as possible, so that she can find out how to get it, so that she is not under supervision while bartending. I instructed her that if BEVERLEY were to leave the bar, the bar would have to shut down and that she could not bartend. DEKKER stated she understood and would call to inquire about her license.

I then asked BEVERLY if the bar would be open on New Year's Eve. She stated that the bar would be open and probably not open all night long, but she was not sure. I informed her that I would email the listed agent, John ALIOTA and inquire about being open.

I then informed them that we (police) may stop in and make sure everything is going ok at the bar, as well as all the bartenders having their Class D licenses with them or on premise.

I emailed ALIOTA, but he had not responded to my email.

## License Premise Report

This license premise report is written by PO David LETTEER, assigned to District 5, Late Power Shift, Sq. 5468 with PO Russell MACRAE.

On 01-31-21 at 9:28 p.m., we were dispatched to TJ Aliotas Bar, located at 261 E. Hampton Ave., which is a licensed premise in the city of Milwaukee. The caller stated an intoxicated person is trying to get into their vehicle in their vehicle behind the bar. We were also informed that the person calling stated all the vehicle doors were open on a black SUV vehicle and that the person who was with the vehicle fell in the snow and possibly hit their head on the door of the the vehicle.

Upon arrival, we went to the rear parking lot of TJ Aliota's Bar, which also contains several other businesses, which were closed at this time. The bar was the only establishment open. We observed a black Chevrolet Suburban parked at the south side of the parking lot, with the drivers side door open and a white male standing next to the door, outside of the vehicle. The vehicle was not in operation at this time.

We approached the vehicle and exited our squad car, speaking to the person standing outside of the vehicle. We spoke to Timothy DUNSIRN (w/m 07-26-77) and observed his wife Megan DUNSIRN (w/f 05-02-78) sitting in the drivers seat on her phone. PO MACRAE attempted to speak to Timothy, but Timothy was swaying back and forth, trying not to fall over. PO MACRAE attempted to ask him his name, but he just stared at PO MACRAE.

We then spoke to Megan, who stated she and her husband were at TJ Aliotas bar and arrived there around 6:30 p.m., after spending the day outside. She stated they had several drinks and that her husband did have more than he should have had. She stated they were going to leave the bar prior to our arrival and go home, but that they lost their keys and could not start or drive their vehicle home, which was 5 minutes away. She stated Timothy was not going to drive.

Megan went on to say that she looked in the bar and that bar staff helped check outside for the keys. I asked Timothy if the keys could have been lost when he fell in the snow and Timothy just stared at me. Megan stated they were concerned about someone taking their vehicle after finding the keys. I asked her if due to Timothy's level of intoxication, a person inside of the bar, maybe bartender, took the car keys so that Timothy would not drive home. Megan stated no one in the bar had the keys.

Due to it being cold outside, in order to keep the two people safe, we drove them home to their address at 5027 Idlewild Ave., in Whitefish Bay. After taking the two home, we returned to the bar and upon arrival, we located the keys to the Suburban in the snow and held on to them. We entered the bar and

spoke to the bartender, Kimberleigh L. NOBLE (w/f 07-30-75) who has a valid Class D Operator's License (BART 234345), which is set to expire 12-31-21.

We informed NOBLE on why we were there and she stated she started work at about 6:00 p.m. and that Timothy and Megan were already inside of the bar. NOBLE stated she served the two shots and beer. While serving them she observed Timothy had hit a wall, but that she stated his wife told her that she was going to drive. NOBLE stated the two left, but that a short while later they came back in stating they lost their keys to their vehicle. NOBLE stated staff at the bar attempted to help locate the keys to the vehicle, but that no one could locate the keys. We informed her that we located the keys and would return them Megan and Timothy.

We informed NOBLE that we would file this report.

I did ask NOBLE if the bar was affiliated or used the Safe Ride Program, which helps intoxicated people get home safely. NOBLE did not know if the bar was part of this program. She stated she would inquire if the bar was using this program.

We then left the bar and went back the residence of Timothy and Megan, returning the keys to their vehicle so their daughter could retrieve the vehicle later in the evening.

The hearing before the Licenses Committee will take place virtually on 7/13/2021 at 10:00 AM. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel — Channel 25 on Spectrum Cable — or on the Internet at http://city.milwaukee.gov/citychannel. Those wishing to provide oral testimony will be asked to do so by phone or internet and are asked to contact the staff assistant, Molly Kuether-Steele at (414) 286-2775 or molly.kuether-steele@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

# Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
