

Pursuant to City of Milwaukee Ordinance 80-10, I respectfully request that a special charge of \$57.54 be placed against the premises located at 2436 N. 25<sup>th</sup> Street for the cost of police services, which took place at 12:44am on April 9, 2020 for Property Damage 80-10-2-c-1-b. The cause for this response was for action(s) or behavior(s) that are prohibited by Milwaukee City Ordinance 80-10. In addition, there will be an Administrative fee of \$25.00 per property for costs incurred by the Department of Nelghborhood Services. Each instance of nulsance activity occurring at the property may be deemed a separate violation of the ordinance and is subject to billing. Once the owner/licensee has been billed on three (3) or more separate dates within one-year time period for the costs of enforcement concerning nulsance activities, this property may be deemed a chronic nulsance pursuant to Section 80-10(6)(MCO), and each and every subsequent incident of nulsance activity at this property may result in a citation(s) being issued to the owner/licensee for chronic nulsance violations.

The owner of the aforementioned premises, Stephen L. Perkins of 2435 N. 46th Street, Milwaukee, WI 53210 will be apprised of this cost referral request by providing a copy of this letter to said owner. The recipient has the right to appeal pursuant to Sec. 80-10-5 of the Milwaukee Code of Ordinances within thirty (30) days of this letter.
