


PROGRAM OVERVIEW

Home Environmental Health Program responds to lead poisoned or lead exposed children at 15 mcg/dl and greater, orders are issued to abate identified lead hazards. Each case receives an environmental inspection and nurse case management services.

- Target population are children 0-6 years of age, investigate children that are screened and identified with elevated blood lead level.
 - Current community partners: Social Development Commission, Sixteenth Street Community Health Clinic, Community Advocates, COLE
 - Staff Information
 - RN (5), Lead Risk Assessor (13), EH Coordinator 4, Managers 4, Disease Environmental Specialist 1, Program Assistant 2, Office Assistant 1, Lead Program Information Specialist 1.
 - Current Vacancies: 1 RN, 1 Lead Risk Assessor, 1 EH Coordinator, 1 Lead Project Assistant, 1 Office Assistant

WHAT WE DO WELL

SUCCESSSES IN THE PAST YEAR

- 2018 MHD Plan of Correction has been closed as of March 23rd, 2021
 - Completed follow-up on all 112 historic properties identified on the Wisconsin DHS correction plan.
 - Implemented Public Health Nurses and Lead Risk Assessor case conferencing
 - Quickbase database, documentation and reporting enhancements
 - Staff recognition
 - Danika: Obtained her RS credential demonstrates competency in a range of environmental health issues and is first author on a research study published in a peer reviewed Environmental Health Journal of Sciences.
 - Dominique: President Elect and Board Member of the Greater Milwaukee National Association of Hispanic Nurses. And established the City of Milwaukee African American Employee Resource Group- sponsored by Erica (MCH Division Director)

PROGRAM OUTCOMES

AS OF APRIL 2021, HEH STARTED RESPONDING TO THE NON-STATUTORY EBL'S 1 (15MC/DL). EACH CASE RECEIVES PUBLIC HEALTH NURSING CASE MANAGEMENT SERVICES AND AN ENVIRONMENTAL INSPECTION.

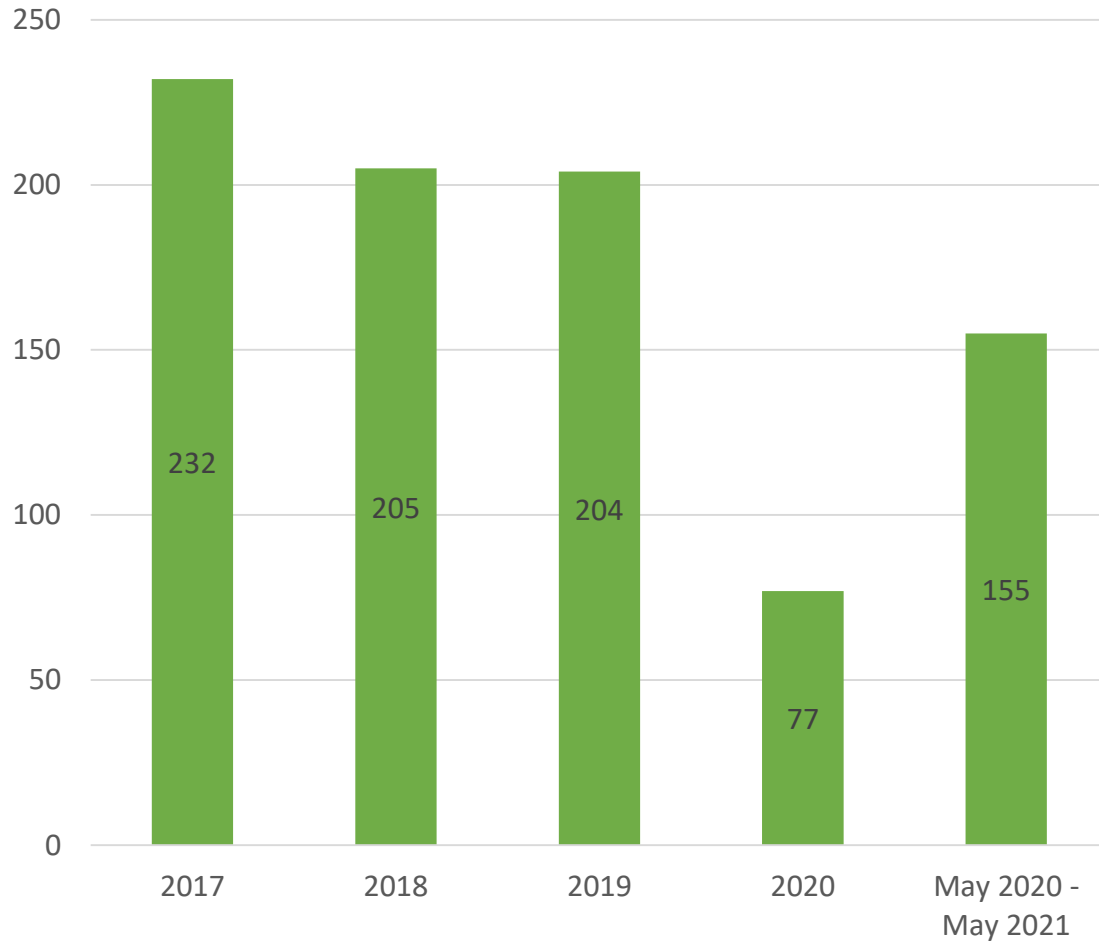

NURSING CASE MANAGEMENT BY THE NUMBERS- 5/2020-5/2021

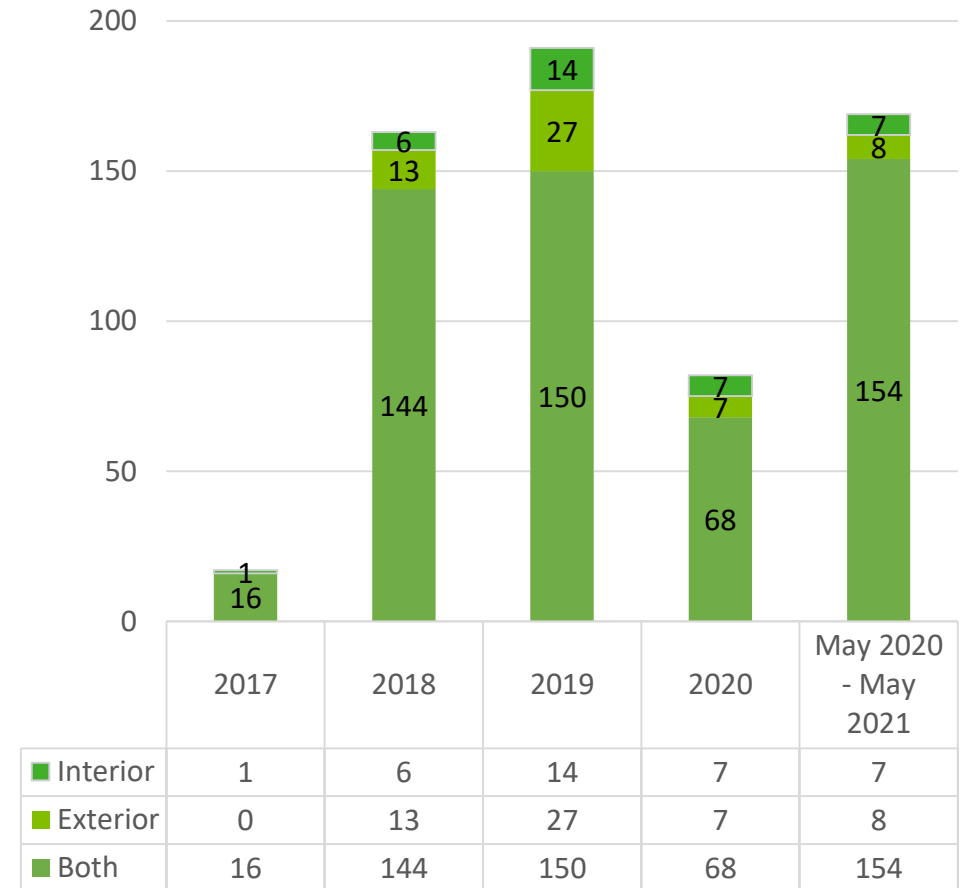

LIRA REPORTS COMPLETED BY YEAR

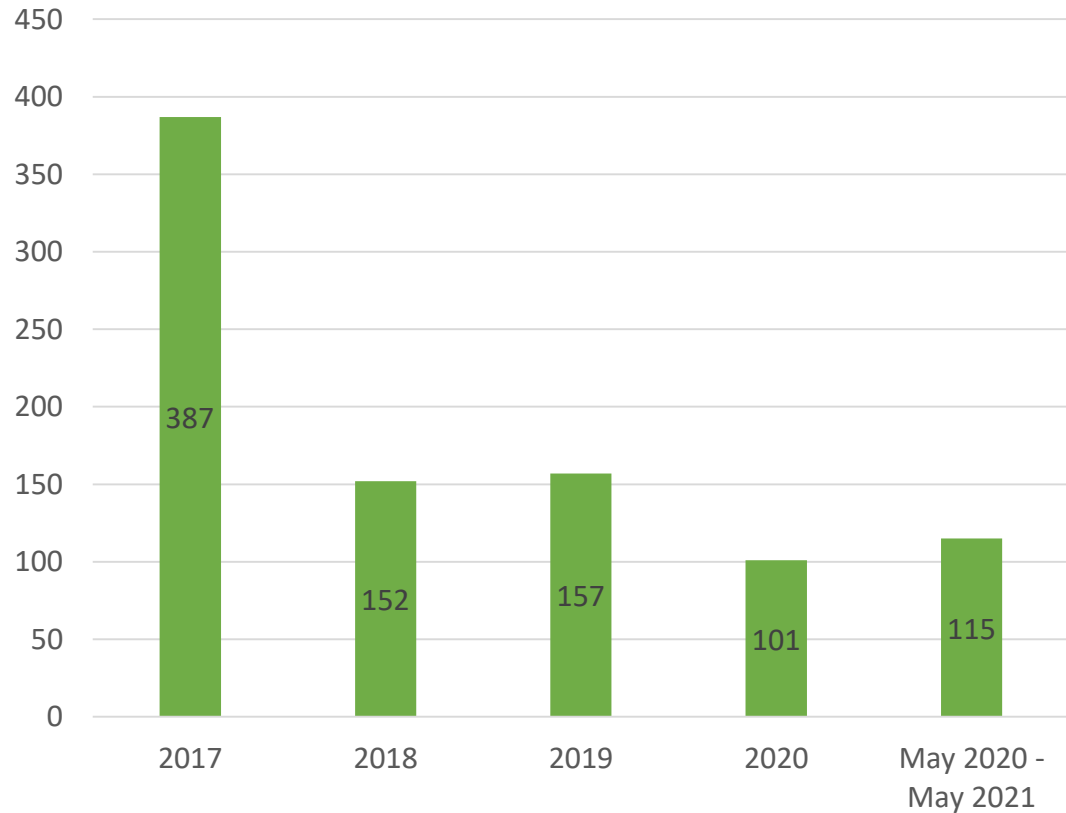


ORDERS ISSUED BY YEAR AND BY TYPE

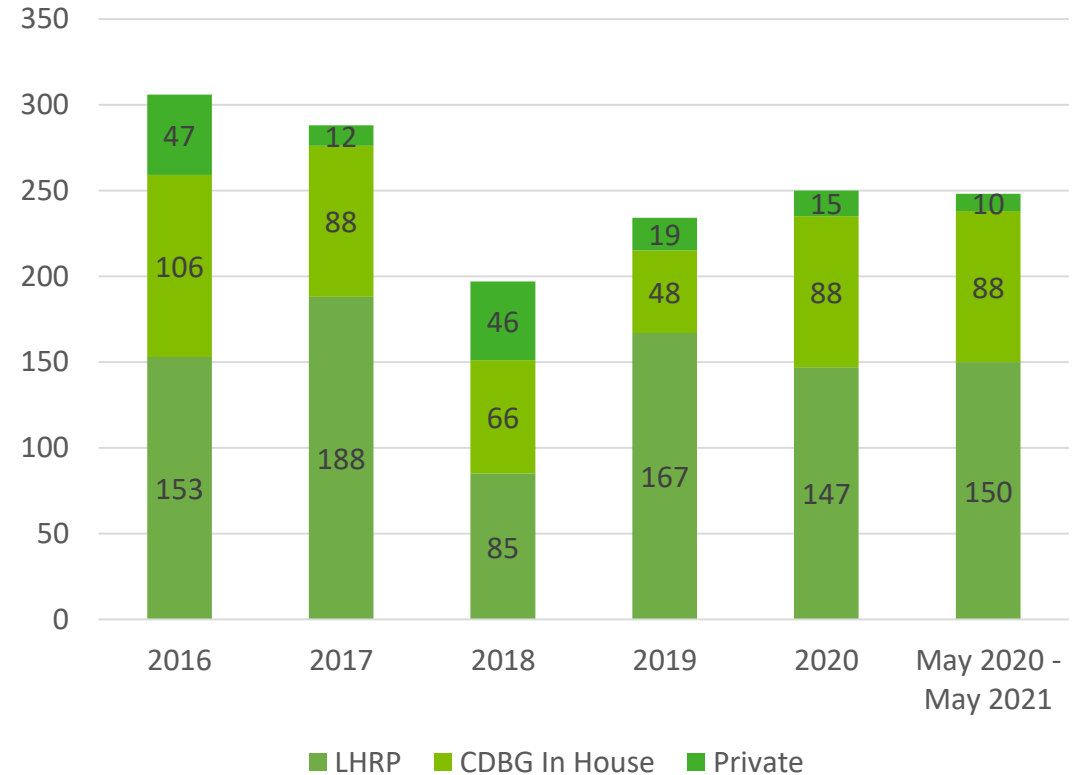


LEAD ABATEMENTS

CHALLENGES TO SUCCESS

- COVID-19
 - HEH program and community partners were working remotely, home visits and inspections were placed on hold. HEH resumed inspections on 06/08/2020.
 - Public Health nurses deployed for COVID related tasks
 - Provider reduction in seeing patients for screenings
- Absentee landlords in the city of Milwaukee
- Contractor capacity
- Operating below staff levels, hiring delays, retention of staff, LRA pay equity with other city similar positions.
