This funding builds upon ongoing efforts of the MHD Laboratory and Sexual Health Program, in conjunction with the Wisconsin Division of Public Health STD Control Section, to enhance timely surveillance for the detection of resistant GC threats locally by expanding laboratory GC culture and antimicrobial susceptibility testing capacity and capability, increasing Disease Intervention Specialists (DIS) activities towards reducing GC and syphilis morbidity in Milwaukee areas, and increasing epidemiology and laboratory capacity to identify the transmission dynamics within high GC morbidity ZIP codes in the city.

The proposal for the year ahead also aims to establish test of cure (TOC) best practices, along with separate activities related to Project T: Gonococcal Isolate Surveillance Project (GISP), whereby the MHD Laboratory would serve as a GISP site, further enhancing GC surveillance, reporting and follow-up related to SURRG activities.

2. Relationship to City-Wide Strategic Goals and Departmental Objectives:

This grant directly relates to the MHD Sexual Health Program goals of STI prevention, treatment and surveillance in the community. Gonorrhea is the second most commonly reported communicable disease in Milwaukee County. The MHD Laboratory already routinely performs antibiotic-resistance testing for GC specimens received from KHC, and these grant funds enable us to continue improving and expanding testing and surveillance services.

3. Need for Grant Funds and Impact on Other Departmental Operations (Applies only to Programs):

Year 6 funding is critical for sustaining the infrastructure and additional support needed in order to add equipment, supplies, and services that are needed to support grant activities as described above.

MHD Laboratory and STI Program staff provided regular (monthly and quarterly) progress reports to the WI DPH and CDC over the duration of the grant.
