..Analysis
This motion establishes a process for the allocation of the first tranche of funds to be received under the American Rescue Plan Act. ~~It is patterned after that used by the Common Council for the deliberation of the annual budget.~~

..Body

It is moved, By the Common Council of the City of Milwaukee, that the following procedure shall be used for the allocation of the first tranche of funds provided under the American Rescue Plan Act.

- ~~1. Common council members shall submit requests for American Rescue Plan Act~~ All allocations shall be submitted as resolutions to the ~~Office of the Common Council - City Clerk.~~ Allocations submitted previously to the under the sponsorship of a Common Council ~~as resolutions need not be re-submitted~~ member or members.
- ~~2. Requests~~ Allocation resolutions shall be ~~prepared in the order received and~~ submitted to the Department of Administration - Budget and Management Division and the Office of Equity and Inclusion for comment. ~~Allocations submitted as resolutions shall be referred to the~~

~~Department of Administration – Budget and Management Division and the Office of Equity and Inclusion for comment.~~

- ~~3. _____ A compilation of all requests Allocation resolutions shall be made public.~~
- ~~4. _____ The assigned to the Finance and Personnel Committee shall schedule a special meeting to take up all amendments submitted until par. 1. Amendments shall be taken up by department affected, departments being sorted by alphabetical order. The Finance for review and Personnel Committee shall submit its recommendations to the Common Council. Given the \$3.8 million previously allocated to the “Earn and Learn” program, these recommendations may not exceed \$193 million recommendation under the usual procedures provided in the *Milwaukee City Charter*.~~
- ~~5. _____ When the recommendations created in par. 4 are reported to the Common Council by the Finance and Personnel committee, the council shall first consider any amendments recommended for adoption by the committee, in order by department affected.~~
- ~~6. _____ The Common Council shall next consider any amendments which were submitted for consideration to the Finance and Personnel Committee but which were not recommended for adoption by the committee, provided they were submitted to the city clerk at least 24 hours prior to the council meeting, in order by budget item affected.~~
- ~~7. _____ The Common Council may next, by a non-debatable two-thirds vote of the members of the council in office at the time of the vote, accept for consideration any budget amendment which was not submitted under either par. 5 or 6.~~
- ~~8. _____ All amendments shall specify the changes in amounts and positions as the result of the amendment.~~
- ~~9. _____ Amendments to amendments may be offered to the Common Council, provided they are germane. All amendments to amendments shall be prepared in the form of a substitute to the original. Such substitute amendments shall not require a separate motion to accept the amendment for consideration in lieu of the original. If a motion to adopt such a substitute amendment fails, the question before the council shall be the adoption of the original amendment.~~
