Dear Council Members:

Enclosed please find a proposed resolution. We ask that it be referred to the Committee on Judiciary and Legislation with the recommendation outlined below.

On December 7, 2020 at approximately 9:40 PM, a semi-truck with an attached trailer was traveling northbound on North 71<sup>st</sup> Street. Attempting to park alongside the curb, the truck struck an overhanging tree branch, resulting in the attached trailer sustaining substantial damages.

Forestry conducted an investigation of this matter. The tree in question is located at 4446 N 71<sup>st</sup> Street. Forestry's investigation revealed that the tree limb struck by the trailer was hanging over the curb line. The actual height of the branch could not be determined since it was no longer in the growing position.

The service request Forestry received for this incident, was the only service request for the tree in the preceding 6 years. The vicinity of North 71<sup>st</sup> Street and West Ruby, where this incident took place, is a residential neighborhood in which the street is not designed for travel by a 53-foot trailer, such as the one involved in this loss. There was no construction on the street forcing the truck into the curb lane.
