This report is written by Police Officer Corstan D. COURT, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 02/09/21 at 10:12pm, Milwaukee Police were dispatched to 2901 N. 5<sup>th</sup> Street for a trouble with subject complaint. Upon arrival, officers observed people entering and exiting the establishment and found the street out front, lined with vehicles. Officers then tried to gain entry into the tavern but found the door to be locked and after about 30 seconds of trying to get the attention of someone inside, a subject comes to the locked door, observed that officers were outside, and turns to someone and tells them the police are at the door. Security then comes to the door and unlocks it. Inside the tavern, officers observed that people were standing shoulder to shoulder, two people using one Hookah, and people standing next to tables and on the dance floor. After asking a few security guards how many people were in the establishment, the last one stated that there were 70 to 80 patrons inside the tavern ( a rough estimate done by one of the officers revealed 170 patrons). After telling security why they were there, they told officers that they escorted the female out, along with other people due to the fact that they were trying to start fights (security made no mention of Item #2).
- 2. On 02/21/21 Milwaukee Police investigated a substantial battery which occurred on 02/09/21 at 10:00pm at 2901 N. 5<sup>th</sup> Street. The victim showed officers a Facebook video which shows the victim exchange words with another subject, inside the establishment, and he pushes the subject. The subject, who was pushed, punches the victim in the face knocking him unconscious. The subject then punches the victim three more times and walks out of the video.

#### INITIAL INVESTIGATION

This license report is written by PO David LETTEER, assigned to District 5, Late Power Shift, Sq. 5468, with PO Russell MACRAE.

This incident was recorded on our body worn cameras.

On 02-09-21 at 10:20 p.m. we were dispatched to the location of 2901 N. 5th St., Savoy's Bar, which is a licensed premise in the city of Milwaukee. We were sent to this establishment for a trouble with subject call, where a female patron was intoxicated and refusing to leave, arguing with someone inside of the bar.

Upon arrival, we observed W. Locust St. and N. 5th St., lined with vehicles, the bar had music playing and people were entering and exiting the tavern. It was estimated that the tavern had at least 100 people inside of the bar, I called for another squad. PO DUERR and PO BEATTIE (Sq. 5436), PO TERRELL and PO BURLO (Sq. 5490) also came to the tavern with us.

PO MACRAE was first entering the tavern and made entry through the outside entrance door, but when he attempted to open the inside entrance door, PO MACRAE found that the door was locked and we could not freely enter the establishment. We could hear voices inside the door yelling "It's the Police, they're standing at the door". PO MACRAE attempted to get the attention of someone inside of the tavern, in order to have someone open the door, so that we could enter the establishment. After about 30 seconds, a black male comes to the door, observes PO MACRAE and myself, then turns to someone in the tavern, yelling "Hey, someone open the door, it's the police!"

The black male then goes back into the bar and another black male, wearing a black Tshirt, which read Guaranteed Protection Services LLC, unlocks the door and let us enter

the tavern.

Upon entering the tavern, I began gathering the tavern license information, Savoy's Bar, Class B Tavern License 208408, which is set to expire 08/25/2021. I also observed the posted occupancy sign, which read 160 persons. While doing this I looked into the bar observed that people were standing shoulder to shoulder, standing next to tables, standing on the dance floor, drinking and conversing. I also observed one Hookah that was being used by two females at the bar.

PO MACRAE made contact with a male sitting at a table with a cash register upon entry to the bar. He was identified as Antonio M. JONES (B/M 02/23/74). JONES stated that he was a "Manager" and that his role was to collect money from patrons entering for a cover-charge. JONES stated that the security who was in charge of the "count" for total persons inside had changed throughout the night. JONES stated that he would personally take responsibility for the lack of count.

I was met by the husband of the listed agent (Tina JOHNSON-WILLIAMS), Orlando M. WILLIAMS (b/m 06-24-68), who stated Tina was not at the bar tonight, due to being sick. WILLIAMS asked why we were at the bar and I explained we were called for the intoxicated female. WILLIAMS stated there was a female in the bar, who was drunk and was trying to fight other people at the bar, but that his security had escorted her out of the bar. WILLIAMS also stated his security had escorted other people out, due to people getting in other peoples faces. They were escorted out of the bar, so that there would not be a fight inside of the bar.

I was able to stop one of the security persons, Gabriel A. SIMMONS (b/m 03-20-81) and asked him if he knew how many people were at the tavern tonight. He stated he did not know how many people were inside of the bar, but that his function was to check people coming into the tavern for weapons. He then pointed to another security person, James G. SEWELL (b/m 08-21-81), who stated he was working the front door. I asked SEWELL if he knew how many people were inside of the bar and he stated he had 79 or 80 people inside of the tavern. I asked him if he had a counter or clicker on his person and he stated he had just put the "Clicker up", then walking away from me, to do something inside of the bar. Both SEWELL and SIMMONS stated they started work at the bar at 7:00 p.m. and were working until bar closing. The third security person was Quintell D. ROBINSON (b/m 01-11-86), who stated he started work at 8:00 p.m. until bar closing.

While at the tavern, people were attempting to enter the establishment, but could not open the main entrance doors, due to being locked, causing patrons to bang on the front

door. It was mentioned that the front door was locked due to being at capacity.

While speaking to WILLIAMS, PO MACRAE attempted to count how many people were inside of the bar. PO MACRAE was able to get a rough estimate of (170 persons) inside of the bar which included staff, with 13 of those people leaving the tavern as soon as we entered the tavern. PO MACRAE then gathered the information of the bartenders, Shanina M. DANIELS (b/f 08-13-77) who does not have a valid bartenders license, Marquetta D. PARKER (b/f 03-15-89) who had a valid Class D Bartenders License (234751) and Latorre A. WALLS (b/f 12-20-84) who has a valid Class D License (234738), and Leroy J. JACKSON (B/M 05/07/69) who did not have a valid Class D Bartenders License.

PO MACRAE and I plan to met with the Licensee personally regarding tonight's issues in the near future.

On 02-21-21 I was advised by PO Ashley NAVONE, that she had taken a Substantial Battery at Mt. Sinai Hospital, that originally occurred on 02-09-21 at 10:00 p.m. The caller stated to PO NAVONE that he was at the bar called Savoy's, located at 2901 N. 5th St.

The victim stated that he was at Savoy's (located at 2901 N 5th St, Milwaukee WI, 53212) on Tuesday, February 9, 2021. The victim stated that while he was at the bar, he got into an altercation with an unknown male that he described as a black male, 38-41 years of age, 6'01"-6'02", medium build, medium complexion, with a gap between his front teeth, wearing all dark clothing and a black knit hat. JONES stated that he pushed the unknown male away from him as they were verbally arguing and then the unknown male struck him with a closed fist, causing him to lose consciousness.

The victim stated that he did not call the police at the time, but that his head still hurt today, so he finally sought medical treatment. The victim stated that he had a video of the incident because someone posted it on Facebook. The victim showed PO NAVONE and her partner PO O'Malia the video and you can see the victim exchange words verbally with the suspect. The victim then pushed pushed the subject. The subject then stuck the victim with a closed fist, knocking him unconscious and then the subject struck the victim three more times while he was on the ground. The subject then walked away out of camera view, and possibly left the business altogether.

The victim was asked to email PO NAVONE the video of the incident and the victim agreed to do so. The victim stated that he did not know the subject that he had the altercation with, but he thinks the owner, "Tina" knows the subject's name.

It should be noted that PO MACRAE and I responded to the bar on 02-09-21 at 10:20 p.m., License Report IR 210400187. We were at the bar for a drunken female who was removed prior to our arrival. While there we were informed that there were subjects who were about to fight, but that security had escorted the subjects out of the bar.

The hearing before the Licenses Committee will take place virtually on 9/8/2021 at 1:20 PM. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel — Channel 25 on Spectrum Cable — or on the Internet at http://city.milwaukee.gov/citychannel. Those wishing to provide oral testimony will be asked to do so by phone or internet and are asked to contact the staff assistant, Molly Kuether-Steele at (414) 286-2775 or molly.kuether-steele@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

# Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.
