My name is

I currently live

on S. Kinnickinnic Ave,

as

I just moved to Bayview in May of 2020 with my fiancé as she was pregnant with twin boys.

ne resident of Bayview and we absolutely loved the area and knew we wanted to start our family here.

However I have to say I am a bit frustrated with the current situation. The bar "The Backyard" is constantly playing music at ridiculous volume levels at all hours of the night.

We specially chose Bayview, over other areas like Walker's point because we thought it was a family friendly neighborhood. However, this bar conducts itself like it's on Marquette's campus.

I have filed noise complaints. I have spoken with the owner of the bar. I have spoken with the owner of the land whom the bar rents from. I have called the police at least 20 times and nothing

has helped. It's almost like they turned it up louder ever since I complained last summer.

Tenuta's Italian Restaurant on Clement Avenue and even when the patio is at full capacity on summer nights, they keep the volume at a reasonable level and turn it off by 9:30pm.

This bar is completely disrupting the entire neighborhood and it must stop. It's actually ridiculous. We are trying to raise newborn twins. We moved from downtown to Bayview specifically for less noise and it's 1000x worse.

I am honestly unsure how C-Viche (the restaurant neighboring the bar) can handle the noise. I feel bad for them.

I have attached videos to this email so you can hear how loud the music is. In 2 of the videos, I am on my balcony, and you can see that they have zero customers, yet they continue playing music extremely loudly. These were on a Sunday night at 11pm and tonight (Tuesday) around 9:15pm.

The 3rd video, is from inside my apartment during this past summer (September), when they played music at even louder volumes. This video was taken inside my apartment with all doors and windows shut at 8pm on a Thursday. This night my newborn son actually suffered a panic attack from the constant noise and vibrations. (Sorry for the feet in the video)

Now that my twins are 7 months old and have become more aware, they constantly wake up from the music.

Please, please, please make them turn the music off by 9pm and play it at more reasonable volumes while it is on.

We have tried EVERYTHING.

Thank you so much for your time and I am so sorry for bothering this late at night.

This is another email about the excessive noise from the same bar that I've been complaining about. The music ceased for maybe three total days. This is absolutely ridiculous. I have been listening to obnoxious music since noon today. Last night the music blared until past midnight.

My little sister who is nine years old planned on sleeping over last night. She made my dad come pick her up at 11:30pm because the music was making her nauseous.

My windows have literally been shaking since this afternoon. This is absolutely ridiculous!!!!!!!!

WE HAVE BEEN ASKING FOR YOUR HELP!!! WHERE ARE YOU?? ARE YOU GOING TO DO ANYTHING??? I have been told countless times that if a place gets continuous complaints they can lose their license?? Have you tried revoking it??? What are you doing to try and solve this issue?

You are supposed to be protecting the interest of your constituents!! These people at this bar don't live in this neighborhood. So you allow them to come disrupt your neighborhood and the people represent and then allow them to drive home to their quiet neighborhood while ours suffers??

You said there would be police monitoring the situation?? Where have they been?? I fully understand noise ordinances however it doesn't give people the right to make as much noise as they want during the day? You're not allowed to have excessive noise everyday all day. People can request a permit on a per day basis if they plan on making excessive noise for a party. Nobody is allowed to disrupt 2 blocks of an entire neighborhood with their music. I mean get real. This is absurd.

You're supposed to represent the middle class. Do you know what the middle class does on Mondays? They work. Or have you forgotten as you sit in your quiet office while your constituents are suffering?

People have jobs to get up for tomorrow morning, but they're not entitled to enjoy a nice evening in their home on a Sunday night?? They have to listen to DMX for 6 hours straight?

Do something. Help us. We've been waiting.

3. On 06/21/2020 at 9:35pm officers were dispatched to a Trouble with Subject at The Backyard, 2155 s Kinnickinnic Av. The officers observed a male subject on the ground being held down by security. The officer interviewed security who stated the subject slammed down his beer and the bartender wanted him to leave. The subject refused to leave and security escorted him out. A minor physical altercation occurred outside. The subject threw up several times outside and was taken to the hospital for medical treatment.

- 4. On 07/26/2020 at 10:10pm officers were dispatched to a Noise Nuisance at The Backyard, 2155 S Kinnickinnic Av. The officer spoke with the manager and advised him of the complaint of loud music on the patio. The manager was cooperative and turned down the music.
- 5. On 08/21/2020 at 12:40am officers were dispatched to a Noise Nuisance at The Backyard, 2155 S Kinnickinnic Av. The officer parked several buildings away and could hear music coming from the patio. The manager stated this volume was the normal level they played the music at. The manager was cooperative and turned down the music.
- 6. On 09/05/2020 at 1:11am officers were dispatched to a Noise Nuisance at The Backyard, 2155 S Kinnickinnic Av. The officers interviewed a bartender who asked for the name of the caller so she could make amends. The officer advised her to call open records to get that information. The bartender provided the license information and her Class D Operator's license. She then became uncooperative with the officers. She stated she has been working in the bar business for 10 years and knows the noise ordinances. The officers told her the ordinances stated the music could not be heard from over 50 feet away and she stated that information was false.
- 7. On 09/05/2020 at 8:48pm officers were dispatched to a Noise Nuisance at The Backyard, 2155 S Kinnickinnic Av. The officers did hear loud music coming from The Backyard. The officers spoke with the manager, Douglas GUEHRER, who stated he has done nothing wrong because he has a permit to play music until 11:00pm.
- 8. On 09/19/2020 at 6:17 officers were dispatched to a Noise Nuisance at The Backyard, 2155 s Kinnickinnic Av. There were three callers that stated they could hear loud music from two blocks away. When the officers arrived they could faintly hear music from 1 block away. The volume at the door was determined to be unreasonable. The officers spoke with the manager, Douglas GUEHRER, who stated he just arrived and agreed the music was too loud. The manager stated he had a meeting with police and was told he had a permit to play music until 12am on weekends. He stated he has changed the hours of the outside patio to conclude at 8pm in order to curb the noise complaints. The officers could not reach the callers to be complainants.
- 9. On 01/01/21 at 5:41am, Milwaukee Police were dispatched to 2155 S. Kinnickinnic Avenue for a fight compliant. Investigation revealed that four patrons at the tavern were involved in an altercation, the instigating group left, and the victim stated that he did not want police service.

10. On 06/07/21 at 8:42pm, Milwaukee Police conducted a license premise check at 2155 S. Kinnickinnic Avenue. There were no violation found and all licenses were in order.

Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at http://city.milwaukee.gov/citychannel. Those wishing to provide oral testimony will be asked to do so by phone or internet and are asked to contact the staff assistant, Molly Kuether-Steele at (414) 286-2775 or molly.kuether-steele@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
