This report is written by Police Officer Corstan D. COURT, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 02/28/2019 officers were dispatched to Holiday Inn at 545 W. Layton Av for a Trouble with Subject call. The officers spoke with an employee who stated they allowed a subject to charge his phone in the lobby and now the subject was making threatening statements to customers. The subject was issued a Disorderly Conduct citation and conveyed to his grandmother's house.

- 2. On 10/13/20 at 6:20pm, Milwaukee Police were dispatched to 545 W Layton Avenue for a suspicious person compliant. Investigation revealed that a subject tried to steal paper used to place key cards in. The area was checked with negative results.
- 3. On 12/29/20 at 9:59am, Milwaukee Police were dispatched to 545 W. Layton Avenue for a welfare check. The subject left prior to police arrival.
- 4. On 01/15/21 at 9:00am, Milwaukee Police were dispatched to 545 W. Layton Avenue for an entry complaint. Investigation revealed that a subject staying at the hotel had property stolen from her locked room while she was gone. The assistant manager informed police that a different room was entered the day prior and that a housekeeper's hotel key was used to gain access to the room. There are multiple cameras that may have caught the incident but the assistant manager was unable to access the system.

Managements only issue was with the homeless and people loitering who do not belong on the property. They try to handle the situation themselves but if they cannot, they will notify the police. Regarding the burglary incidents where a housekeepers' card was used to access rooms, they were able to re-activate all key cards and the thefts have stopped. A CEPTED was performed on the property and the management would like to meet quarterly with the police to voice any concerns.

Investigation revealed that a subject, who was not a customer, locked himself in the bathroom and refused to leave. On Friday, January 15, 2021 at approximately 7:53 pm p.o. Benjamin DELANEY and I were dispatched to 545 W Layton Av (Holiday Inn) for an entry call for service.

Upon arrival, I spoke with Gwenette M MCPHAIL (b/f 01-27-94) who stated she is working in Milwaukee for a nursing program. She stated she left her hotel room at approximately 9:00 am on Jan 15, 21 and returned to her room at approximately 7:45 pm. MCPHAIL stated when she returned she observed the items in her locked hotel room were scattered and she was missing approximately \$850 in electronic equipment, approximately \$3,000 in jewelry and \$500 in cash.

I spoke with the assistant manager Ann E NOLAN (w/f 09-06-82) who informed me that a different room was entered on January 14, 2021 at approximately 11:50 pm, however the victim did not wish to file a report. NOLAN stated a housekeepers hotel key card was used to enter the room but she was unable to figure out who it belonged to. NOLAN stated that after the room was entered on January 14 the master key cards for all employees were wiped and reissued.

There are multiple cameras on scene that may have caught this incident. NOLAN stated she does not have access to them however, the General Manager will be in on January 16, 2021 at approximately 7:00 am.

On Saturday, January 16th, 2021 at 9:42 AM, I was dispatched to the Holiday Inn, 545 West Layton Avenue, regarding a Burglary investigation.

Upon arrival, I spoke to the caller, Abel NMN SALAZAR, W/M, 03-21-76. SALAZAR stated that at approximately 8:00 AM today, he proceeded to look for his Apple Ipad and was unable to locate it. SALAZAR stated that he proceeded to look for his backpack as he may have placed it back in the backpack. SALAZAR stated that upon checking the area where his backpack was last located, he was unable to locate his backpack in the hotel room. SALAZAR stated that he last observed his backpack on Friday, January 15th, 2021 at approximately 6:00 PM. SALAZAR stated that all the listed property was in the backpack, with the exception of the Apple Ipad and Apple watch. SALAZAR stated that he had no further information.

SALAZAR stated that he attempted to locate his Ipod and Airpods by using the "find me" app, but was unable to locate at this time.

I then proceeded to check the door for any signs of forced entry and none was located. It appeared that the items touched by the actor(s) in this offense were taken by the actor(s) as there was no signs of ransacking at this time.

I then proceeded to take 8 photos of the scene and area where the listed property was taken from.

I then proceeded to contact District Six, Lieutenant GLIDEWELL, via telephone and Incident Notification and was advised that I would be handling the investigation.

Upon speaking to the General Manager, identified as Stephen G. MCCULLEY, it was found that a master key to the hotel had been taken from a housekeeper's cart, which was in the common area hallway to the hotel and accessible to anyone who walked past the cart. MCCULLEY stated that the key, which has since been deactivated, was also used to enter other rooms in the hotel as well. MCCULLEY stated that he would view video surveillance footage and conduct a key audit on room #255, and would notify P.O. BISCOBING regarding this information.

On Monday, January 25, 2021, at 2:25 pm, my partner Police Officer Michael WARD and I, conducted a quarterly meeting with Holiday Inn and Suites General Manager Stephen McCulley (w/m, 10/26/60) and Assistant General Manager Ann E. Nolan (w/f, 09/06/82). These meetings are conducted to go over any questions or concerns that hotels may have and go over the calls for service that are coming from the locations.

McCulley and Nolan stated that some of their most common complaints are homeless individuals that come into their property and refuse to leave the property and loiter. McCulley stated they try to handle the situations themselves but if they can not they will notify the police. McCulley stated that they had a increase in thefts, which they managed to find out what had occurred and was able to reactivate all key cards. They believe that someone took a key card from one of the house keepers carts and were able to access the individual rooms. McCulley stated since they have re-activated all key cards thefts have stopped.

The location has three parking lots on the property. One parking lot located on the north

west side of the property. On parking lot on the north of the property and one to the east. The east parking lot are mostly used for park and fly vehicles, which must be checked in with the hotel. McCulley stated that they have increased the lighting in the parking lot and currently have a total of 13 cameras. Three of which are located in the exterior of the property. McCulley stated they have 10 interior cameras which are located in the 1st/main floor but do not have cameras on the second or third floor. The hotel does have a pool and fitness center which all rooms need a key card for access and a total of 130 rooms. McCulley stated the hotel has three additional entry/exit doors, which are only access by keycard. The main entry/exit door lock at approximately 9pm and can only be opened by hotel staff. McCulley stated there are 2 employees working at night as well for safety reasons. McCulley stated that everyone who checks in to the hotel must provide an identification card.

I explained to McCulley and Nolan that there were no additional concerns that we had and that we would like to meet quarterly. Both McCulley and Nolan were provided with contact cards and were provided our main office number as well.


