This report is written by Police Officer Xavier Benitez, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 09/19/18 at approximately 2:40a.m., Milwaukee Police responded to National Hotel, located at 1515 W. National Av., for a Battery Cutting. Further investigation revealed a tenant had been stabbed by his wife. The victim was treated and released at Froedtert Hospital for treatment. No violations were observed at the licensed premise.
- 2. On 03/31/19 at approximately 12:26a.m., Milwaukee Police responded to National Hotel, located at 1515 W. National Av., for a Subject with a Knife complaint. Upon further investigation, it was determined there was no weapon involved and this was a verbal argument between the manager (Matthew T. Bellanger) and a tenant. Bellanger admitted that whoever made the call to police, lied regarding a weapon, just to speed up police service. Bellanger was advised of proper eviction procedures.

3. On 09/27/20 at 1:44pm, Milwaukee Police were dispatched to 1515 W. National Av, for a battery complaint. Officers spoke with the victim who stated that one of the other tenants called him a derogatory name and then spit at him. The victim stated that there is a prior history with the tenant. Officers were unable to locate the suspect and gave the victim paper work regarding a restraining order. Officers obtained the suspect information and advised the victim a citation would be issued.

- 4. On 10/23/20 at 12:35pm, Milwaukee Police were dispatched to 1515 W. National Av, for a battery complaint. Officers spoke with management who stated that a suspect that was subleasing room # 105 struck him in the face, causing pain. Officers located the suspect and the original renter of room #105. The renter stated that he gave permission for his friend to stay in his room. Officers arrested the suspect and processed him at District #2 for a battery citation. While officers were processing the suspect, they heard over the police radio another call of service at the location regarding the original renter, making threats to tenants.
- 5. On 10/26/20 at 10:00am, Milwaukee Police were dispatched to 1515 W. National Av, for a trouble with subject complaint. Officers spoke with the manager who stated that an ex tenant was outside the premise and was not allowed at the location for striking another manger on 10/23/20. Officers spoke with the ex-tenant and informed him that he was not allowed on the premise. The subject was informed and that he could be cited for trespassing if he did not comply. The subject agreed to leave the location, with no further incident.
- 6. On 10/26/20 at 10:30am, Milwaukee Police were dispatched to 1515 W. National Av, for a subject with weapon complaint. Officers spoke with caller who stated that he was in a physical confrontation with the tenant of room #105. The caller stated that he would like to prosecute the tenant for battery regarding the fight. Officers spoke with staff who stated that both parties were involved in a fight. The staff provided officers with the other tenant's information. Officers spoke with the tenant in room #105, who stated that he was involved in a fight regarding the other subject bothering him. Officers explained that both parties would receive citations. The subjects involved declined to press charges and did not complain of injuries. Officers spoke with staff and stated that staff should take steps to remove the person responsible for the disturbance.
- 7. On 10/27/20 at 8:30am, Milwaukee Police conducted a license premise check at 1515 W. National Av. Officers of District #2, spoke with the owner of the rooming house regarding the large volume of police calls of service. The owner was advised that within a short span the property had 60 police calls for service with sometimes as many as 6 calls a day. The owner was notified that he would be receiving an 80-10 nuisance status for the location. The owner stated that he was aware of the problems and has removed 3-4 tenants that were the main contributors to the police calls of service.
- 8. On 11/03/20 at 10:07am, Milwaukee Police were dispatched to 1515 W. National Av, for a battery complaint. Officers spoke with caller of room #205 who stated that he was walking down stairs and the tenant in room # 105 starred at him and tried to hit him. Officers spoke with the other party involved and the subject stated that the other tenant berated him and called him racial slurs. The onsite manger stated that the tenant in room #205 is moving in 2 days and if he does not, he would be evicted. Officers informed the tenant in room #105 to avoid the other subject until he moves out and to call the police if the subject threatens to fight him.
- 9. On 11/08/20 at 8:06am, Milwaukee Police were dispatched to 1515 W. National Av, for a trouble with subject complaint. Officers spoke with the owner of the property who requested police because he wanted to go inside a tenant's room to check on him. The owner previously knocked on the door and the tenant threated to punch whoever was knocking. The owner stated that he had the right to go inside to make sure the tenant was following his building policy. Officers informed the owner that there was no legal authority to enter the tenant's room. The owner would have to start the eviction process if he was having problems with the tenant.

- 10.On 11/13/20 at 6:58am, Milwaukee police were dispatched to 1515 W. National Av, for a dead on entry complaint. Management of the building allowed police access to the cameras for the investigation. The cause of death was regarding medical issues.
- 11.On 11/27/20 at 10:55am, Milwaukee police were dispatched to 1515 W. National Av, for a dead on entry complaint. Officers spoke with witness at the location, who stated the deceased had an ongoing illness, but did not want to seek medical attention. Building management were cooperative with officers during the course of the investigation.
- 12. On 03/04/21 at 1:03am, Milwaukee police were dispatched to 1515 W. National Av, for an over dose complaint. Officers met the tenant of room #214. The tenant of the room stated that at 1:00am his brother entered his room and collapsed. The subject was unconscious but breathing. Milwaukee Fire department medical arrived on scene and administered narcan to the subject. The subject responded and was now awake. The subject refused further medical treatment from MFD medical. Officers informed the tenant if the subject's condition worseness to have him receive further medical treatment.

On Sunday, September 27th 2020, at 1:44 PM, we were dispatched to a Battery complaint at 1515 W National Ave, located in the City and County of Milwaukee (WI), with my body camera fully functional, operating at the time of the investigation, and attached to my right shoulder lapel.

Upon arrival, we spoke with the victim/caller of the Battery complaint, identified as Brandon J Duncan (B/M, 03-30-1984), in front of the apartment complex. Duncan stated at approximately 1:25 PM on today's date, he was leaving his apartment (Room 208) to use the shared restroom on the floor when his neighbor, later identified as Oscar R Rodriguez (H/M, 12-14-1976), who lives in Apt 205 started following him and watching where he was going. Duncan stated he has an unpleasant history with Rodriguez, so he yelled at him to stop following him. Duncan stated Rodriguez then, intentionally and without consent, spit at him, then proceeded to call Duncan a "Nigger". Duncan stated their manager, only known to him as "Bill" witnessed the entire incident, however when Duncan asked Bill if he saw the incident, Bill told him yes but left the floor and then left the location in his vehicle, refusing to help at all. Duncan stated Rodriguez is a problem in this apartment complex, as he starts problems with many tenants and also deals drugs there.

Upon reviewing prior calls at the location, we obtained the full information for the suspect in this Battery complaint.

Duncan was given Restraining Order paperwork and advised that we would be issuing a citation and also arresting Rodriguez if we could locate him.

On Friday, October 23rd, 2020, squad 2421 (PO Miguel BENITEZ and I) was dispatched to a battery complaint located at the rooming house at 1515 W National Av in City and County of Milwaukee.

It should be made aware that there had already been two separate calls for service for this location already on 10-23-20. (CAD 20-297-0376 & 20-297-0654).

Upon arrival at the location the on-site management, William S KVIDERA (W/M, 03-14-56) indicated that he had been punched in the face by the tenant's in room 105, James M COMBS (B/M, 01-29-92) sub-leasing roommate known as an approximately 20YOA Native American male named "Joe". Neither COMBS or "Joe" were on scene when officers arrived having fled from the building.

KVIDERA stated that the actions were done without consent and with intent. KVIDERA stated that his prescription worn glasses were damaged during this incident.

PO BENITEZ and I checked the area for the subjects and did not locate them. At approximately 12:56PM the subjects ("Joe" and COMBS) arrived back at the location and were threatening members.

PO BENITEZ and I made contact with COMBS and "Joe" who was identified as Joseph AVENDO (N/M, 03-17-00). AVENDO stated that nothing had happened between himself and the management on scene earlier. AVENDO also stated that he was given permission from COMBS to be able to live at the location and not management. It should be made aware that COMBS is the only person listed on the lease for room 105.

AVENDO was placed under arrest and transported to District Two and later released with a battery Citation. (Citation # J981DG26P0).

IT SHOULD ALSO BE MADE AWARE that while PO BENITEZ and I were at District Two processing AVENDO another call for service (CAD# 20-297-1091) came through for 1515 W National AV stating that COMBS approached another resident involved after police left with AVENDO threatening to stab him (Brian G EMMERICH (W/M, 03-27-79) for getting his roommate AVENDO arrested.

On Monday October 26, 2020 at 10:30am we were dispatched to a subject with a weapon complaint at the Nation Hotel located at 1515 W National Ave. It is located in the City and County of Milwaukee. Upon our arrival we were met at the door by the caller, identified on scene as Steven L KNUTSON (w/m D.O.B 02-01-1990) who stated, that he had been "tussling" with someone (later identified as James M COMBS b/m D.O.B 01-29-1992) who was the occupant of room 105. KNUTSON stated that COMBS was in the lobby causing a disturbance and that KNUTSON was trying to help out the staff. We interviewed KNUTSON and determined that both KNUTSON and COMBS had thrown punches at each other.

KNUTSON stated, that he placed COMBS in what he described to be a "head lock" to attempt to gain control of COMBS. On scene was a witness identified as Steven D HANNON (w/m D.O.B 10 -07-1966) who stated, that he is a staff member at National Hotel and witnessed both COMBS and KNUTSON exchange punches and push each other, HANNON stated, that while KNUTSON was walking away COMBS approached KNUTSON and punched him in his back. It should be noted that the National Hotel staff did not identify either of these parties as employees. KNUTSON stated, that COMBS is "crazy" and should take him to get evaluated at MCMH. I then requested from the office staff the information of COMBS, and was provided his name and room number. KNUTSON stated, before making contact with COMBS that he wanted to prosecute him for the battery.

We approached room 105 and made contact with COMBS who was cooperative and discovered that both KNUTSON and COMBS were involved in mutual combat and that KNUTSON stuck COMBS as well. COMBS stated, that the incident occurred because KNUTSON "got in his business" and was bothering him by continuously knocking at his door and asking for cigarettes. We notified COMBS that KNUTSON wished to press charges for battery, and COMBS stated, that he would like to do the same. Upon explaining the process of going to court for the citation both COMBS and KNUTSON both decided they did not desire prosecution. Neither party was injured during the fight or required medical services. National Hotel front office staff were informed that they are responsible for the safety of their guests and that if there is one occupant that is causing a disturbance that they should take steps to have that person removed.

On Monday, September 7, 2020, at approximately 12:16pm, Milwaukee Police officers responded to the premise for a "Battery" complaint. During the investigation, officers located the caller/victim, who is a tenant at the premise, stated that he was in a verbal argument with another tenant, and during the argument the subject intentionally struck him with a hammer in his head causing bleeding and bruising, which required medical attention. Officers were subsequently able to locate and arrest the suspect after the incident.

On Sunday, August 30, 2020, at approximately 2:28pm, Milwaukee Police officers were dispatched to St Luke's Hospital for a "Battery Cutting" complaint, which occurred at the premise. During the investigation officers spoke with the victim who stated that he was at the premise, when a tenant from the premise attacked him with an unknown sharp object, causing lacerations which required medical attention. Officers were subsequently able to locate and arrest the suspect after the incident.

On Thursday, September 24, 2020, at approximately 4:10pm, Milwaukee Police officers were dispatched to the premise for a "Battery" complaint. The caller, a tenant at the premise, called 911 regarding threats and harassment that occurred 4-5 days before. The resident intentionally placed a 911 emergency call for the purpose of communication not related to the reporting of an actual emergency.

On Thursday, September 24, 2020, at approximately 10:04pm, Milwaukee Police officers were dispatched to the premise for a "Trouble with Subject" complaint. The caller, an intoxicated tenant at the premise, called 911 regarding an incident with another tenant that occurred the day before. The resident intentionally placed a 911 emergency call for the purpose of communication not related to the reporting of an actual emergency.

On Thursday, September 24, 2020, at approximately 11:19pm, Milwaukee Police officers were dispatched to the premise for a "Battery" complaint. The caller, an intoxicated tenant at the premise, became engaged in a physical altercation with another tenant at the premise, creating a disturbance at the premise.

On Thursday, September 27, 2020, at approximately 10:50am, Milwaukee Police officers were dispatched to the premise for a "Threat" complaint. The caller stated that another tenant at the premise entered his room without his permission, and threatened to batter the caller, causing him to fear for his safety. Officers on scene issued the subject a citation for Disorderly Conduct.

On Thursday, September 27, 2020, at approximately 1:44pm, Milwaukee Police officers were dispatched to the premise for a "Battery" complaint. During the investigation officers spoke with the caller, who stated that another tenant at the premise began following him as he exited his apartment.

The victim then told the subject to stop it, at which time the subject spit on the caller and yelled racial slurs at him, which caused the subject to fear for his safety. Officers on scene attempted to locate the subject to issue a citation for Disorderly Conduct.

On Thursday, March 4, 2021 at approximately 1:03 AM, Squad 2322 (PO Matthew WILSON and I) were dispatched to 1515 W National Av (NATIONAL HOTEL), in the City and County of Milwaukee, to investigate an Overdose complaint.

Upon arrival, I observed a black male subject standing by the entrance door of 1515 W National Ave, this building is a rooming house with three floors and multiple rooms. The male subject informed me the manager who was located in apartment 214 called police and was informed to let police into the building.

On scene, we walked to the second floor, apartment 214, where we locate the building manger who was identified as William S KVIDERA (w/m, 3/14/56) along with the resident and renter of 214 who was identified as Robert F. SCHWARTZ (w/m, 10/08/63). SCHWARTZ stated his brother who he only could identify as "BRIAN" walked into his room at approximately 1:00 AM, on today's date and collapsed right away. SCHWARTZ stated "BRIAN" is his half brother but would not provide any other information. KVIDERA stated "BRAIN" has been staying with SCHWARTZ for the last four days however could not provided any other information.

We observed a white male subject wearing a neon green shirt, with bold lettering, blue jeans and blue Nike tennis shoes, on the ground, not conscious but breathing and snoring. We observed new needles on the bed, in its original packaging and not used. All the medication on scene, belonged to SCHWARTZ.

MFD Engine 23 and 26, green shift, lead by LT BAUS arrived on scene. MFD administered 1.75 mg of Narcan.

"BRIAN" responded to the NARCAN, in which he began to vomit and complain of being really cold. As MFD attempted to continue their medical treatment, "BRAIN" continued to vomit and eventually was placed on the bed. "BRAIN" stated he did not know were he was and how he got there. "BRAIN" stated he did not want to go to the hospital for medical treatment. MFD then left scene.



National Hotel will continue to expand and improve existing practices to ensure a safe and secure living environment, including the following points, in addition to expanded use of points of action. We welcome your feedback as to this process, and are open to suggestions, with the confidence that our Plan of Action is comprehensive to the extent that it will facilitate growth in a positive, safe, secure, and productive community-oriented environment.

- 1. Building Manager to attend October 7, 2021 City of Milwaukee Live In-Person Landlord Training Course Proof of Registration enclosed.
- 2. Management to thoroughly screen applicants to recognize and identify applicants with history of violent, aggressive, harassing, or otherwise unlawful conduct on non-discriminatory basis, consistent with local, state and federal law.
- 3. Management to ensure tenants carefully review and understand tenant rules and regulations, including by meeting with new tenants to go over rules and regulations.
- 4. Any violations of tenant rules and regulations to be promptly brought to attention of tenant to ensure tenant understands rules and consequences for further violations.
- 5. Installation of additional security cameras throughout building.
- 6. Security cameras to be monitored for violations of rules and regulations.
- 7. Installation of additional lights.
- 8. Posting of tenant rules and regulations in prominent places throughout the facility.
- 9. Posting of Building Manager and Security Manager contact information to encourage tenants to immediately report rule violations.

- 10. Training of Management to continue to foster and develop positive relations with local law enforcement in event of unlawful activity.
- 11. Security Manager to continue to reside in building continue to regularly monitor upper floors.
- 12. Building Manager to continue to reside in building continue to regularly monitor first floor.
- 13. Management to communicate frequently with ownership to inform of any issues needing attention.
