There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-2.7-4, probative evidence concerning whether or not a new license should be granted may be presented on the following subjects: whether or not the applicant meets the municipal requirements, the appropriateness of the location and premises where the licensed premises is to be located and whether use of the premises for the purposes or activities permitted by the license would tend to facilitate a public or private nuisance or create undesirable neighborhood problems such as disorderly patrons, unreasonably loud noise, litter, and excessive traffic and parking congestion. Probative evidence relating to these matters may be taken from the plan of operation submitted with the license application, if any, but shall not include the content of any music. Evidence regarding the fitness of the location of the premises to be maintained as the principal place of business, including but not limited to whether there is an overconcentration of businesses of the type for which the license is sought; whether the proposal is consistent with any pertinent neighborhood business or development plans, or the location's proximity to areas where children are typically present. The applicant's record in operating similarly licensed premises; and whether or not the applicant has been charged with or convicted of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the activity to be permitted by the license being applied for or any other factor which reasonably relates to the public health, safety or welfare may also be considered. See attached police report or correspondence.

Notice for applicants with warrants or unpaid fines:

Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.

Failure to attend this meeting may result in the denial of your license. Individual applicants and partnership applicants must attend or attend by an attorney. The agent or attorney for corporate or limited liability applicants must attend. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition attend the virtual hearing and are willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should request an interpreter attend the meeting with you, at your expense, so that you can answer questions and participate in your hearing.

Patty,

Here is my general concern about those machines. They are legal, as long there is an option to "check for prizes" (or some wording of that nature), because the courts have deemed them not to be gambling machines. The machines DO encourage loitering in a business at all hours of operation and provide a reason for a potentially problematic person to remain in a business for much longer than the usual amount of time required to purchase items. From what I've seen the customers who use these machines are the same subjects who panhandle in and around the properties. I liken the machines to selling single condoms, "chore boys", digital scales, single cans of high alcohol content beer, etc... businesses have some control over what customers they attract based on what items or services they provide. These choices have a factor in how the business operates and is viewed by the neighbors.

3. On 12/10/2012 officers conducted a licensed premise check at 2310 West Greenfield Avenue (Citgo) based on an anonymous tip that the business was selling single cigarettes. The applicant denies selling single cigarettes and officers discovered no evidence to substantiate the complaint.

4. On 11/10/13 at 10:13 am, Milwaukee police were working the Wisconsin WINS Tobacco Initiative and had an underage student enter 2310 W Greenfield in attempts to purchase tobacco products. The clerk, identified as Joga Gill, sold a package of Show Buzz flavored cigars without asking for ID. Gill admitted the sale and was cited.

5. On 12/05/2015 a 17 year old working in conjunction with Milwaukee Police Department and the WI WINS Tobacco Initiative entered the Citgo at 2310 W. Greenfield. He was able to purchase a grape flavored Cigarillo. The clerk admitted to selling the Cigarillo. The applicant was advised of the M.A.R.T.S program.

- 6. On 02/18/2016 Milwaukee police responded to a trouble with a subject complaint at 2310 West Greenfield Avenue. The caller, Satya Jati, told police he was working at the store around 3:40am when a subject entered the store and removed several bags of pork skins from the shelves. The caller believed this subject was going to steal the pork skins, and told him he was going to call police. The subject then returned the pork skins to the shelf and threatened to kill the caller if he came outside. The subject then left the store. The caller told the officer he did not want to press charges.
- 7. On 09/24/2016 the applicant was cited at 3105 N. Holton Street in the city of Milwaukee.

- 8. On 01/13/2017 at 10:55pm officers responded to a trouble with subject call at 2310 W. Greenfield Av. The officers spoke with the applicant who stated he called because there was a subject refusing to leave and blocking the door. The subject was gone when the officer arrived.
- 9. On 02/05/2017 at 10:55pm officers responded to a sick and injured person at 2310 W. Greenfield Av. The officers found MFD treating a female who had admitted to using heroin. The victim's friend stated she was giving her friend a ride, when she became unresponsive. She pulled over and called for medical attention. While waiting she administered Naloxone. The victim was released from the scene.
- 10. On 02/08/17 at 8:36 am, Milwaukee police were dispatched to 2310 W Greenfield for a hit and run which caused damage to one of the gas pumps. A report was filed.
- 11. On 02/23/17 at 2:58 pm, Milwaukee police were dispatched to 2310 W Greenfield for a trouble with subject complaint. A woman had thrown items off a shelf and told the clerk to call police. Officers responded and the woman told police she did it because she wanted to go to MCMH. She was a voluntary C7 and conveyed to MCMH.
- 12. On 03/21/2017 at 10:42am officers responded to 2310 W. Greenfield Av for a suspicious person call. The officers spoke with the caller who stated 3 subjects were fighting in the store. The subjects left before the police arrived.
- 13. On 04/10/2017at 7:37pm officers responded to 2310 W. Greenfield Av for a sick/injured person. The officers found MFD treating a female inside the store. The female stated she was smoking crack in the area when she started having chest pain. She went to this location to call medical attention.
- 14. On 04/26/17 at 12:45 pm, Milwaukee police were dispatched to 2310 W Greenfield for a sick/injured person call. A woman caller stated a female needed help in the stations laundry mat. Police responded and found a known drug abuser, medical was called and she was conveyed to a hospital for treatment.
- 15. On 04/26/17 at 2:22 pm, Milwaukee police were dispatched to 2310 W Greenfield for a panhandler complaint. Upon arrival, the subject was gone.
- 16. On 05/20/17 at 2:45 pm, Milwaukee police were dispatched to 2310 W Greenfield for a trouble with subject complaint. Upon arrival, the subject was no longer on scene.
- 17. On 05/29/2017 at 5:58pm officers responded to 2310 W. Greenfield Av for a trouble with subject call. The officers interviewed the applicant who was the caller. He stated he had two subjects panhandling in front of the station. The applicant stated he confronted the subjects and they threatened to harm him so he called the police. The subjects were not on scene when the police arrived.

- 18. On 06/19/17 at 10:02 am, Milwaukee police received a complaint of seven subjects loitering and causing a disturbance at the Citgo gas station located at 2310 W Greenfield. Upon police arrival, subjects were no longer on scene.
- 19. On 07/04/2017 at 10:24am officers responded to 2310 W. Greenfield Av for a trouble with subject complaint. The caller stated there was a known subject who loiters outside the business harassing customers. The caller just wanted the subject to leave and not return.
- 20. On 07/05/2017 at 7:38pm officers responded to 2310 W. Greenfield Av for a trouble with subject. the caller was the applicant who stated there was a subject panhandling in front of the station. The officers cited the subject who is a known to the officers.
- 21. On 07/11/17 at 10:39 pm, Milwaukee police on routine patrol observed an auto drive into the gas station lot located at 2310 W Greenfield. A DOT check revealed that the plate did not list to the auto. Police conducted a traffic stop and the car drove forward over the curb and became stuck. The driver and passenger were ordered out of the car and were temporally detained. The vehicle was towed for safe keeping and a search prior to the tow revealed a box filled with a green leafy substance which later tested positive for THC was found in the trunk. Both subjects were arrested and taken to D2 for processing.
- 22. On 07/12/17 at 4:44 pm, Milwaukee police were dispatched to 2310 W Greenfield for a additional information. Police spoke with the clerk, Joga Gill, who advised police that on 07/10/17, property damage was done to the emergency fuel pump shut down system. A subject had removed the entire unit from the stores exterior wall. Due to regulations, this forced the Citgo to stop operations until it was fixed approximately 18 hours later. Gill estimated the loss of sales in gas to be \$7000-\$8000 during that time. Gill further stated he did not know how much the repair would cost and would advise police as soon as he received a bill. Video surveillance showed a male, known by police, walk up to the emergency fuel shut down box and begin pulling it. The male is then seen holding a box shaped item and he leaves that area. He is then seen returning and walking up to the propane lockers and begins manipulating the cage as if he was trying to pry it open. The male then attempts to open the lid in the ground where gas is filled and stored. He leaves the area shortly after. The subject was later found and arrested on warrants and charged with property damage.
- 23.07/24/17 at 2:15 pm, Milwaukee police were dispatched to 2310 W Greenfield for a subject down. The clerk, Bidyut Mondal, stated a female asked to use the bathroom around noon and continued assisting customers. Mondal stated around 2 pm, he went to the bathroom and observed a female laying on the floor unconscious. The female had overdosed on heroin and medical was called while police administered Narcan. She was conveyed by MFD to a near by hospital.
- 24. On 08/02/17 at 1:45 pm, Milwaukee police were dispatched to 2310 W Greenfield for a fight complaint. Police were advised that a female was trying to enter cars and would not leave. Upon police arrival, the woman was gone.

- 25. On 08/06/17 at 10:08 am, Milwaukee police were dispatched to 2310 W Greenfield for a trouble with subject complaint. The caller was requesting police for a woman who was refusing to leave and causing a disturbance. This woman had been warned in the past that she was not allowed on the property. Police cited the woman for disorderly conduct and loitering.
- 26. On 08/14/17 at 1:48 am, Milwaukee police were dispatched to 2310 W Greenfield for a shooting complaint. Police spoke with the clerk, Bala Alavindia, who stated a victim of a shooting came into the gas station and sat in the store for 16 minutes and attempted to stop the bleeding from her gunshot wound. Avaindla stated he asked the victim several times if she wanted him to call an ambulance and the victim declined. Avaindla still did not call police and left the business open during the incident. Avaindla also mopped up evidence regarding the shooting. Cameras located inside and outside the store at the fuel pumps captured the incident on video.

27. On 09/08/18 a 17 year old working in conjunction with the Milwaukee Police Department and WI WINS Tobacco initiative, was able to purchase a 2 pack of Swisher Sweet Cigars at 2310 W. Greenfield Avenue, The sales clerk admitted to selling the item and the station was mailed a MARTS enrollment packet.

- 28. On 08/12/19 at 12:30pm, Milwaukee Police were dispatched to 2310 W. Greenfield Av., for an Armed Robbery. The victim stated upon exiting the store he was approached by an unknown male, who displayed a small black handgun and demanded the victim's personal items. The victim stated he threw his fanny pack to the ground. The clerk was cooperative and provided video surveillance to officers.
- 29. On 10/17/19 at 2:38 pm, Milwaukee Police responded to a ShotSpotter investigation at 2310 W. Greenfield Av. On arrival officers were able to locate 10 shell casings and 2 bullet fragments in front of the gas pumps. The clerk was identified as Mondal BIDYUT, and stated he did witness the incident; however, he did not call 911. MONDAL could not provide a reasonable explanation as to why he did not call the police. Video surveillance shows 2 suspects, who were patrons of the gas station, later exchanging gun fire in the parking lot near the gas pumps, with a third suspect. All three suspects fled the scene. Other patrons, who were on scene, fled the gas station lot for their safety.

- 30. On 10/28/19 at 10:09pm., Milwaukee Police were dispatched to an Armed Robbery complaint at 2310 W. Greenfield Av. The victim stated he was having problems purchasing gas with his debit card, at which time he entered the store and asked the clerk if he could use Apple Pay or a Cash app to purchase gas. The clerk, Singh DALJIT, stated he could not accept that as a form of payment, and the victim exited the store. Once outside the victim stated he was approached a female who agreed to give the victim cash for the transfer on a cash app. The victim stated he agreed and transferred \$110.00 via the app, when a second suspect approached and pointed a firearm stating "if you call the police I will kill you". Both suspects fled the scene. Officers were unable to obtain video surveillance of the incident.
- 31. On 10/29/19 a meeting was held at District 2 with Milwaukee Police and the licensee from 2310 W. Greenfield Av. The main concern in this area is that employees do not call police or seem to be hesitant to call police when illegal activity is occurring, specifically the shots fired in Item #29 on 10/17/19. The issue of prostitution, concerns by neighbors and surrounding businesses, as well as the volume of calls for police was also addressed. The licensee was served with a nuisance designation.
- 32. On 11/12/20 at 12:12am, Milwaukee Police were dispatched to 2310 W. Greenfield Avenue for an armed robbery complaint. Investigation revealed that a customer was putting air in his vehicle tires when a subject approached, robbed him, and fled the scene. The employee was very cooperative with the investigation and video surveillance captured the incident.
 - 33. On 04/06/21 Milwaukee Police conducted a License Premise Check at Citgo Gas Station, 2310 W Greenfield Av. This was in regards to information received regarding entertainment machines on the premise without a license. The officer did observe 2 machines in operating condition on arrival. The officer spoke to the agent and advised that he needed to obtain a Public Premise License to operate the machines. The agent was cooperative and agreed to apply for the license. No other violations were observed.

I advised GILL this was correct, however, he would still need a PEP license in order to have them operational. GILL stated he understood and would apply immediately for the proper license.

The hearing before the Licenses Committee will take place virtually on 9/20/2021 at 1:25 PM. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at http://city.milwaukee.gov/citychannel. Those wishing to provide oral testimony will be asked to do so by phone or internet and are asked to contact the staff assistant, Molly Kuether-Steele at (414) 286-2775 or molly.kuether-steele@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.


