2. Approval of the July 9, 2009 meeting minutes

Ald. Bauman moved approval of the minutes. There were no objections.

Roll call taken at 11:33 A.M.

Mr. Kammholz leaves.

3. Status report and discussion on the housing trust fund award process

City Attorney Tom Gartner appeared on this matter.

Mr. Gartner handed out a letter and a spreadsheet that he put together that explains the status of each of the organizations that have received a housing trust fund award (Exhibit 1). He then gave an update on where each of the organizations are in the award process. He said he did not include in his handout the exact dollar amounts that have been disbursed as of today.

Ms. Madden said if the disbursement of monies takes place when each unit is complete, how does that match with the housing trust funds financing gap as far as last dollars into the project?

Mr. Gartner replied that the policy requirement that the housing trust fund dollars are to be the last dollars into a project is a problem, because it puts a burden on the awardee. He said that is an issue the Community Blocks Grant Admin. (CDGA) staff needs to resolve.

Ald. Murphy said the rationale on why this board had establish the policy that requires the housing trust fund dollars be the last dollars into the project is due to the risk that the dollars could be lost if a project would go under.

Ms. Sanchez asked if there is an official policy for the disbursement of HTF dollars?

Ald. Murphy replied in the affirmative.

Ms. Sanchez asked if the policy could be amended by being more flexible when determining the timeframe for disbursement of funds? She said that the timeframe for the disbursement of funds could then be determined on a case by case basis.

Ald. Murphy asked Mr. Mahan to give his advice on the timeframe for the disbursement of HTF dollars?

Mr. Mahan replied that he agrees that putting the money up front is risky. He said that to prorate the funds to be disbursed by units completed could work and that is something this board could consider doing.

Mr. Peters asked if the money could be disbursed early by requiring some kind of collateral? Would that reduce the risk?

Mr. Gartner replied that housing trust fund dollars are not the first mortgage lender for the project and the housing trust fund dollars are a very small potion of a project's total funding and if a developer would foreclose on a project the housing trust fund dollars would not be the first on the list to receive its funds back. He also said that the CDGA staff should be given some flexibility in its procedures on when the funds can be disbursed.

Ald. Murphy said that the applicants should be advised from the beginning that the housing trust fund monies will be the last funds in and there are no exceptions.

Mr. Soika said he would not be in favor of the housing trust fund dollars being the first in.

Mr. Soika referred to Mr. Gartner's handout and asked Mr. Gartner about his timeline

on finalizing the housing trust fund agreements?

Mr. Gartner replied that he has other work, other than housing trust fund award agreements, that requires his attention and he has to establish priorities. He also said that if an awardee contacts him and says that their project needs to proceed immediately he would focus on getting that project agreement completed.

Ald. Murphy replied that he hasn't heard from any of the awardees that their project is being held up because their agreement isn't completed.

Ald. Murphy said that he met with Mercy Housing representatives yesterday and they are not going to continue to pursue their request for early disbursement of their housing trust fund award. He said they are moving forward with their project.

Ms. Sanchez asked how was the announcement of the housing trust fund Request for Proposal (*RFP*) made public?

Mr. Mahan replied that the housing trust fund RFP was noticed in the Community Journal (Northside), Community newspaper Spanish El Conquistador (Southside), Journal/Sentinel and on the City of Milwaukee, Community Dev. Grants Admin. Website. He said WHEDA was also notified.

Ms. Sanchez said the technical assistant training session is scheduled for Wed. Oct. 14th and the due date for the RFP is on Monday, Oct. 19, 2009 and she feels that the training session is being scheduled a bit too close to the due date of the RFP.

Mr. Mahan suggested that the due date for the RFP could be moved from Oct. 19th to Friday, Oct. 23rd.

Ald. Murphy said that for the next housing trust fund RFP the training session should be scheduled at least two weeks prior to the due date.

4. Discussion relating to the City of Milwaukee's active tax incremental districts

Ald. Murphy referred members to the spreadsheet provided by the Mr. Kammholz, Comptroller's Office, that shows a list of all the active Tax Incremental Districts (Exhibit 2).

Ald. Murphy said the City is seeking a change in state legislation that would authorize the use of one additional year of TID financing to assist in financing housing projects. He said, in addition, Ald. Bohl is also looking at requesting the use of TID financing for City street repair.

Ald. Murphy said he and Ald. Bauman have reviewed the City's 2010 budget and the TID funds are at a negative balance.

Mr. Soika said he met with Ms. Mary Brooks yesterday and she recommended that this board ask the Council to look at getting TID financing for housing for 2011.

Ald. Murphy replied that he will continue to work on the legislation and will bring it back again next year.

5. Discussion relating to the implementation of donation recommendations

Mr. Mahan said that this board should be aggressive in reaching out to United Way and convincing them into adding the housing trust fund to its list of donation recipients.

Mr. Peters asked if *Mr.* Mahan considered Community Shares?

Mr. Mahan replied that he is not familiar with Community Shares.

Ald. Murphy said this board should look a pursuing both United Way and Community Shares.

Ald. Murphy said the Mayor's 2010 proposed Budget allocates \$400,000 in additional funds to United Way.

Ms. Madden asked how would this board go about getting United Way to add the Housing trust fund to its list of programs to be funds?

Ald. Murphy replied that the next step would be to invite United Way to appear before this Board so that they can learn more about the housing trust fund. He said a petition needs to be submitted by City to the United Way.

Ald. Murphy said he and Mr. Mahan will work on putting together a plan and bring it back before this board for consideration.



Re: Status of the Housing Trust Fund Award Process

Dear Alderman Murphy:

In a September 22, 2009 letter I was asked to provide a detailed report relative to the status of projects which have received awards through the Housing Trust Fund Advisory Board. Attached for your consideration is a spreadsheet prepared by the City of Milwaukee CDGA which lists (i) the 15 Housing Trust Fund Grant awards approved to date; (ii) the amount of each award; (iii) the date of the Common Council Resolution approving the award; and (iv) the total number of housing units for each such award.

The three Grant Agreements which have been executed to date pertain to the Bishop's Creek Family Housing Project, the Heartland Housing/Guest House Project and the St. Catherine's Residence, Inc. Project.

Grant Agreements for each of the remaining projects, except the Mercy Housing Lakefront Project, have been drafted and are currently in varying stages of review. In addition, EBE Agreements have been drafted for all of those projects which will be subject to the City's EBE requirements and Regulatory Agreements have been prepared for recording in conjunction with those projects where such regulatory agreements are necessary in order to memorialize ongoing compliance with grant requirements.

Given the varying progress on the individual projects I am unable to provide an estimated time for the execution of each individual grant agreement and the related documentation. Working together with the CDBGA, I will endeavor to meet the timetables of grantees required for closings and construction as they are scheduled for each project.
