Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 07/19/18 at 3:40 pm, Milwaukee Police were conducting sales of alcohol to underage persons and had a female, who was 19 years old, enter 1901 W. Atkinson Avenue (Tip Top Foods) in an attempt to purchase liquor. The 19 year old was sold a Smirnoff Ice Smash Containing 8% alcohol. The clerk was identified as Ranjit KAUR who, because of a language barrier, called the agent and the officer's explained the situation. The agent was advised that a letter will be sent to him regarding the "Respect 21" program.

2. On 03/01/21 officers conducted a license premise check at Tip Top Foods, 1901 W. Atkinson Av. Officers interviewed the sole employee on scene and requested to see his Class D Operator License, since alcohol products were offered for sale. The employee stated he did not have one, however, called an employee with a valid Operator License to take over operations at the store. No other violations were found.

On 03-01-21 we conducted a license premise check of Tip Top Foods, located at 1901 W Atkinson Ave., which is a licensed premise in the city of Milwaukee.

Upon entering, I was met by Ashar SINGH (w/m 07-09-94) who was the clerk behind the counter and the only person working in the store. I was able to located the Class A license (0199312), which expires 10-31-21. As I was looking around the store from the cashier area, I observed coolers with beer and various alcohol products. I asked SINGH if he has his Class D Operator's license. SINGH seemed confused by what I was asking for.

We informed SINGH that if alcohol was to be served that the agent, Gagan GILL needed to be present or he (SINGH) needed to have a Class D license. It should be noted that when we entered the store, we did not observe SINGH sell any alcohol.

We informed SINGH that he could not sell alcohol and if there was alcohol to be sold, a person with a Class D license would need to be present until 9:00 p.m. SINGH then called Tajinder SINGH (w/m 09-24-71) to come to the store and take over alcohol sales. I did observe a Class D Operator's license belonging to Tajinder displayed on a cigarette cabinet. We waited at the store until Tajinder arrived, but until he arrived we made sure that customers coming into the store did not purchase any alcohol.

Tajinder did arrive and stated he would stay at the store until close. He stated that he would also assist SINGH in acquiring a Class D Operator's license.

Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

## Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
  - a. Include only information relating to the above license application.
  - b. Include only information you have personally witnessed or seen.
  - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
  - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.

**Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.**
