


SYPHILIS STRIKES MILWAUKEE


The City of Milwaukee has seen a 300% rise in syphilis cases during the COVID-19 Pandemic

Increasing cases in women, persons who exchange sex for money, and IV drug users.

Figure 2. Syphilis Incidence Trends 2018 — 2020

A significant rise in new syphilis cases was seen in the City of Milwaukee during 2020, in particular the later half of the year. As the figure shows, this spike in cases is limited to the City of Milwaukee and does not affect incidence within Milwaukee County or the surrounding Southeast Region of Wisconsin.



STI Incidence in the City of Milwaukee, January 1, 2016 - September 15, 2021







USING DATA TO GUIDE ACTION

- 1. Targeted testing and outreach to key population(s)
- 2. Pilot new field testing and treatment model
- 3. Partner with trusted community organization(s)
- Ensure follow-up for those with medical and social needs are met

HEPATITIS C

- 1% all adults (2.4M) living with chronic Hep C
- Only 56% cases aware of diagnosis
- Hep C now treatable within primary care
- MHD has necessary lab technology
- Referral pathways for connection to care and case management
