PLEASE NOTE: A zoning change is being considered for the property within the boundary shown on the map on the reverse side of this notice. If your property is not within the zoning boundary, then you are receiving this notice because your property address is within 200 feet.

DEAR PERSON OF INTEREST:

The Common Council has referred file number 210714 to the City Plan Commission (CPC) for recommendation. This file relates to the change in zoning from Two-Family Residential, RT4, to Local Business, LB2, to allow commercial uses on the properties located at 3610 and 3616 West Vliet Street, on the northeast corner of West Vliet Street and North 37th Street, in the 15th Aldermanic District.

This zoning change was requested by the Department of City Development (DCD) and will allow commercial uses on the subject sites. More specifically, these sites are currently owned by the City of Milwaukee. A Request for Proposals (RFP) was issued by DCD for these sites earlier in 2021, and a buyer was selected to purchase and renovate the existing building. The zoning change to LB2 would allow a wider mix of uses within the building that are consistent with the Vliet Street corridor, including a commercial kitchen, retail, and residences on the upper floor. **Please refer to the reverse side of this notice for map details.**
