There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. This report is written by Police Officer Corstan D. COURT, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 10/29/2015 the applicant was cited at 2311 North Murray in the city of Milwaukee for Sale of Alcohol to Underage Person.

2. On 02/27/2017 Milwaukee police responded to an injured person at St. Mary's Hospital. The victim, Megan Demunck, told officers she had been at Scooter's Pub (158 East Juneau Avenue) when an argument began between a male and a female inside the business. The male broke a glass and kicked one of the broken pieces in anger. This piece of broken glass struck Demunck in the leg, causing a laceration that required 6 stitches. Milwaukee police incident report #170580007 filed.

- 3. On 03/30/2017 a 20 year old Milwaukee police aide, working in conjunction with Milwaukee police, was able to enter Scooter's Duke's on Water (150 East Juneau Avenue) where she was served a Miller Lite beer. An officer later informed Todd Wargula that the business had failed.
- 4. On 06/17/2017 Milwaukee police responded to a trouble with a subject complaint at Dukes (158 East Juneau Avenue). Investigation revealed a subject attempted to gain entry to the business after bar hours. When he was told he could not enter, the subject broke the glass on the door with his fist. The subject was cited for vandalism.

5. On 08/26/2017 officers were dispatched to a fight at Dukes on Water, 158 E. Juneau Av. The investigation revealed two subjects, who were friends, got into an argument over one of their girlfriends. One subject attempted to hit the other while in the bathroom causing the subject to slip and fall hitting his head. The subjects were kicked out by security. A Disorderly Conduct citation was issued.

- 6. On 03/17/2018 an officers was outside Duke's on Water, 150-58 E. Juneau Av, and observed an altercation between one of Duke's security, Abdullah GILBERT, and another person, Aaron WUEBBEN. The investigation revealed WUEBBEN was in line waiting and became upset with the wait. He was stating GILBERT was not letting him in because of his race and he then grabbed GILBERT by the throat causing GILBERT to push WUEBBEN to the ground and hold him for Police. WUEBBEN was cited for Disorderly Conduct.
- 7. On 07/15/2018 officers were flagged down for a fight at Duke's, at 158 E. Juneau Av. The officers observed a security guard from Dukes, Travis COLEMAN, stepping on a subject, Jarvis NTABA, lying on his back. COLEMAN stated NTABA was upset because he was not being let inside after "last call" and got in his face in an aggressive manor. COLEMAN stated he grabbed his shoulders and performed a leg sweep, taking him to the ground and held him for officers. NTABA had pain to his head and was taken to the hospital for evaluation.

8. On 11/29/2018 officers conducted underage tavern enforcement in District 1. An underage Police Aide attempted to gain entry to Dukes on Water, 158 E. Juneau Av. The Police Aide was allowed entry and was served a Miller Lite for \$4.00. The bartender was identified and issued a citation.

9. On 03/07/2019 at 2:02am officers observed multiple people inside Duke's on Water, 158 E. Juneau Av, after closing time. The officers entered and observed 6 patrons inside the bar and 2 drinks on the bar. The bartender stated he was trying to get the patrons out but they were not leaving fast enough and they try to remain friendly with patrons so they will become repeat customers. The officers advised him the patrons must be out of the bar by closing time.

- 10. On 03/18/2019 at 12:42am an officers observed a patron exit 158 E. Juneau Av with an open bottle of beer. The officer advised the subject he had to return to the bar with the alcohol and reminded security that patrons could not exit with alcohol. The officer observed the tavern was very busy and asked the security guard what his patron count was. The guard stated he was not keeping count. The officer spoke with the manager who stated he has not been keeping count but knows they are below capacity. When asked how he knows they are below capacity he stated he has been doing this for 18 years and has been through many counts, so he knows what 400 people in the tavern looks like. He was advised that St Patrick's day is a very busy day on Water St and it is best to keep a count to remain under capacity.
- 11. On 05/23/2019 at 11:13pm officers observed patrons of Duke's on Water leaving the tavern with open glass bottles of beer. The officers conducted a licensed premise check and observed the patrons standing shoulder to shoulder with no room to move. The officer asked the security person at the door what his patron count was, and he stated he did not know. The officer attempted to locate the manager but was unable to find him in the bar. The officer returned at closing time to speak with the manager about the violations. He stated he knows they are not over capacity because he has been doing this for 18 years and knows what 400 people in the bar looks like.
- 12. On 05/26/2019 at 1:50am a Police Sergeant observed a Dukes on Water bouncer standing in the middle of the cross walk yelling at a patron. He observed the bouncer pointing in the face of the patron threatening to beat him up. The sergeant approached the bouncer and told him to return to the bar. The sergeant then spoke with the manager of Duke's, who stated he had been threatened by customers several times and he was closing early because of an unruly crowd. The sergeant advised that Code Red officers were nearby to help.
- 13. On 06/11/2019 officers, along with agents from the WI Department of Revenue, conducted a licensed premise check at Duke's on Water. The two bartenders, who did have valid operator's licenses, could not provide paper copies to the officers. The officers observed that the posted Class B Tavern license was expired and advised the manager to post the current license.
- 14. On 08/24/2019 at 1:53am officers were flagged down by security at Scooter's Pub for a subject who was sick. The officers observed a subject, sitting at the bar, begin to vomit and fall to the floor hitting her head on a bar stool. The bartender stated the subject came into the bar intoxicated and was only served alcohol when her friend ordered it. The bartender stated she took the alcohol away when the patron got sick. The subject was conveyed to the hospital for being incapacitated by alcohol.

15. On 12/22/2019 at 12:07am officers responded to Duke's, 158 E. Juneau Av, for a Trouble with Subject. The officers a subject punch another patron and flee the scene. The officers spoke with security in an attempt to identify the subject. Security was uncooperative with the officer saying he didn't have to be a witness. The manager was cooperative with the officers and did identify the subject as a frequent patron. Another patron made a complaint that she was pushed to the ground by security. The security officer was issued an Assault and Battery citation. The patron who was punched stated he did not want to prosecute for his incident.

16. On 03/02/2020 officers conducted training at Duke's on Water, 158 E. Juneau Av, in the identification of fake ID's. There were 10 security member there for the training.

17. On 07/24/2020 at 11:02pm officers spoke with the manager of Duke's, 158 E. Juneau Av, about foot traffic around the tavern. Suggestions were made about the entrance and exit of patrons from the business. The manager was receptive and stated they would make the necessary changes.

- 18. On 01/30/21 at 2:22am, Milwaukee Police were flagged down for a fight at 150 E. Juneau Avenue. Investigation revealed that a security manager had to physically escort a patron out of the establishment and when they got to the front door, he two hand pushes the patron through the front door into a snow bank. While the patron is walking away, the security manager strikes the patron in the face causing him to fall and he begins to taunt the patron as he is on the ground. The patron then flees the scene and is pursued by the security manager. The security manager, along with the majority of the security staff were terminated and the new security manager said that a new surveillance system will be installed.
- 19. On 12/18/20 at 12:30pm, Milwaukee Police received a call from a subject who lives above 158 E. Juneau Avenue complaining about the noise emanating from the tavern. The complainant said that the tavern turns on the music around noon on the weekends and stays on until bar close. Officers responded to the establishment and spoke with the manager who stated that he would turn the music down.
- 20. On 02/07/21 at 1:40am, Milwaukee Police were dispatched to 158 E. Juneau Avenue for a battery complaint. Investigation revealed that an armed security guard was battered by a patron they were escorting out of the tavern. The armed security guard lost consciousness from the altercation and when he woke up he observed the subject walking towards him. He then drew his firearm and ordered the subject to stay back. The subject then fled on foot.
- 21. On 04/20/21 at 1:50am, Milwaukee Police were dispatched to 158 E. Juneau Avenue for a Threat compliant. Upon arrival, officers interviewed the caller/employee who stated that two subjects entered the establishment at bar close and asked for drinks and the bartender refused them service. The subjects became irate and had to be escorted out of the tavern by the caller and when they were outside, the subjects threaten to shoot up the establishment. While the subjects were walking away, surveillance footage captured one of the subjects breaking a window at the tavern. The tavern staff was helpful and cooperative with the investigation.\
- 22. On 06/12/21 at 12:34am, Milwaukee Police responded to 158 E. Juneau Avenue for a shots fired complaint. While walking near the tavern, officers heard what appeared to be a single gunshot from inside the tavern. Investigation revealed that a group of males and females were arguing inside the establishment and security was escorting them out when someone fired a single shot inside. None of the employees witnessed who fired the shot and officers recovered surveillance footage. The bar staff was cooperative regarding the incident.

- 23. On 06/14/21 at 12:00am, Milwaukee Police conducted a license premise check at 158 E. Juneau Avenue. Officers interviewed the manager who stated that they are going to make some changes to the tavern due to events that have recently occurred. These changes include, starting a weekend cover charge, the purchase of two hand-held metal detectors, a dress code, and at the end of the night security will help clear the corner and the front of their business.
- 24. On 06/15/21 at 12:19am, Milwaukee Police were dispatched to 158 E. Juneau Avenue for a battery complaint. Investigation revealed that a female was kicked out of the tavern for slapping a male and antagonizing fights with patrons. While outside the male and female began to fight and the male was assaulted by numerous males. The female was arrested for an outstanding warrant.
- 25. On 06/30/21 at 1:08am, Milwaukee Police observed a fight outside 158 E. Juneau Avenue. The fight was broken up and investigation revealed that a female, who was denied entry earlier in the evening, came back and spit in a bouncer's face. The bouncer then grabbed the female, fearing that she might retrieve a weapon from the vehicle she exited before the assault, and tried to flag down police. While looking for the police, a male subject approached the bouncer and both subjects began to assault the bouncer. The incident was captured on surveillance footage and the male subject was cited.
- 26. On 07/30/21 at 2:00am, Milwaukee Police observed a tavern violation at 158 E. Juneau Avenue. One of the windows was open to the location and people were talking through that window. When officers entered the tavern, they observed 4 employees and two unknown people who were later to be identified as and off-duty employee and a regular citizen. A co-owner was told about the incident the following night and they said that they would address that with staff.
- 27. On 09/02/21 at 2:00am, Milwaukee Police observed an altercation outside of 158 E. Juneau Avenue. While dealing with the argument, officers observed patrons inside the tavern with zero intention of being out of the tavern by 2:00am. An officer went inside and observed 15-20 people still standing inside as well as people in the men's bathroom. The manager told officers that she was one of only two employees and did not have any reason as to way there were still patrons inside the tavern after hours. The tavern has been warned previously about having patrons in the bar after hours.

#### INITIAL INVESTIGATION

This report is written by PO Brian WUNDER assigned to District One, Late Power Shift.

On Saturday 1-30-2021 at approximately 2:23am while working "Code Red" Squad 1441 (PO Jason CHADWICK and I) along with SGT Vincent WOLLER (Squad 1411) were flagged down regarding a fight that originated 158 E. Juneau (Dukes on Water) which is in the City and County of Milwaukee.

The investigation revealed a bouncer identified by the security manager as Antonio S DUNDY (B/M 05/03/91) walked up to two patrons as they were seated at the bar. DUNDY escorts one of the patrons out of the bar without incident. DUNDY then returns and approaches the 2nd patron. A short confrontation ensues between DUNDY and the 2nd patron, eventually leading to DUNDY physically having to escort to the front door.

DUNDY then two hand pushes the patron through the front entrance, at which point the patron stumbles and falls into a snowbank before picking himself back up.

After standing back up the patron begins to walk away and is then struck in the face with a closed fist by DUNDY, causing him to fall to the ground between Dukes and Scooters bar (154 E Juneau Ave). DUNDY the stands over the patron, who is now completely off DUKES' Premises, and taunts the patron.

The patron again stands up and is swung at by an unknown subject. DUNDY pursues the patron as he is fleeing W/B from the area in an attacking manner.

Shortly thereafter a large altercation takes place out of camera view, where the 2nd patron is severely injured (Broken Orbital Bone)

The incident was captured and reviewed on DUKE'S CCTV System. No further CCTV footage exists in the surrounding area to identify any further actors and/or employees involved.

Prior to this event, DUNDY was informed his shift leading into January 31st 2021 would be his last.

In addition to DUNDY, the majority of the Security Staff was terminated.

Dukes's new Security Manager has stated a new CCTV system will be installed in the near future and has requested MPD assistance in training the new security staff.

This report is written by PO Molly PLUMLEY, assigned to District One, Late Power Shift.

On Friday, December 18, 2020 while assigned to Desk Officer, I took a phone complaint regarding a noise nuisance at Dukes On Water (158 E Juneau). The caller identified himself as STEINPAS, Daniel G. (W/M 2/8/1968). STEINPAS stated he lives above Dukes On Water, in apartment #209. STEINPAS stated he is having a problem with the loud music/base from the bar vibrating his floor. STEINPAS stated the loud music has caused him to have migraines and lose sleep. STEINPAS stated the music turns on around noon on the weekends, and stays on until well after bar close. STEINPAS stated he has talked to the managers regarding the loud music, and he gets the impression that they think they can do what they want. I informed STEINPAS that I would be filing this report regarding his complaint.

PO DEBRASKA and PO KREMSEROVA (Sq#1440) responded to Dukes on Water and spoke with the manager who they identified as HUTCHINSON, Daniel J. (W/M 4/9/1978). HUTCHINSON stated he would turn down the music for STEINPAS. It should be noted that PO DEBRASKA's observations reflected that the music in the tavern was no louder than it normally is, and the outside speakers for the tavern were turned off.

This report is being submitted by Police Officer Lorenzo HERNANDEZ, Squad 1240, in full duty uniform, wearing a Body worn camera. I was partnered with Police Officer Fidah MUSTAFA. I am currently assigned to District one, early shift.

On 03/03/21, at approximately 7:39 PM, P.O. MUSTAFA and I were dispatched to 158 E Juneau Ave for a Battery call for service. This address is located in the City and County of Milwaukee, Wisconsin. This location is a tavern and is conjoined with Scooters pub (154 E Juneau ave.) Milwaukee Police Sergeant Jeffrey PAUTZKE, Squad 1212 was also on scene.

See Police Officer MUSTAFA's supplemental report regarding digital photographs, witness statement, and video surveillance.

Upon arrival I spoke with the victim verbally identified as Colton K DILLON (w/m 10/26/95.) I did not notice any obviousness bruising on DILLON's person.

DILLON stated he went to the "Scooter's" side of the bar and assisted the other bouncer identified as Nolan T. GARRISON W/M 7/6/2000.

DILLON stated he asked GARRISON, "Is this guy getting kicked out, GARRISON acknowledged, "Yes." On Tuesday, 04/20/21 at 2:15am, my partner PO Ester KREMSEROVA and I (Squad 1440 with body camera worn/activated) were dispatched to a threat complaint at 158 E Juneau Ave (Duke's On Water). Upon arrival we spoke with the caller, Daundre KAFKA, who stated that 2 patron's that he removed from the bar had been outside threatening to shoot at the tavern. KAFKA stated that the subject's came into the bar for drinks right after they had announced the last call (1:45am). KAFKA stated that the bartender would not serve the subjects and they became irate. KAFKA stated that they began yelling and cursing because they would not be served. KAFKA stated that the bartender asked him to remove the subject's, which he then did. KAFKA stated that once the subjects were removed one of them began yelling threats that he was going to shoot up the tavern. KAFKA stated that at this point he called the police.

KAFKA described the subject's as follows: Suspect 1 - b/m, 30yoa, 5'05", 190lbs, dark complexion, short braids and wearing a navy blue puffy Columbia zip-up jacket. Suspect 2 - b/m, 28yoa, 5'09", 185lbs, light complexion, bald and was wearing a gray flat brim baseball hat.

KAFKA stated that suspect 2 was the person threatening to shoot at the tavern.

I then spoke with the bartender, Margarita LIMON, regarding what she observed during the incident. LIMON stated that the 2 suspects came into around bar close asking to be served. LIMON stated that last call had already been announced so she would not serve them. LIMON stated that they got upset and began causing a scene by yelling and swearing. LIMON stated that she gave them several opportunities to calm down or she would have security remove them. LIMON stated that she eventually told KAFKA to remove the suspects. LIMON stated that once they were outside the tavern she could hear one of them threaten to shoot at the tavern. LIMON stated that KAFKA called the police and that she had the remaining customers stay inside until we arrived. LIMON also informed me that when the suspects were walking away from the location one of them broke a window (\$500) on the east side of the building. LIMON was not sure which suspect damaged the window but we could review the surveillance video to find out.

I spoke with the manager, Jeremy CHARUSCH, when he arrived on scene. CHARUSCH was able to show us the surveillance footage from the tavern. We were able to observe the suspects inside the bar as well as outside on the sidewalk after they had been removed from the tavern. We were able to observe at 2:13am, suspect 1, pick up an unknown item from the sidewalk and throw it against the damaged window. Both suspects then walk north on water street out of camera view. CHARUSCH informed me

I was walking near the tavern and heard what I believed to be a single gunshot from inside the tavern. Once inside I located a single casing on the ground inside the front door of the tavern. The casing was a R&P 9mm Luger brass casing that I placed on MPD Inv# 21021641.

While on scene I spoke with the bar staff regarding the incident. I spoke with Lyle NOVY (Bartender) regarding what he observed. NOVY stated that he had his back toward the crowd but could hear several subject's arguing loudly. NOVY stated that he heard a loud gunshot and then got on the ground. NOVY did not see anyone fire a gun.

I also spoke with Margarita LIMON (Bartender) regarding what she observed. LIMON stated that she observed a group of males arguing with several females. LIMON stated that security approached the 2 groups and began escorting them toward the door. LIMON stated that she then heard a single gunshot come from the group. LIMON did not see who fired the gun.

I then spoke with Amanda KRANZ (Manager/Bartender) regarding what she observed. KRANZ stated that she observed a group of males arguing with several female patrons. KRANZ stated that the argument began escalating so she turned the music to the bar off and yelled for security to escort the groups out. KRANZ stated that as security was escorting the groups out she heard a gunshot so she got onto the ground. KRANZ stated that she did not see who fired the gun.

I then spoke with Arturo TORRES (Security) regarding what he observed. TORRES stated that he heard KRANZ yell for security regarding a group of unruly patrons. TORRES stated that he began escorting the group toward the front door when someone fired a single gunshot. TORRES stated that he could not tell if the gunshot came from the people he was escorting toward the door or someone else inside the tavern.

On Wednesday, June 30, 2021 at 158 E. Juneau Ave, located in the City and County of Milwaukee, at 1:08 AM I observed subjects fighting in front of the location.

I spoke with the victim, Jeremy R. CHARUSCH (w/m, 10-27-84), who stated earlier in the evening he had a group of males and females attempt to enter the bar but they were refused because of improper identification. CHARUSCH stated the suspect, Iyana S. VASSER (b/f, 10-24-02), was a member of the group and when she was refused entrance she attempted to push her way past him. CHARUSCH stated he had put his arm in front of VASSER blocking the door to prevent her from entering. CHARUSCH stated the group then left the location.

CHARUSCH stated later in the evening he was standing by the front entrance when a vehicle pulled up and stopped directly in front of the door. CHARUSCH stated VASSER exited the vehicle and ran up to him and spit in his face. CHARUSCH stated VASSER then turned back towards the vehicle. CHARUSCH stated he feared VASSER was going to retrieve a weapon from the vehicle and he feared for his safety. CHARUSCH stated he approached VASSER before she was able to return to the vehicle and took control of one of her arms. CHARUSCH stated he turned his body away from VASSER while holding her arm and began looking for Police Officers who he had observed patrolling the area earlier. CHARUSCH stated he saw Officers in front of the bar just before VASSER arrived in the vehicle. CHARUSCH stated that a male subject who was also in the vehicle exited the vehicle and attacked him also. CHARUSCH stated the male subject punched him with a closed fist several times on his body which caused him pain. At this point Police arrived.

CHARUSCH stated VASSER bit him in the back and scratched the left side of his neck causing him pain. CHARUSCH stated he did not consent to being spit on, bit or scratched and wished to prosecute.

CHARUSCH was issued a PV-17 and a Community Contact Card.

Squad 1921, PO Peter ULATOWSKI, took photos of the scene and of CHARUSCHs injuries.

CHARUSCH declined medical attention but stated he would go to the hospital at a later date and would provide Officers with information regarding his injuries.

LEFLORE stated the female suspect approached the victim in an "aggressive" manner and saw her spit in the victims face. LEFLORE stated he saw a male exit the vehicle also and approach the victim in an "aggressive" manner. LEFLORE stated from his experience if they approached him in the "aggressive" manner he would have felt as if they were going to assault him. LEFLORE stated the male subject had his fists "clinched" as he approached the victim. LEFLORE stated he went to aid the victim who was being assaulted by the female and male. LEFLORE stated he did not sustain any injuries.

The male subject involved was issued a citation and released at District One, Citation # J981KNTWTJ.

I was standing on the N/E corner of the intersection of N. Water St. and E. Juneau Ave. when I observed several subjects physically fighting on the N/W corner of the intersection, 158 E. Juneau Ave. When I and other Officers arrived on scene we separated the subjects and detained one male and one female. The victim, CHARUSCH, informed me the two had just assaulted him.

I observed the victim to have scratch marks on the left side of his neck which were bleeding and a bite mark on his back near the middle of his shoulder blades that was approximately the size of a \$.50 cent coin.

CHARUSCH provided video of the incident via email, description to follow:

The victim is standing on the steps of the entrance to the bar where he works. The suspect arrives in a gold or silver Honda. Suspect exits the front passenger side door. Suspect jogs up to where the victim is standing. Suspect spits in victims face, victim attempted to block the spit. Suspect then attempts to return to vehicle. Victim takes control of suspects right arm. Suspect then starts striking victim with an open hand on his back and on the back of his head. Male in vehicle exits front driver door and advances to where suspect and victim are standing. Witness is seen intervening pulling male subject away from victim and female suspect. Female suspect is seen continuing to strike victim. All subjects then go out of camera view.

On Thursday, September 2nd 2021 my Partner PO Jesse MATTSON and I (squad 1442) were monitoring bar closing on N. Water St. and E. Juneau Ave.

We observed Squad 1432 PO Erik RODRIGUEZ and James DAUER activate their emergency squad lights in front of Dukes on Water located at 158 E. Juneau Ave. We drove our squad car to back them up. As we arrived we observed individual's outside of Duke's arguing and yelling at each other. I activated my Body Worn Camera as I exited the vehicle.

It was approximately 1:57 AM when we looked inside of Duke's and observed individuals still inside drinking with zero intention of being out of the tavern at 2:00 AM. We observed one Security Staff member working who was outside at the time, and one bartender inside the bar. At 2:00 AM I walked inside and observed approximately 15-20 people still standing inside, as well as some people in the Men's bathroom.

I spoke with the Manager who identified herself Amanda A. KRANZ (W/F 10-09-77). She stated she was the only bartender working and only had one Security Staff member working. She was aware that everyone had to be out of the Bar by 2:00 AM, and did not have any reason as to why there were still patrons in after hours.

I informed her that I would be writing a License Premise report as Duke's has been warned previously about having patrons in the bar after hours.


