- 2. On 03/27/20 at 9:00am, Milwaukee Police conducted a burglary investigation at 3106 N 42nd Pl. They conducted follow up at The Citgo, 3114 N. Sherman Blvd which is next door. The employees where helpful in retrieving the surveillance footage and able to successfully download the video and use it as evidence.
- 3. On 08/16/20 at 2:48am, Milwaukee Police were conducting an investigation at 4200 W. Burleigh Street when they heard gunshots coming from the parking lot at 3114 N. Sherman Blvd. When officers went to investigate the incident, they did not find anyone injured or property damaged, but found 2 casings in the parking lot of the filling station. Officers reviewed the video surveillance but found nothing of evidentiary value.

4. On 10/02/20 at 7:17am, Milwaukee Police were dispatched to 3114 N. Sherman Blvd for an accident complaint. Investigation revealed that a vehicle struck one of the pumps while backing out of a parking space. The actor stayed on scene and a report was filed.

- 5. On 08/14/21 at 11:30pm, Milwaukee Police were dispatched to 3114 N. Sherman Blvd for a shots spotter complaint. Officers reviewed camera footage, which revealed two male subjects in a physical altercation prior to the shots being fired. The footage had technical difficulties and was not reviewed in its entirely. The business was not fully cooperative and did not want to provide officers with the clerk that was on duty at the time of the incident. Officers downloaded the video from the hard drive; the video was placed on police inventory. No casing were located near the location.
- 6. On 08/30/21 at 10:06am, Milwaukee Police were dispatched to 3114 N. Sherman Blvd, for a violation of restraining order complaint. The agent stated that a known suspect was on his property and attempted to buy groceries. The suspect was denied and told to leave the location. The suspect remained at the location and moved the outside garbage can around the location. The agent stated that the incident was captured on video, but the agent was unable to get play back. Officers provided the agent with department email and stated that the video could be emailed. Officers confirmed the restraining order is valid and checked for the suspect but was unable to locate the suspect. The suspect frequents the business and had a prior offense for violating the restraining order. Officers are pending the case and will have the incident reviewed at the District Attorney's office.
- 7. On 09/06/21 at 8:33am, Milwaukee Police were dispatched to 3114 N. Sherman Blvd, for theft complaint. The victim stated that an unknown suspect reached in to her purse and took money while she was paying for items at the counter. The suspect then fled the location on foot. The business was cooperative and provided video to the officers of the incident.

This report is being written by PO Austin SHULL, assigned to District 7, Early Shift, Squad 7260.

On Saturday August 14, 2021 at 11:30 p.m. (while in full duty uniform equipped with an Axon body worn camera activated and in a unmarked squad car), I was dispatched to 4246 W Burleigh St to meet Squad 7214 (SGT. Juan LOPEZ), regarding a ShotSpotter activation (Flex 81-691730).

Prior to arrival, the correct location was 3114 N Sherman Blvd (Citgo Gas Station). Upon arrival, I met with SGT. LOPEZ who stated he was observing camera footage which captured a physical altercation take place prior to police arrival outside of the business. The camera being viewed was the southwest camera pointing towards the gas pumps. The physical altercation led to shots fired which activated the ShotSpotter.

I took notes of the following time stamps:

22:44 - 2 subjects enter the gas station. Subject 1 is a black male, 6"02, slim build, 150 pounds, braided hair, wearing gray sweatpants, black shoes, and a blue checkerboard shirt and subject 2 who is described as a black male wearing multi color clothing. Prior to entering the gas station, subject t2 appeared to have said words to subject 1, which prompted subject 1 to follow subject 2.

at 22:44 - both subject began to physically fight in the gas station parking lot. During the fight, an all black firearm was see thrown from subject one near the exit on the east side of the business. Shortly after the firearm was thrown, I observed a female wearing all pink pick up the firearm and "tuck" the firearm in her left armpit area.

At 22:47 - subject 1 is seen forcibly grabbing the firearm from the female and is seen pointing the firearm at subject 2 firing one shot.

It should be noted I could not view the rest of the video surveillance due to technical difficulties with the video system. SGT. LOPEZ did inform me that no casings were located on scene and no one who was seen on video surveillance was on scene. No calls for service was also made regarding this incident. The female subject who was observed on surveillance is employed at the business and is identified as Gurji SINGH (W/F 03-31-1961) and is the wife of the owner identified as Pakhar SINGH (W/M 3-10-1952). It should be noted the owner was not very cooperative with me and did not want to provide his wife's information at first. The owner stated he gave me enough information.

This report is submitted by Milwaukee Police Officer Jesse BENITEZ Jr., assigned to District 7, Day Shift.

On Monday August 30th, 2021, at 10:06 AM I was assigned to Squad7150 (PO Kevin GAULKE and I) responded to a violation of restraining order complaint at the Citgo Gas Station located at 3114 N Sherman Blvd. The victim and owner of the property, Pakhar SINGH (Asian / Male 3/10/52) stated that a known suspect was on the property and on video. The suspect was identified as Jo D. SHANNON (male / black 7/17/62). SINGH is the owner of the property and has a valid and served restraining order against the suspect, Milwaukee County Case#2021CV004056.

I spoke with the employee at the register who was identified as Mandip SINGH (Asian / Male 4/8/99). Mandip observed the suspect come inside the store at approximately 9:30 AM and attempt to buy several grocery items but was denied. Mandip stated the suspect went over to the ATM machine and then outside pressing on the buttons of the gas pump. The suspect then took a garbage can and moved it across the parking lot towards the entrance. Mandip stated that this incident was captured on video however he could not get a copy of the video at this time. Mandip was provided my information and stated he would be able to send a copy of the surveillance video by email.

Squad 7150 went to SHANNON's listed address, 2938 N 40th Street to locate him. We were unable to locate him or anyone at the location. It should be noted that SHANNON frequently comes to this location despite the restraining order from the owner of the property. The most recent reported incident was from 8/21/21, MPD case#212330144. This case is currently pending and will be reviewed at the District Attorney's office.

This report is submitted by Milwaukee Police Officer Jesse BENITEZ Jr., assigned to District 7, Day Shift.

On Tuesday September 6th, 2021, I was assigned to Squad 7150 (PO Samphanh LUANGPHAXAYACHACK and I). At 8:33 AM, Squad 7150 responded to a theft from person complaint at 42nd Burleigh. I met the victim identified as Jasmine S. RAMOS (female / black 9/18/93) who stated that this occurred at 3114 N Sherman BI at the Citgo Gas Station.

RAMOS stated that she was at the gas station and checking out at the front counter. RAMOS stated that as she was paying, the suspect came from behind her and removed \$50.00 from inside her purse. RAMOS stated that there was no struggle or threats made by the suspect. RAMOS stated that the suspect removed the money and fled the store on foot. RAMOS chased the suspect who was last seen going north on 41st Street from Burleigh and then east in the alley. RAMOS stated that the money was five \$10.00 bills

I went to the gas station to review any video which may have captured this incident. I was able to review video of this incident which captured the suspect behind the victim at the counter. The suspect reaches into the victim's purse and immediately flees on foot from the store towards Burleigh. The events described by the victim is consistent with the video. The video was recorded on body camera by PO LUANGPHAXAYACHACK. The employee who assisted us reviewing video was Arshdeep SINGH (Asian / Male 11/10/02).

The hearing before the Licenses Committee will take place virtually on 10/19/2021 at 10:55 AM. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at http://city.milwaukee.gov/citychannel. Those wishing to provide oral testimony will be asked to do so by phone or internet and are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
