There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-2.7-4, probative evidence concerning whether or not a new license should be granted may be presented on the following subjects: whether or not the applicant meets the municipal requirements, the appropriateness of the location and premises where the licensed premises is to be located and whether use of the premises for the purposes or activities permitted by the license would tend to facilitate a public or private nuisance or create undesirable neighborhood problems such as disorderly patrons, unreasonably loud noise, litter, and excessive traffic and parking congestion. Probative evidence relating to these matters may be taken from the plan of operation submitted with the license application, if any, but shall not include the content of any music. Evidence regarding the fitness of the location of the premises to be maintained as the principal place of business, including but not limited to whether there is an overconcentration of businesses of the type for which the license is sought; whether the proposal is consistent with any pertinent neighborhood business or development plans, or the location's proximity to areas where children are typically present. The applicant's record in operating similarly licensed premises; and whether or not the applicant has been charged with or convicted of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the activity to be permitted by the license being applied for or any other factor which reasonably relates to the public health, safety or welfare may also be considered. See attached police report or correspondence.

### Notice for applicants with warrants or unpaid fines:

Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.

Failure to attend this meeting may result in the denial of your license. Individual applicants and partnership applicants must attend or attend by an attorney. The agent or attorney for corporate or limited liability applicants must attend. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition attend the virtual hearing and are willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 02/04/2016 a representative from Fire On Water (518 North Water Street) attended a training course regarding the use and identification of fake ID's conducted by Milwaukee Police Officers given at The Winchester (2321 North Murray Avenue).

2. On 05/30/18 at 1:00am, Milwaukee Police were dispatched to 518 N Water Street (Fire on Water) for a noise complaint. Upon arrival officers interviewed the agent who stated that the live band was done for the evening. When told that officers were sent there for a noise complaint, the agent said that he has no plans to stop having loud bands play with open windows and doors at the front of the tavern facing the street. When the noise ordinance was explained to him and that he could be cited, he stated that he understood and he would be seeing "us", the police, a lot this summer. The agent told the officers that his tavern has been at that location for 10 years and the hotel has just opened, so he's not going to change anything.

#### ADDITIONAL COMMENTS/RECOMMENDATIONS:

This report is being submitted by Officer Carlos Felix assigned to District One. The CPTED of the property was conducted on August 30th at 2:00PM. The property is a four floor brick building attached to several other buildings with mix use occupancy. The space was occupied with a business known as Fire on Water, which closed approximately a year ago and is vacant at the time of inspection. The agent stated that her contractor plans on installing a total of 12

cameras throughout the interior and exterior of the business, but she is unsure of the placement of the equipment. There will be live music at the location and performers will setup on a short stage area near the front entrance off of N. Water Street. If there is no live performance the stage will be used as a preferred seating area furnished with couches. The Floor plans will stay the same and tables will be added to the first floor for dining. On the second floor there is a second bar area which will be utilized along with additional seating. A lower basement may be outfitted and used as a coat check area. There is space accessed within the kitchen which will be used as dry locked storage and a wall will be added to divide the room for office space. I advised that a camera should monitor inside or outside of the office and to utilize a secure safe.

The agent stated the age requirement will be 25 years and up, I advised that she can adjust the age restriction up from what is on the application but cannot go below the age restriction. She stated, she will call the City to make sure the application is 21 years and above but will restrict the age limit at the door. There are plans to have event nights for people under 25 years old.




### City Concentration Map - 518 N Water St




