On 10/07/20 at 8:15pm, officers were dispatched to a Trouble with Subject at Taco Bell, 6268 S. 27th St. Officers interviewed the caller who stated she placed an order through the drive thru, drove off, then realized she was missing part of her order. The caller stated when she returned the door was locked to gain entry so she had to wait in a long line to get the problem rectified. The caller further stated by the time she reached the drive thru window, she wanted a refund for all her food because it was now cold. Officers interviewed the manager who stated they lock the lobby early due to COVID. The manager stated the caller was extremely irate and yelling, however, refunded her for the portion of food she was missing. The caller left without further incident.
- 5. On 03/01/21 at 1:50am, officers were dispatched to Taco Bell, 6268 S. 27th St., for an Injured/Sick Person. Officers interviewed the caller who stated a subject was passed out at the drive thru window with the money for the food in hand. The caller stated MFD had been on scene and allowed the subject to walk home, since they lived around the corner. On officers arrival the vehicle had already been moved.
- 6. On 03/03/21 at 10:50am, officers were dispatched to Taco Bell, 6268 S. 27th St., for a Trouble with Subject. Officers interviewed the manager who stated he was having trouble with an employee over a disciplinary issue. The employee was asked to leave by the officers and complied.
- 7. On 03/04/21 at 9:08am, officers were dispatched to Taco Bell, 6268 S. 27th St., for a Trouble with Subject. Officers were advised by an employee that a physical fight took place between the manager and an employee who had previously been fired. Officers observed both subjects on the ground with visible scratches and torn clothing. The employee was advised to leave the premises and the manager was advised to contact Human Resources in the future with personnel matters.

This report is written by Sergeant Latanya DIEDRICH, assigned to District 6, Early Shift.

On Wednesday, October 7th 2020, at 8:15pm, while assigned to Squad 6211, I, Sgt. DIEDRICH was dispatched to a Trouble with Subject complaint at 6268 S. 27th St, Taco Bell, located in the City and County of Milwaukee.

Upon arrival, I spoke with the caller, RAMIREZ-YARBROUGH, Margie (w/f 6-14-80 6160 S. 6th St, 312-409-3398) who stated she went through drive-thru at Taco Bell and ordered approximately \$27 worth of food. She stated she drove away, and after she got around the block she realized she was missing some food. She stated she returned, and pulled into the parking stall in front of the doors of the business. RAMIREZ-YARBROUGH stated she knocked on the door to get their attention and someone inside yelled for her to go back through the drive-thru. She said there was a long line of cars so she waited at door and just wanted someone to come there, to help her but they again told her to drive around. RAMIREZ-YARBROUGH stated she then waited in the line, and finally got to the window and wanted a refund of all her food because now it was cold but the employee refused her refund, so she contacted police.

I then spoke with the manager, ZAVALA, Ismael R who stated RAMIREZ-YARBROUGH arrived at the window and was yelling at him about her food, asking for a refund but he was unable to figure out what she wanted because she was being very hostile. As I was interviewing him, he still was not sure what food she was missing. He stated the lobby was closed early due to covid-19, and their policy is once the door is locked, they can not unlock the door for anyone. He stated that is why no one addressed her at

the door. He stated they only had 3 employees working at the time, and a long line of cars they were not able to go outside to talk to her, so she was told to pull back around through the drive-thru.

I spoke with another employee, ROMANS, Leticia who stated she observed RAMIREZ-YARBROUGH outside and yelling about her food. She stated she was at the register and was pointing for RAMIREZ-YARBROUGH to go around. She stated RAMIREZ-YARBROUGH was standing outside, jumping up and down, yelling.

ZAVALA refunded RAMIREZ-YARBROUGH \$5 for the Stacker Box that she was missing and she left without incident.

I was in full MPD uniform and was equipped with an Axon body worn video camera at all times relevant to this investigation (see related LPR from 03-03-21).

On 03/04/21 at 0908 I was dispatched to a fight at Taco Bell 6268 S 27th ST. Sgt Gregory FLORES, PO Mark HAASE and PO Brian BISCOBING responded as well.

Upon arrival I spoke to an employee (Sylvia VAZQUEZ). She stated Mario (OJEDA) came to work this morning at 0900. The GM(HERNANDEZ) told him he was fired and to leave. She stated immediately they began to fist fight. She did not see who started it, but it appeared it was a mutual fight. She stated it was loud and she was frightened. She called police.

I walked into the kitchen and observed HERNANDEZ on top of OJEDA. Both men had visible scratches and torn clothing. Please review body camera video for statements from HERNANDEZ and OJEDA, if desired.

INVESTIGATION REVEALED IT WAS A MUTUAL FIGHT AND NEITHER WANTED CITATIONS ISSUED.

I reminded HERNANDEZ of HR assisting in personnel matters. He requested I inform OJEDA not to return to the business.

OJEDA agreed to the request.

Those wishing to view the proceeding are able to do so via the City Channel — Channel 25 on Spectrum Cable — or on the Internet at http://city.milwaukee.gov/citychannel. Those wishing to provide oral testimony will be asked to do so by phone or internet and are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
