Corrine Miller
North 24th Place from West Concordia Avenue to West Hopkins Street

Dear Honorable Members:

This letter is in reply to an application dated August 23, 2021 regarding a request for an honorary street name of Corrine Miller on North 24th Place from West Concordia Avenue to West Hopkins Street.

Chapter 113-3 of the Milwaukee Code of Ordinances provides the guidelines to consider when reviewing honorary street name requests. The guidelines provided in the code have been reviewed and the following comments are offered:

Mother Corrine Miller gave 70 years of service to better the lives of people in her community. She was active in the Golden Rule Church Of God In Christ and was a shining example of altruism, as she lent her hands and resources to the community.

Mother Corrine Miller made herself available to any community member and was able to donate food, clothing, money, furniture, holiday gifts, and so much more to those in need. Miller consistently shared her blessings to build up the community where she proudly built her life. Her efforts gave families something to believe in and provided hope for better days ahead.

The request to honor Mother Corrine Miller posthumously with an honorary street name of "Corrine Miller" includes 14 letters and spaces. The letter size of the honorary street name will be sized to fit the standard honorary street sign space.

Two (2) blue honorary street signs will be needed; one will be mounted at West Concordia Avenue and the second at West Hopkins Street on the North 24th Place signs. Please refer to the attached map showing where the honorary street name signs will be located. The petitioner may choose to furnish the honorary street signs but they must be fabricated to established City standards. The City can fabricate the signs at \$50 each. In either case, the City will install the honorary street signs at a cost of \$50 per sign. The petitioner is to deposit \$100 to the City if they furnish the two signs or \$200 if the City fabricates and installs the signs. If a sign needs to be replaced in the future, the City is to be notified of the missing or damaged sign and the petitioner is to cover the cost to fabricate and mount the sign as described above. The City's cost to fabricate and install future signs is subject to change.

North 24th Place will remain the official street name so addresses will not change.

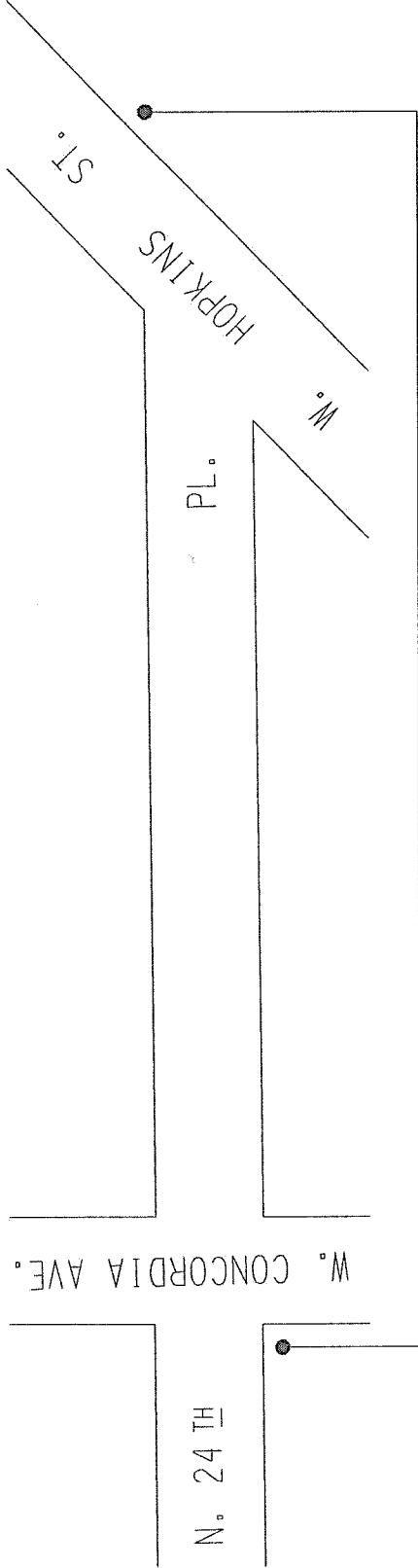
