

The Community Within the Corridor involves the renovation of several existing buildings on North 33rd Street between Center Street and Hadley Avenue. The buildings will be converted into 64 Corridor Lofts, 36 Crème City Lofts, six 30 Square Townhomes and 91 Briggs Apartment Homes. The development will include a Community Service Facility with early childhood education, Science, Technology, Engineering, Art and Math after-school programming, a health club, laundromat, and a petite grocery store



Through September 30, 2021, this project has achieved 21.3% Professional Services inclusion.




