Thank you for your application. We do not permit chain link fences and we strongly discourage front yard fences. It is generally best to have the fence no farther forward than the front wall of the house on the grand boulevards like Sherman. See the attachment.

Masonry work, such as the porch repairs can be eligible for a 25% tax credit, if you spend at least \$10,000 over 5 years on work directly affecting the house. Fencing is considered landscaping and is not eligible for the tax credit.
