RE: REQUEST TO RE-EXEMPT POLICE SERVICES SPECIALIST-INVESTIGATOR POSITION

Dear Commissioners:

The Department received the Finance and Personnel Committee's approval to fill eleven (11) vacant Police Services Specialist-Investigator positions at its meeting of October 6, 2021. Pursuant to Fire and Police Commission Rule XI, Section 12, I am requesting that the Board re-exempt these positions.

The Police Services Specialist-Investigators are civilian positions that relieve full-duty law enforcement officers engaged in indirect law enforcement activities, at locations throughout the department, by performing the duties associated with such activities. Police Services Specialist-Investigators conduct background investigations for police, fire and civilian applicants, conduct follow-up investigations to include forgery/white collar crime, city license investigations, cold criminal cases, pawnshop investigations, and confiscated property. In addition, this position assists with record requests and litigations; to include responding to requests for information, assists with the research, compilation and dissemination of Police Department records as mandated by Wisconsin State Statutes pursuant to the Open Records Law, applicable Federal and State Supreme Court decisions and Milwaukee Police Department Policy.
