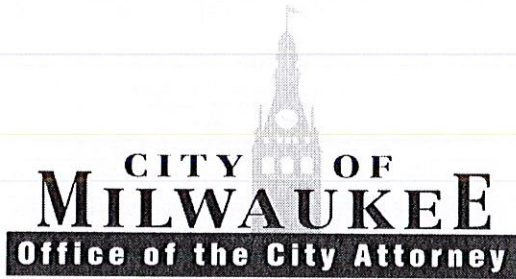


Enclosed please find a proposed resolution. We ask that it be introduced and referred to the Committee on Judiciary & Legislation, with the following recommendation.


Jeep Transport alleges that on September 25, 2020, their truck was damaged when it collided with a tree branch at North Teutonia and West Kiehnau Avenues. Claimed damages total \$5,649.11.

The Infrastructure Services Division indicates that on September 25, 2020 Street Maintenance was performing joint repair on North Teutonia Avenue and did have traffic diverted to the parking lane. Prior to doing this, they did not contact Forestry to have trees cleared to a minimum clearance.

Because settlement of this matter is deemed expeditious to the City of Milwaukee, we recommend settlement of this claim in the amount of \$5,649.11 and have enclosed an appropriate resolution for your convenience.
