2. On 4-18-2005 at 2:11am, Milwaukee police were sent to a fight at 2106 W National Ave. Upon investigation, it was learned that a fight started between 3 patrons of the El Jalapeno tavern. Two were treated at Froedtert Hospital for stab wounds. One received 35 stitches to his stomach and left side of his face and one other received 4 stitches to his left side of his face and required surgery for a large laceration to his stomach.

Investigation revealed a male entered the business with the lower portion of his face concealed pointing a gun demanding money from the clerk. The clerk failed to comply and the suspect became angry and whiling fleeing the premise, kicked out the plexiglass window of the front door. Nothing was obtained and no injuries were reported.

- 8. On 12/03/11 at 3:11 am, Milwaukee police investigated a Battery complaint that occurred at 2106 W National Avenue. Police spoke to the victim who stated that a known subject punched him in the face while he was inside the El Jalapeno Restaurant. The suspect was still on scene and was issued a citation and later observed by officers leaving in a truck with friends. Around 4:05 am, a shooting occurred in front of the restaurant with the victim of the earlier battery being the suspect and victim of the shooting being the suspect from the earlier battery.
- 9. On 04/08/12 at 3:08 am, Milwaukee police responded to a Fight complaint at 2106 W National Avenue. Investigation revealed that a fight started inside the restaurant with two males fighting and as the fight intensified, more patrons became involved. Officers spoke with Whesley Rios, who works as a security guard for the restaurant and obtained his statement regarding the incident. Police also spoke with the manager Everardo Gutierrez-Garnica regarding the incident. He stated his brother Angel Gutierrez-Garnica was out of the country for a family medical emergency and was unable to be contacted. Police observed security cameras mounted in the restaurant, but when officers asked to view the video of the fight, were told by Everardo that he didn't have a key to locked video room located in the basement. Police issued several citations to patrons involved in the fight.

19. The applicant is on probation for Item # 18. Email notification to the Wisconsin Department of Corrections on 05/29/2019 requesting they provide information to the License Division regarding the probation/parole status and the end date of the status.

20. On 03/17/2019 officers were dispatched to a Trouble with Subject complaint at El Jalapeno, 2106 W. National Av. The applicant was the caller and he stated he has security on Friday and Saturday night due to the high amount of customers. The officers broke up several fights and issued a citation for a battery that occurred.

- 21. On 11/18/2019 officers were dispatched to a Fight at 2106 W. National Av. The caller stated it appeared other patrons wanted to fight him. The applicant stated several males began to argue and he asked them to leave the business. The subjects left and the applicant had no further information.
- 22. On 03/01/2020 officers investigated a Shooting at 1500 W. Scott St. The investigation revealed the shooting may have been related to a Trouble with Subject that occurred earlier in the night at Tagueria El Jalapeno, 2106 W. National Av. The officers spoke with the applicant, who stated at about 3:20am there were two groups arguing in the restaurant. He had his security escort one group out and kept the other group inside for 15-20 minutes. After that time the second group left in two separate cars. The applicant provided video of what happened inside the restaurant.

- 23. On 12/11/20 at 2:42am, officers were dispatched to a Shooting complaint at El Jalapeno, 2106 W. National. Officers were met by the agent and advised an argument broke out inside the restaurant that escalated into a physical fight outside. Officers were advised that he eventually heard multiple shots fired outside. Officers located a victim with a gunshot wound to the leg. Officers located multiple casings in the area and observed video surveillance of the incident. The agent was cooperative with the investigation.
- 24. On 01/15/21 at 1:00pm, officers conducted a meeting with the agent regarding several latenight incidents that occurred at El Jalapeno, 2106 W. National Av. The agent was advised of the necessity to develop a safety plan for Covid-19 with the Health Department. Officers further advised that despite security personnel, there are still ongoing issues, therefore, a

reevaluation of the security plan may be needed. The agent was encouraged to call police when incidents arise.

25. On 08/20/21 at 3:10am, officers were dispatched to a subject with a gun at El Jalapeno, 2106 W. National Av. Officers spoke to the waitress who stated patrons were arguing with one another and it began to escalate. The caller stated she asked the patrons to leave; one cooperated and there was no further incident. The employee was cooperative with the investigation.

This report was written by P.O. Kendall Corder assigned to District Two Late shift squad 2328.

On Friday December 11, 2020 at 2:42 am my partner P.O. TOMASZEWSKI and I (While in full uniform operating a marked squad equipped with axon body cameras) responded to **2106 W National Ave** (Which is located in the City and County of Milwaukee for a Shooting Complaint.

Upon arrival officers spoke with the owner of El Jalapeno identified as Angel Guiterrez (W/M, 6/28/71), who stated there was a verbal argument inside of El Jalapeno that escalated into a fight outside of El Jalapeno GUITERREZ stated he observed multiple people fighting outside of El Jalapeno and moments later after the physical altercation GUTIERREZ stated he heard multiple gunshots outside of El Jalapeno. While investigating on scene Officers discovered the victim identified as Sandro A Moreno W/M (12/16/02) was shot one time in the left leg. MORENO was located at 2949 S 9th St in the alley. While on scene officers located 8 9mm spent casings all casings were recovered and inventoried by P.O./IBIS TECH Robert Lemanczyk Jr. (Inv#20046243).

A Video Surveillance Canvass was conducted by Squad P.O. BONGEL who recovored video at 2110 W National Ave and 2138 W National Ave. All video was given to Det. Elgerrith Tucker for review.

While on scene GUTIERRERZ was very cooperative with police and did not obstruct officers investigation.

This report is written by PO Matthew DIENER, assigned to District 2, day shift, squad 2166. On Friday, January 15, 2021 at approximately 1:00pm we conducted a licensee call-in with the owner of El Jalapeno, located at 2106 W National Av. The call-in was conducted at District 2, 245 W Lincoln Av. In attendance was the licensee, Mr. GUTIERREZ-GARNCIA, Captain SALAZAR, PO CONTRERAS, ACA Heather Hough, and via phone Alderwoman ZAMARRIPA. The meeting was held regarding several late night incidents at occurred at the premise, including fights, shots fired, and a shooting that occurred on 12/9/20. Mr. GUTIERREZ stated that the premise is open until 4:30am, and they do have security that works on the weekends. We discussed Covid-19 capacity regulations and the requirement of a safety plan for the health department to alter capacity restrictions. We also mentioned that even with security, there are still ongoing issues, and that his security plan might need some readjusting and/or reevaluation. We advised that any further violent crimes like shootings, batteries, fights, stabbings, could put his business into 80-10 nuisance status, and that he shouldn't be discouraged from calling police for assistance. He was further advised that we encourage license premises to call police when and if incidents occur, and generating PA-33 "tavern reports" are not inherently negative.

On Friday, August 20th, 2021 Squad 2321 (PO Omar PEDROZA-BELTRAN) and myself were dispatched to the location of 2106 W National Ave, in the City and County of Milwaukee.

Officers responded to a subject with gun at this location. Upon arrival, I spoke with the waitress at the location who was later identified as Olga FLORES (w/f 6/26/75) who stated that there was an argument that took place between two parties at the restaurant. FLORES told the subjects to leave the establishment because they were beginning to get loud with one another. One of the parties did so and no further incident took place inside the business. My interview with FLORES was all conducted in Spanish and FLORES was completely cooperative with Officers.

I then spoke to the owner of the business who was later identified as Angel GUTIERREZ-GARNICA (w/m 6/28/1971) who stated that their were subject fighting with each other near the rear of the business but it started inside the business. GUTIERREZ-GARNICA stated that his employees were able to stop the fight from getting physical by kicking one of the parties out. GUTIERREZ-GARNICA was completely cooperative with Officers.
