Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. 2. On 04/29/2017 at 2:33am officers conducted a licensed premise check on TJ's Lounge, 2911 W. North Ave. The officers heard loud music and entered the tavern. they observed 20 patrons sitting at the bar with some continuing to consume alcohol. The applicant was the bartender. She was cited for Class B Premises Allow Patron after Hours.

3. On 05/06/2017 at 2:30am officers observed a large group of cars parked in front of TJ's Lounge, 2911 W. North Av. At 2:40am the officers conducted a tavern check. The officers heard loud music coming from inside. The security guard unlocked the door and told everyone they had to leave. The officers counted 40 patrons leaving the bar. The manager was Kevine BARNETT and he did not understand why officers made contact with the tavern. The applicant was cited for Class B Premises Allow Patron after Hours.

4. On 06/24/2017 officers were dispatched to TJ's Lounge, 2911 W. North Av, for a fight. Upon arrival the officers were advised by security that one subject left and the other was in the parking lot. The officers observed the intoxicated subject in the parking lot refusing to leave. He was detained when he attempted to strike one of his friends.

5. On 01/01/2018 officers were dispatched to an Entry complaint at 2911 W. North Av. The officer was met by a security company that had an open front door. The officer searched the building and found nothing out of the ordinary. The investigation determined the employee had

left the door unlocked when they left for the day.

6. On 05/28/2018 officers were dispatched to a Shotspotter call at 2929 W. North Av. The officers went to 2911 W. North Av to check for witnesses. They spoke with the manager, Kevin BARNETT, who stated he did not hear any shots and would be closing the bar for the night.

8. On 06/21/2019 at 1:35am officers were dispatched to T-Jay's Lounge, 2911 W. North Av, for a tavern violation. The caller stated his 15-year-old sister was in the bar and there were subjects smoking marijuana. The officers checked the ID's of the patrons and did not find anyone underage. No violations observed.

9. On 06/28/2019 officers were dispatched to T-Jay's Lounge, 2911 W. North Av, for a property damage complaint. The officer interviewed the victim who stated she was inside T-Jay's from 1:30am to 1:50am. When she came out her car door window was broken and items missing. The victim was found to be 20-years-old. The officer interviewed the manager and the door man who stated they did not let anyone underage in the bar. The applicant was issued a citation for Allow Underage on Premise.

- 10. On 07/01/2019 at 1:09am officers were dispatched to a subject with gun in the area of T-Jay's, 2911 W. North Av. The officer spoke with the caller by phone, who stated a security guard had brandished a firearm. The caller was uncooperative and hung up on the officer. The officer went to T-Jay's and spoke with the manager, Kevine BARNETT. He stated nothing out of the ordinary happened that night. The staff was very cooperative with the officers.
- 11. On 08/25/2019 at 2:20am officers were dispatched to N. 29th St and W. North Av for a shotspotter call of over 30 rounds fired. The officer interviewed the manager of T-Jay's, 2911 W. North Av. He stated they had no problems that night and were closing at 2:15am when they heard shots fired from a vehicle on the street. He provided video which showed a vehicle exit the parking lot to the west of T-Jay's and pull up to another vehicle on the street. One vehicle fired at another and both fled. One of the vehicles fleeing struck a parked car, flipping it on its side.
- 12. On 09/03/2019 at 1:08am officers were dispatched to T-Jay's lounge for a wanted subject. The subject was located and arrested without incident.
- 13. On 09/08/2019 at 1:17am officers conducted a licensed premise check at T-Jay's Lounge, 2911 W. North Av. The officer observed more than 80 cars in the area and conducted a capacity check. The door man stated he thought capacity was 136 and they had about 120-130 patrons. The officer checked and found capacity was 80 people. The bar was closed and all subjects were counted as they exited and the officer counted 213 people, which included employees. The investigation also revealed the bar was charging a cover charge, which wasn't posted and was serving food without a license. The manager stated they did not need a food dealer license because they were giving the food away. The applicant was cited for the violations.
- 14. On 09/22/2019 at 1:18am officers were dispatched to T-Jay's Lounge for a tavern violation. The caller stated there were several underage people inside the bar. The door man stated he knew the officers would be coming because he had turned away female with no ID. The officers checked the bar and did not locate anyone underage.
- 15. On 10/04/2019 a meeting was held at District 3 regarding T Jay's Lounge. The applicant stated she is not involved in the daily business, her husband Kevine BARNETT, runs the business. She stated she was unaware of several of the incidents at the business. She was advised of the recent incident on 09/08/2019 and the possible citations. She was advised to use a counter, post signs with prices and monitor patrons at close. She stated she would advise BARNETT of the information provided.

16. On 11/03/2019 at 1:55am officers were observing closing time at 2911 W. North Av. The officer observed a commotion out front which was blocking traffic. The officer cleared the crowd and spoke with a female, who stated she was trying to get back in the bar to get her friends shoes. She stated a security guard grabbed her by the head and pushed her out. The

officer spoke with the bartender, who stated the subject described by the female was not an employee. The officer attempted to locate the subject on several different dates but could not locate an employee matching the description.

17. On 11/23/2019 at 12:55am officers observed 65-70 cars parked outside of 2911 W. North Av. Knowing the capacity was 80 patrons the officer called for a supervisor and additional cars to conduct a capacity check. The officer spoke with the bartender, Kevin BARNETT, and asked him how many people were inside the tavern. The bartender stated 89 people and he knew it was over capacity. The bar was shut down and the patrons were counted as they exited. The officer counted a total of 118 people inside the bar. BARNETT stated he was counting patrons as they entered and showed the officer a handheld counter, which had 91 displayed. BARNETT stated his duties as the bartender pulled him away from the door so he may have missed patrons. BARNETT was advised to have a separate employee doing the count and to post the actual cover charge.

- 18, On 03/14/2020 at 2:00am officers conducted a license premise check at TJ's Lounge, 2911 W. North Av. The officers did not observe any loitering outside and observed staff keeping vehicles from stopping in front of the tavern. The officers observed closing and found it to be orderly.
- 19. On 08/02/2020 at 2:24am officers were dispatched to a Battery at N. 29th St and W. North Av. The officer observed a large group outside the business. They were directed to a female on the ground by a vehicle in the parking lot. The victim could not answer questions due to her intoxication level. The witnesses stated a male subject hit the victim with a 2x4 causing a cut to her head. The officers spoke with the manager, Kevin BARNETT, who stated the suspect has been banned because of this and other violations in the past. BARNETT stated cameras did not cover the incident. The officers questioned BARNETT about occupancy because of the large number of cars in the area. The officers reminded BARNETT that his capacity is 50% of normal because of the ongoing pandemic.

21. On 10/31/20 at 1:40am, Milwaukee Police were dispatched to a Shotspotter complaint which indicated five rounds were fired in the parking lot west of 2911 W. North Avenue. The were two additional Shotspotter alerts which indicated eight rounds (4 rounds per alert) were fired in the parking lot at 2829 W. North Avenue. Officers interviewed the bartender of the tavern and she said that she did not hear or know anything regarding the incident. The manager was interviewed and he told officers that there was a power outage which shut down the cameras which would have captured the incident. Both employees were cooperative.

- 22. On 11/29/20 at 1:50am, Milwaukee Police were dispatched to 2911 W. North Avenue for an overdose complaint. Investigation revealed that the subject was in the establishment with some friends when he passed out. The subject was carried outside the tavern and 911 was called. MFD administered Narcan and the subject was conveyed to the hospital.
- 23. On 01/03/21 at 1:53pm, Milwaukee Police were dispatched to 5000 W. Chambers for a sexual assault complaint. Investigation revealed that the victim was at 2911 W. North Avenue drinking and does not remember what happen during the night. The victim woke up the next morning and had injuries from an unknown source, so she went to the hospital.
- 24. On 02/12/21 at 1:35am, Milwaukee Police were dispatched to 2911 W. North Avenue for a subject with gun complaint. Investigation revealed that the caller was upset because he was denied entry into the club and security did not have a firearm with him during the encounter with police.
- 25. On 03/07/21 at 12:47am, Milwaukee Police, along with the city's health department, conducted a license premise check at 2911 W. North Avenue. Officers observed inside the tavern patrons standing shoulder to shoulder, wall to wall, and dancing. Minimal patrons were wearing masks and the tavern was over capacity. The health inspectors spoke with the manager, who was cooperative, and told him they would be issuing four citations. (no citations found at the time of this report)
- 26. On 03/19/21 at 12:16am, Milwaukee Police were dispatched to 2911 W. North Avenue for a tavern violation (underage presence). Officer arrived on scene, told the manager why they were there, and performed a walk through of the establishment. Officers did not see any evidence of underage patrons and the manager said that he denied a group of females earlier in the evening which might have triggered the call for service.
- 27. On 04/18/21 at 1:54am, Milwaukee Police were flagged down for an entry to auto at 2911 W. North Avenue. After taking the entry to auto report, it appeared to officers that the tavern was over capacity and there were vehicles leaving the area recklessly and at a high rate of speed. Additional police squads responded to the location to monitor the crowd and deter criminal behavior.
- 28. On 05/13/21 at 5:05pm, Milwaukee Police, along with a Department of Revenue Agent, DNS Inspector, and an ADA, performed a license premise check at 2911 W. North Avenue. The Agent confiscated 27 boxes of various liquor because the manager could not provide purchase orders or were contaminated. 1 box of tobacco was also confiscated because the applicant does not have a tobacco license. The manager admitted to buying liquor from a store other than a distributer. The applicant was issued a citation for building code violations.

Investigation revealed that three people were shot inside the tavern and all were receiving treatment at local hospitals. Video surveillance showed the shooting occurred inside the establishment and shows the employee's cleaning up and throwing away evidence before police arrival. The bar manager repeatedly lied to police about the incident and was subsequently arrested.

This report was written by P.O. Ryan DOMBECK, assigned to District Three, Late Power shift.

On Saturday, October 31st, 2020, at 1:14 AM squads were dispatched to a Shotspotter alert at 2917 W. North. Shotspotter indicated five rounds in the parking lot west of TJay's Lounge (2911 W. North Ave).

There were two additional Shotspotter alerts (CAD#203120230, and CAD#203120234) which indicated four rounds in the lot at 2829 W. North Ave and four rounds in the parking lot at 2829 W. North Ave.

Upon arrival officers observed several people running from TJay's Lounge and the TJay's Lounge Parking lot. Another caller stated that she heard an argument followed by gunshots.

Officers located 2 casings in the parking lot of TJay's Lounge.

I spoke with Taina COLLINS who stated she was working behind the bar. COLLINS stated that she did not hear any gunshots or know anything regarding the incident.

P.O. ZUBE conducted follow up at a later date and spoke with Kevin BARNETT, who stated he was the bar manager. BARNETT stated he was aware of the incident but a power outage shut down the bar's camera system. BARNETT stated that AT&T advised BARNETT that the cameras should have recorded the incident but BARNETT would not be able to view any footage until AT&T could fix the system on Wednesday, November 11th, 2020.

Both BARNETT and COLLINS were cooperative.

(T Jay's Lounge) for an overdose call for service. Upon arrival I observed MFD already on scene tending to an individual who was down outside the bar. I was advised by P.O. BRUMAGE that the individual was identified as Logan T. CLEARY (w/m, 5-4-98).

I made contact with the bar who stated CLEARY was inside the bar with a couple friends when he then passed out. CLEARY was then carried outside and 911 was called. I made contact with Kevin J. BARNETT (b/m, 5-26-83) who is the manager and advised him it was time to shut down the bar for the night. BARNETT had the DJ shut the music off and patrons started to calmly and cooperatively exit the bar. BARNETT advised me the camera system is still down at the bar.

CLEARY was tended to by MFD and Narcan was administered. CLEARY was transported to St. Mary's Hospital for further treatment.

On Sunday, January 3rd, 2021, at approximately 1:53 PM, while on patrol, squad 3235, PO Will VANLAANEN, and I were dispatched to 5000 W Chambers St, located in the City and County of Milwaukee, WI, to investigate a sexual assault.

Upon arrival, we located the caller/victim Latasha A HOLMON (B/F 11-09-82). HOLMON stated on 1-02-21 between 10-11 PM she went to T-Jay's lounge at 2911 W North Ave located in the City and County of Milwaukee, WI, with her boyfriend Mitch. HOLMON stated she met up with her friends "Mya" and "Maliquia" at the location.

HOLMON stated that she purchased alcohol while she was at the bar and was drinking from an open cup. HOLMON stated that she was intoxicated and does not remember what happened during the night. HOLMON stated she woke up in her home with her boyfriend. HOLMON stated she had injuries from an unknown source and went to the hospital.

Sensitive crimes was informed of the incident and arrived on scene to handle the investigation.

Upon arrival at the location the health inspectors Mike STARKS and Tim STEIN made contact with the manager Kevin J BARNETT (b/m, 05/26/1983). BARNETT was cooperative with the tavern check. STARKS, STEIN, ZUBE, and I attempted to walk through the bar. We were unable to walk from the entrance to the back of the bar due to patrons standing shoulder to shoulder, wall to wall, dancing. There was so many people in the establishment that we were unable to conduct an official count. It should be noted that the official capacity limit is 80 persons. The establishment was so over capacity, that while exiting STEIN was lost and could not keep up with us exiting the front entrance.

Minimal patrons were wearing their masks (during covid protocols).

While outside P.O. ZUBE counted approximately 80 cars parked outside surrounding the bar. Previous knowledge of the area around the bar, we know that all of these vehicles were most likely patrons of the establishment. The immediate area around the bar is commercial properties and minimal residential.

On Sunday, April 18th, 2021 at approximately 1:54 AM, Squad 3465 (Myself and PO WARNER) was flagged down at the address of 2911 W North Ave. The listed victim, Sean E KERN (B/M, 03-29-1989) explained that his vehicle had been broken into, and his firearm had been stolen while he was inside "T-JAY'S LOUNGE" and his vehicle was parked outside the location, which is a tavern.

My partner and I were conducting a Tavern Check at the same address, so I broke away and handled this assignment as 3465W.

KERN's vehicle had been parked on the street between N 29th St and N 30th St while KERN was inside the bar. KERN left his vehicle, with his firearm inside, underneath the passenger seat, at approximately 11:45 PM. KERN discovered his vehicle had been broken into at approximately 1:45 PM.

KERN stated that he owns 2 firearms, and the firearm that was taken from his vehicle was a black 9mm Taurus Millennium G2. KERN did not know the serial number, but stated the firearm had been placed on MPD inventory previously. The serial number was found by looking up the previous report — SN# TJZ92234 — Case # 172670043

I did observe that the front passenger window to KERN's vehicle had been shattered, and a crowbar was left behind on the front passenger's seat. KERN also stated that it appeared his car had been rifled through.

KERN left the scene shortly after reporting the incident. No photos were taken because the victim did not remain on scene.

It appeared that T-JAY'S LOUNGE was overcapacity during the incident, and when the crowd left the location (at the time this incident was being reported) many vehicles were leaving the area recklessly and at a high rate of speed. Additional MPD squad's responded to the location to monitor the crowd and deter criminal behavior.

On Thursday May 13, 2021 P.O. HUDSON, P.O. CARLONI, Sgt WASHINGTON and I accompanied special agent GEORGEANN KING (alcohol and tobacco enforcement) on a license premise check of T-JAYS located at 2911 W north ave.

Also present for the inspection was department of neighborhood services inspector, John YANG, and District 3 assistant district attorney Francesco MINEO.

Upon arrival at the location we spoke with the manager Kevin BARNETT (b/m, 05/26/1983).

During KING's inspection 7 bottles of liquor which were identified as contaminated, in the rail or behind the bar. Some of bottles were filled with bugs inside and others had broken pore spouts inside the liquor at the bottom of the bottle. Also during KING's inspection BARNETT could not provide purchase orders for most of their liquor. A total of 27 boxes of various liquor were confiscated by KING. Most of these confiscated boxes had shipping labels cut off by a razor blade in an attempt to hide where the liquor was purchased from. Other boxes had the labels intact which read HAMPTON BEVERAGE II, which is located at 8608 N 107th St and is not a license distributor which is required for a bar to purchase from. BARNETT stated that is where he purchasing most of his liquor from but also uses badger distributing. BARNETT stated that he knew he should not be purchasing liquor from the liquor store. BARNETT was able to provide minimal purchase orders from badger distributing. BARNETT also had to have someone drop the purchase orders off at the bar because they were not kept onsite which is also a violation.

KING also confiscate 1 box of shisha tobacco which is sold and used in their HOOKAH.

VIBE does not have a license to sell tobacco and is not allowed to smoke inside the location.

Upon police arrival, the staff, to include the listed Business Agent (who is also the owner) had cleaned up the bar, to include using bleached water while mopping the floor. The following subjects identified themselves as staff as the location.

Everton L STEWART (B/M, 10-04-2000) / Cook

Darius D BERRY (B/M, 12-30-1994) / Security

When police initially arrived on scene, none of these subjects would provide honest information regarding the shooting incident. After camera footage was turned over, it was determined that these subjects were being untruthful, and subsequently, BARNETT was arrested for misdemeanor obstruction and felony "Harboring/Aiding a Felon-Falsify Info."

My partner and I did not view the footage. The video was viewed on scene by CIB personnel.

On said day, date, and time, we were sent by Milwaukee Police Lieutenant Phillip Simmert to respond to Aurora Sinai Medical Center, located at 945 N 12th St, Milwaukee, WI., 53233, St Joseph's Hospital, located at 5200 W Chambers St, Milwaukee, WI., ,53210 in regards to a shooting complaint originating at 2911 W North Av, in the City and County of Milwaukee. The victims identified as, Eric K BROWN (B/M, 03-06-1992) and Montie L RUSSELL (B/M, 11-17-1989) were both dropped off at Aurora Sinai Medical Center, and BROWN suffered one (1) gunshot wound to the right foot and RUSSELL suffered one (1) gunshot wound above the left knee.

Det. Jung and Det. Driscoll conducted interviews on both RUSSELL and BROWN who both stated they were at the bar T Jay's hanging out and talking to girls when an unknown person started shooting within the bar and shot both victims. RUSSELL and BROWN stated they didn't know who shot them nor did they see anyone shooting inside of the bar. The victim identified as, Demetrie M GRIFFIN (B/M, 03-06-1992) was dropped off at St. Joseph's Hospital, and suffered one (1) gunshot wound to the right calf muscle. Det. Braunreiter conducted an interview of GRIFFIN who also stated he was at T Jay's bar hanging out when an unknown person inside the bar started shooting and that's when he felt he was struck to the leg.

Det. McFadden conducted an interview of the bar owner identified as, Kevin J BARNETT (B/M,05-26-1983) at T Jay's Bar located at 2911 W North Av, which is in the city and County of Milwaukee. BARNETT stated it was around 70 patrons occupying his establishment tonight but a shooting did not occur inside or outside of his bar. BARNETT said he seen a few people running outside on the back patio, but didn't hear any gunshots and everyone outside on the patio all exited out of the front door on the north side of the bar. I then asked BARNETT did he see anyone with any gunshot wounds come past him or leave the bar and BARNETT stated he did not. Let it be noted I also observed BARNETT to be armed with a handgun later identified as a black HK USP COMPACT 9mm semi-automatic handgun located on the right side of his waistband in an appendix holder. I then asked BARNETT were his surveillance cameras in full operation and functional at the bar and have they recorded tonight's events, and he stated yes and allowed me to view the surveillance footage on his iPhone.

I then viewed the video which showed at 12:41am on todays date, on the interior camera, an altercation occurs within the inside of the bar with two black male subjects. I then observed a black male, in his late 20's to early 30's, with a low haircut, full beard, neck and arm tattoos, wearing a light-colored t-shirt, and dark pre-ripped jeans hereinafter

referred to as Suspect #1, produce a black semi-automatic handgun from his waistband after get punched by the second black male, with corn rolls in his hair. I then observe Suspect #1 shoot several times towards the direction of the first black male, while striking BROWN, RUSSELL, and GRIFFIN and all dropped on the floor inside of the bar. I then observe BROWN, RUSSELL, and GRIFFIN all hobbled and limped out of the back door of the bar.

After a few minutes went by on the interior camera I observed BARNETT come in through the front door of the bar and run to the back of the bar. I the observed him talk to several of the workers and immediately they grabbed brooms and started sweeping up everything on the floor in the immediate area of where Suspect #1 was standing and firing shots. The workers are then seen sweeping that area and handing the broom and dustpan off to one another as another returns with a mop and mops up the immediate area of where BROWN and RUSSELL were laying and the area where Suspect #1was firing shots, intentionally removing and destroying any physical evidence of where the crime was committed. Let it be noted the first call to police was received 11 minutes after the incident that a shooting occurred at this bar. When squads arrived BARNETT stated only a fight occurred and nothing else.

I then viewed the video with the same timestamp on the exterior camera which pointed directly over the patio, where I observed BARNETT on the patio talking to friends. Shortly after you see everyone on the patio including BARNETT, duck and react to the gunshots being fired on the inside of the bar. I also observed a large amount of people runout to the patio and run out of the back gate of the patio in front of BARNETT as he's seen running towards the back door of the patio.

Det McFadden conducted a second interview of BARNETT and when confronted with the facts from the video and him being untruthful he then changed he story. BARNETT now stated that a girl told him that someone was shooting so he pulled out his firearm from his waistband and went towards the backdoor to the bar. I then asked him did he fire his gun and he then stated he didn't fire his gun and he now never pulled his gun out he only clutched it on his waist. I then asked BARNETT again did he pull his gun out and he now stated he couldn't remember. I asked him if I could have access to the video DVR system which holds all of the surveillance video and he stated the room was locked and he did not have the key. I then asked BARNETT where is the garbage from tonight that they took out of the bar, because there was evidence inside of those bags. BARNETT stated it was in the back dumpster and when Det. Rice went to check the dumpster and there was only a bag of wet towels and no other bags and were located.

Over an hour later once the Forensic Investigator arrived on the scene I then asked

BARNETT if he could call someone so we could get access to the DVR upstairs because we needed to recover all of the video from tonight. BARNETT then stated he doesn't know if his wife has the key and he has no way of gaining access. I then reiterated that we were going to go up there and retrieve it, I observed BARNETT reach into his right front pant pocket, retrieve several keys, then walk to and unlock a door in the back of the bar, which led to the upstairs living area and he walked us to the DVR system to retrieve video. BARNETT knowingly gave false information to Milwaukee police Detectives with the intent to mislead during the investigation. BARNETT also ordered his employees to clean up which would hide and destroy all physical evidence making it nearly impossible for the apprehension, prosecution or conviction of Suspect #1 for this felony offense.

BARNETT was placed in custody and conveyed to District 3 for processing. End of report.
