Purpose of Amendment:

The purpose of this amendment is to increase the contract total by \$109,787.00 from \$3,512,443.00 to \$3,622,230.00 in accordance with projected budget listed on Health Department Letter dated September 10, 2021 (Exhibit 1). In addition, extend the contract term one (1) year from 01/01/2022 through 12/31/2022, exercising the option to extend annually.

Background:

Physician services, essential medical support and consultation have been provided to the Milwaukee Health Department by Dr. Geof Swain as Chief Medical Officer/Medical Director from late 1993 through August 2017, and by Dr. Paul Hunter as Associate Medical Director since August 2009.

Currently, Dr. Paul Hunter, Medical Consultant for Communicable Diseases, Dr. Jessica Dalby, Medical Consultant for Sexually Transmitted Diseases (STD), and the to-be-named mutually approved successors, provide contracted services. These include medical consultation for all programmatic divisions, administrative leadership and to the Health Department as a whole, as well as running the Immunization Program, the Communicable Disease Program, the TB Control Program, and clinical activities at the STD Clinic. The medical consultants also provide support for limited occupational health issues, assist with program and policy development in conjunction with clinic managers, and facilitate/perform various research and evaluation activities.

The City of Milwaukee has a long-standing relationship with the University of Wisconsin-Madison (UW-Madison) and the previous knowledge of the services required is very important in providing continued medical and public health consultative services to the citizens of Milwaukee. The partnership with UW-Madison allows the city access to top research and medical facilities within southeast Wisconsin as well as continued expertise from associated physicians, researchers, and other faculty and staff. The partnership also allows UW-Madison to send medical and public health students to learn under the direction of experienced public health physicians and other public health professionals.

Re: Renewal of MHD-UW Contract for Physician Services

Dear Dr. Rakel:

I am writing to formalize the desire of the City of Milwaukee Health Department (MHD) to extend the contract between MHD and UW regarding physician consultant services for the Milwaukee Health Department. I wish to amend the terms of the current contract effective January 1, 2022 for 1 year, through December 31, 2022.

The current contract a Medical Consultant for Communicable Diseases (Dr. Hunter) and Medical Consultant for Sexually Transmitted Diseases (STD, Dr. Dalby). The attached page (page 3) shows the specific scope of services for each position.

Dr. Hunter will continue at 0.05 FTE. Dr. Dalby will increase to 0.15 FTE (previously 0.12 FTE). The current contract also includes the option for additional as-needed, mutually-agreeable, UW faculty physician support up to 0.1 FTE. The table on page 2 of this letter specifies the consulting dollars that I am willing to earmark for these crucial services.

Paul Hunter MD has provided essential and significant medical support and consultation to MHD since August 2009. Jessica "Jess" Dalby MD provides crucial support to MHD specifically related to our STD clinical services. The additional time requested in this year's contract will allow Dr. Dalby to play a key role on a multi-year CDC initiative, Strengthening the United States Response to Resistant Gonorrhea (SURRG). Milwaukee is one of 9 sites for SURRG and the MHD plays a lead role statewide.

I am committed to continuing this mutually beneficial relationship, and to providing appropriate and competitive remuneration to individuals like Drs. Hunter and Dalby who are essential to MHD's ongoing operations. I would also like to leave the door open for potential shorter-term or project-specific collaborations with UW faculty physicians.

In every case, these UW faculty physician collaborations stand in strong support of the mutually-held public health goals of the UW SMPH broadly and your department specifically, as well as the MHD. I would also point out that MHD provides 100% of the salary and fringe benefit support for these FTEs. Therefore, I hope and trust that the UW SMPH will support me in implementing the contract renewal as requested in this letter.

Scope of Services

Medical Consultant for Communicable Disease (Dr. Hunter):

- Provide limited, remote medical consultation to the Immunization and Communicable Disease programs when the MHD Medical Director is unavailable
- Provide limited, remote medical consultation by telephone to the STD program when the STD Physician Consultant (Dr. Dalby) is unavailable.
- Provide limited consultation and support for medical and public health teaching of professional students within the health department
- In collaboration with the MHD Medical Director, provide limited support to MHD for research and data analysis related to immunization and communicable disease

Medical Consultant for Sexually Transmitted Diseases (Dr. Dalby):

- Serve as Medical Consultant for the Sexual Health and Family Planning clinic, including:
 - development and maintenance of up-to-date STD and contraception-related medical protocols; and
 - medical supervision and staff development for nursing staff at the Sexual Health and Family Planning clinic
- Provide availability to Sexual Health and Family Planning clinic staff for telephone consultation as needed
- Provide limited supervision and oversight of sexual health and family planning-related medical teaching within the health department
- Provide limited support for various sexual health-related research and data analysis activities
- Provides consultation to and supervision of MHD Advanced Practice Providers, including entering in a documented collaborative agreement
- Act as medical specialist for SURRG grant and related activities, including workgroup and meeting participation
