Regarding the nuisance of garbage and litter violations at 4340 N. 19th Place

May 28, 2021, at about three o'clock in the afternoon, I received a call from my tenant that the house was on fire. Firefighters responded to the fire, and everything in the home was thrown into the fenced yard and garage. The insurance company did not issue a check until October 21, 2021. The property did not have a tenant living in the property paying rent, and I did not have the resources to clear the yard and garage. We needed to obtain at least six dumpsters to remove all the debris, and with no rent coming in, that could not be completed during that timeframe allotted. Tim Bogen, the condemnation inspector, told me that he was aware of the problem and not to worry about it. Tim also had me write a letter to the City to release twenty thousand dollars of insurance money for the condemnation to take care of the problem. The City is yet holding ten thousand dollars. To remove everything from the yard and garage after the fire would have taken a minimum of 2 weeks, if not more.

You were notified by the Department of Neighborhood Services to correct a garbage and litter nuisance code violation at 4340 N 19TH PL. This was the third (or more) violation of Section 79-12 of the Milwaukee Code of Ordinances within the 12 month period proceeding the date of this violation. Section 79-16-2 allows the City of Milwaukee to charge a repeat litter charge as described in Section 200-33-49.2 to obtain compensation for inspectional, administrative and equipment costs.

The repeat litter charge for this order is \$101.60 which includes a 1.6% training and technology surcharge. As indicated in the original order, this charge, if unpaid, will be placed on the property tax bill. If you wish to pay this amount rather than to have it appear on your tax bill, you may do so before September 15, 2022 at this address:

If you wish to formally appeal this charge you must file that appeal within 30 days of the date of this letter. It must be filed with the: Administrative Review and Appeals Board, Office of the City Clerk, Room 205 City Hall, 200 E Wells Street, Milwaukee Wisconsin 53202, (414) 286-2231. Please contact them to obtain the proper application form. There is a \$25.00 fee required when filing this appeal.

Please be advised that if you have filed for bankruptcy, this letter is for informational purposes and is not intended to be construed as an attempt to collect a debt during the pendency of your bankruptcy as other conditions may apply.

If you feel the garbage or litter was not on your property or feel this letter was issued in error, please call (414) 286-5771 to have this matter reviewed. A review does not extend the time to appeal.
