Interim Commissioner Weber presented an update including the Common Council vote for Health Commissioner candidate, the ending of the Emergency Order and how it impacts Medicaid renewal and eligibility, current COVID vaccine availability, and preparations for Fall 2023 COVID vaccine availability.

5. Communication from Board Director, Alderwoman JoCasta Zamarripa, regarding Ascension Wisconsin's reductions in healthcare service at St. Francis Hospital Milwaukee

Board Director, Alderwoman JoCasta Zamarripa, provided an update regarding the reduction and elimination of services at Ascension Wisconsin's St. Francis Hospital Milwaukee and how it has impacted the southside community and across the city of Milwaukee.

Guest speaker Executive Director of the Wisconsin Federation of Nurses and Healthcare Professionals, Jamie Lucas' presentation included trends from 2016 – 2023 regarding profits, salaries, eliminated and remaining services at St. Francis Hospital Milwaukee.
