Mr. Dehne testified that he is the owner of Buckhead Saloon Suite Nightclub, a neighboring business in the area. He opposed on the grounds that the bar has deviated from its original plan of operation from a country bar to an Irish concept that rents out its bar.

Mr. Dehne testified that he has personally seen intoxicated patrons from the bar and that the bar does not open at 11 a.m. everyday of the week as originally planned. Instead, the bar opens only from Thursday through Saturday. He added that the business has deviated from its operating plan, is not a full scale restaurant, has brought in violent crowds in the area due to its DJ events, has loitering outside in the back alley, and promotes "all you can drink" events.

Ald. Bauman was present in opposition due to neighborhood testimony. He also opposed due to deviation from the plan of operation, which should have an opening time of 11 a.m. and lunch service as a restaurant during the daytime. Operation during the daytime by this business was important to help daytime business activity in the area be active.

Ald. Perez moved to make a 2010 letter from Mr. Shemitis to Westown Association regarding the business plan, provided by Ms. Callies, as part of the record. There were no objections.

On behalf of Westown Association, Ms. Callies testified in objection due to deviation from the plan of operation. In his 2010 letter, Mr. Shemitis wrote that the business would be a country bar with live music serving lunch, open every weekday, refrain from utilizing event promoters, and have Mr. Shemitis daily managing the bar. The bar does not serve lunch, is now an Irish sports bar, does not have Mr. Shemitis as the daily manager, and has used event promoters. She has personally observed the bar not being opened from Monday to Tuesday on two occasions but could not remember exactly when. The association has received complaints from neighboring businesses and the police department regarding the disorderly behavior, loitering, and fighting caused by patrons of the bar.

Mr. Dehne further testified that there still exists social media promotions for booked events at the bar, such as a Hmong New Year event on December 15, 2012.

Ald. Bauman was present in opposition due to neighborhood testimony, deviation from the original plan of operation, subleasing done by the bar, nuisance behavior of patrons, and the police report. He suggested not renewing the license.

Mr. Shemitis gave testimony. The business does not serve lunch as originally planned. He is not there everyday but is hands-on with many operations. There

have been event bookings with and without his knowledge. Event planners and promotions have occurred, but some were done without his knowledge by the previous management team. Mr. Vecitis was recently hired to head the a new management team. Staff and the kitchen are being changed so that food can be served going forward. The business is open six days a week.

Mr. Vecitis testified that he has been the new manager for ten days, the business had been recently shut down for two weeks between Monday and Wednesday for renovation, erroneous social media promotions will be removed, and future booked events have or will be cancelled.
