Sylvia Schultz - 3138 S Clement Ave - She has experienced noise issues from the business. Customers frequently rev motorcycles in front of the bar. She has seen one of the owners revving a motorcycle in front of the establishment. Isabel Calderone - 3142 S Clement Ave - She has experienced noise that other objectors testified to.
