2. Public Art Subcommittee Report

The Raimondi sculpture that was removed from the Blue Cross Blue Shield building has drawn attention to a need to develop best practices for decommissioning public art. The Board is not in a position to fund this process, but the Public Art Subcommittee will develop some ideas at the next meeting.

Ald. Murphy stated that ordinances similar to historic preservation ordinances will be investigated.

3. Grants Update
