About 250 Statements of Economic Interests have been filed, which is just about half of the total. The staff assistant emailed a reminder the day prior to the meeting to everyone who hasn't yet submitted. As a result of that e-mailing approximately 30 more statements were filed. Relating to a discussion at the last meeting, the filing deadline this year is actually March 2nd because Feb 28th falls on a Saturday. The late fee kicks in on March 13th.

5. Review newly filed Statement of Economic Interest Forms for clarity and completeness.

The Board reviewed and approved the Statements of Natalie Fowler and NIcole Anderson.
