3. The Board may convene into closed session to hear disciplinary matters and related information pursuant to s. 19.85(1)(b) and/or (f), Wis. Stats., and to consider and render confidential advice pursuant to s. 19.85(1)(h), Wis. Stats. to conduct an investigation of a complaint.

*Mr.* Kalscheur moved, seconded by *Mr.* Shelledy to go into closed session. There were no objections.

Mr. Shelledy moved to amend the March 17, 2015 minutes to read under item #3, to read that in closed session the board voted unanimously to conduct an investigation, seconded by Me. Kalscheur.

4. The Board may then convene into open session as authorized by s. 19.85(2), Wis. Stats.

In Closed Session the board discussed a complaint. Based on Chapter 303-23 of the Milwaukee Code of Ordinance, Mr. Kalscheur moved, seconded by Ms. De La Rosa, to dismiss the complaint since no probable cause exists to believe that a violation of chapter 303 has occurred. There were no objections.
