Sande Robinson and Jan Serr & John Shannon were nominated for 2017 Friends of the Arts. Ms. McSweeney has nominated all nominees. There was a unanimous vote and all nominees won.

7. Announcements

Mr. Flores stated a nearby church has offered space after the UWM Peck School fire.

Ms. Layden stated Marquette has also offered space for those displaced by the fire.

Mr. DeLind stated the Milwaukee County Zoo will be hosting Beastie Beats for the
Milwaukee Symphony Orchestra in summer 2018. Ms. Klose stated it is National Fair
Housing Month and there is an exhibit at Milwaukee County Historical Society
regarding the Fair Housing Marches of 1967-68. Ms. Kingsbury stated there is a
LGBTQ queerzine exhibit at Woodland Pattern. She stated Jeff Moran will also be
having a show at Woodland Pattern. Both exhibits were funded by the Arts Board.
