Atty. Winkler says that fifty people attended a town hall meeting and showed support for the license.

Opponent:

Kenneth Salinger, Jr., 8403 W. Keefe Ave. He says that he was unable to attend the meeting due to work, but he is opposed to the license. Mr. Salinger, Jr. says that there are problems with loud music, litter and cruising in the area, and there would be two different bars in the building instead of two. He also says that Pete's Pizzeria has not been a problem.

Atty. Winkler says that the previous bar, Mixers, was a problem bar and is now gone. He also says that the problems that occurred as a result of Mixers will not occur at the new bar.

Supporters:

Thomas Angelo, 3550 N. 84th St., business partner of the agent. He says that they decided to have a business that was better for the neighborhood instead of a nightclub. Mr. Angelo also says that the business will be for the neighborhood and will not be advertised on the radio.

Steve Schiro, 3440 A. N. 84th St. He is in support of the license. He says that he has known the applicant for ten years and that he thinks that they want the business to be an asset to the neighborhood.

Jeff Brandenburg, owns a shoe repair business at 3448 N. 84th St. He is in support of the license.

Jacob Lepold, owner of the bulding, 1420 W. Brown Deer Rd, River Hills. He is in support of the license. He says that he will be watching his son and his son's business partner to make sure that the business is respectful of the neighborhood.

Ald. Zielinski moves to make the photos provided by Mr. Salinger, Jr. a part of the record. Prevailed 5-0. (Exhibit 1)

Ald. Donovan says that the drug activity in the bar is a concern to him, as is a bartender back in 2008 not being licensed. He believes that some level of discipline should be extended to the applicant.

Mr. Lechuga says that he has to leave the bar to go to Mexico for medical reasons. Atty. Schrimpf says that the law requires that there is someone licensed in charge to operate the bar in his absence.
