 Resolution relating to the Certified Local Government review of the National Register of Historic Places nomination for the Oriental Theater, at 2216 - 2230 N. Farwell Avenue.

Michael McQuellan wrote the application for nomination. The theater was constructed in 1927 by a man who specialized in movie theaters and was constructed as a movie palace. It has two minarets, both topped by onion domes and the building was built by a wealthy newspaper publisher and leased by a movie operator. The original blade sign has been removed and the marquee replaced in 1947. The building also has a wing and "Black Cat Alley" which has exterior art. There is office area above the theater.

*Mr.* Tim Askin's biggest issue is that the state wants the city to be listed as part-owner, but he is resisting. The request is because the marquee overhangs the sidewalk. There is a sidewalk vault and there is no city special privilege. Approve.
