Warren Jones, Vice President of Construction, explained after an original request for bids provided no valid results, an invited request for bid was sent to Great Lakes Components LLC and Travaux worked with them on the quote and staff hope the costs may be reduced. Mr. Jones said Great Lakes has performed and supplied many of the panels at the Westlawn Gardens project.

Director Hurtado commented that in the next year there are indications that prices will be increasing for residential and multi-family construction which will impact labor and material budgets and cause cost overruns. She encouraged staff that if something needs quick approval for lower pricing, they should ask for a special meeting.

He encouraged the Directors to speak with him if they know of someone who would be a good fit for the HACM Board. Mr. Hines mentioned that staff will be providing updates about Travaux to the HACM Board in the coming months and will keep Travaux informed about HACM. 10. The Board may receive a motion to convene in closed session pursuant to Section 19.85(1)(g) Wis. Stats. to confer with a representative of legal counsel who will render oral or written advice concerning strategy to be adopted by the Board with respect to litigation in which it is or is likely to become involved.
