Resolution determining it necessary to make various assessable public improvements at various locations. (Infrastructure Services Div.) -Analysis-

This resolution authorizes engineering studies and directs the Commissioner of Public Works to determine any benefits or damages which would result if the projects were to be constructed. After the Commissioner files his report, a Public Hearing will be held on those projects determined assessable. A resolution will be submitted after the Public Hearing authorizing construction.

Resolved, By the Common Council of the City of Milwaukee that it is necessary and in the public interest to do the following described work according to City specifications, and that such public improvements and resulting special assessments be made pursuant to Section 66.60 and any other pertinent sections of the Wisconsin Statutes and in the manner directed by Section 115-42 of the Milwaukee Code of Ordinances:

#### 2nd and 7th Aldermanic Districts

W. Burleigh St. - N. Sherman Blvd. to N. 60th St. (892-0164-9): Paving the roadway with concrete. Laying a concrete curb and gutter. Laying concrete sidewalk. Doing all the necessary grading pertaining to said work.

#### 4th Aldermanic District

N. 7th St. - W. Michigan St. to W. Wells St. (878-0761-5): Placing an asphalt overlay on the existing pavement. Laying a concrete curb and gutter. Laying a concrete sidewalk.

#### 5th Aldermanic District

W. Keefe Ave. - N. 76th St. to N. 80th St. (878-0711-2): Paving the roadway with asphalt. Laying a concrete curb and gutter. Laying concrete sidewalk. Doing all the necessary grading pertaining to said work. (1999 Paving Program)

N. 98th St. - W. Center St. to 135 ft. m/l south of W. Center St. (829-4592-5): Installing water main.

#### 17th Aldermanic District

N. 17th St. - W. Wells St. to W. Highland Blvd. (890-0146-6): Paving the roadway with asphalt. Laying a concrete curb and gutter. Laying concrete sidewalk. Doing all the necessary grading pertaining to said work.
