Resolution relative to application, acceptance and funding of the STD/HIV Prevention Training Grant. (Health Department)

This resolution authorizes the Health Department to accept and fund the STD/HIV Prevention Training Grant project from the Centers for Disease Control through the Cincinnati Health Department in the amount of \$40,756. The purpose of the project is for the Milwaukee Health Department STD/HIV Clinic to serve as a model training center for students and professionals enrolled in the STD/HIV Prevention Training Center in Cincinnati.

Whereas, The City of Milwaukee appears to be eligible for grant funds from the Centers for Disease Control through the Cincinnati Health Department for the Milwaukee Health Department STD/HIV Clinic to serve as a model training center for students and professionals enrolled in the STD/HIV Prevention Training Center in Cincinnati; and

Whereas, The operation of this grant project from 04/01/01 to 03/31/02 would cost \$40,756 provided by the grantor; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that application to the Cincinnati Health Department is authorized and the Health Department shall accept this grant without further approval unless the terms of the grant change as indicated in Common Council File 940843 (Grant Ordinance); and, be it

- Expend from the amount appropriated sums for specified purposes as indicated in the grant budget and incur costs consistent with the award date;
